

# America in Crisis

The United States has been unassailable for nearly two centuries. For much of this time it has dominated the world, both economically and militarily. Its enemies have long known that the only way to bring it down was to infiltrate its leadership and undermine it from within.

We don't hear the word 'treason' very often in the media because treason is endemic in Western society and the traitors themselves, who control the media, don't wish to draw too much attention to this particular variety of criminality. They do their best work when no-one suspects their existence.

The ultra-rich oligarchs who rule Britain and America financed the rise of Communism. It was designed to replace egalitarian governments in Europe and elsewhere – which based their values on Biblical truth – with a centralized, authoritarian system of government which ruled in perpetuity. In essence they wanted a one-party police state.

The drawback with visible force is that it tells the people that they have an enemy and identifies those in control. To reduce resistance, a two-party structure was introduced in many countries. This gave the illusion that the will of the people was the prime determinant of public policy. By and large the people were satisfied. It never occurred to them that the various political parties might be different branches of the same 'party', a power-sharing cartel which took its orders from a small group of mega-rich individuals.

## **The British created America**

The British created America in 1776 in order to set their plan for world government in motion. This new nation would be used to reshape the world, both economically and politically. Instead of conquering other nations, it would quietly influence their development so that, step by step, they would eventually come together and form a world government. It would also carry out extensive covert operations to coerce any nation that refused to co-operate with its long-term goals. These included the widespread imposition of Freemasonry and the classic British penchant for sponsoring violent revolutions and bloody regime change in various parts of the world.

Today, all nations are covertly aligned within this centrally co-ordinated governance network. As we noted in our last paper (#414), the blueprint for this new system, known as **Agenda 21**, was agreed by the heads of 178 countries in Rio de Janeiro in June, 1992. This comprehensive plan – which is Communist to the core – is being quietly implemented across the world, with little or no public discussion or review.



Since the Communist framework for control of the world's resources has already been agreed and substantial progress has been made in developing the computerized infrastructure that will be needed to support it, the US has largely served its purpose.

## **America is an obstacle to World Government**

Ironically America itself is now the biggest obstacle to the full implementation of this plan. Most Americans despise Communism and will oppose, to the extent that they understand it, any attempt to surrender their sovereignty to an international organization. Having said that, US membership of the UN and the WHO are clear evidence that their commitment to political freedom has weakened considerably since World War Two, but the architects of the coming New World Order are not prepared to wait for it to weaken further. They believe a full transition to world communism will necessitate inflicting a substantial blow to the US, where its standard of living will fall precipitously and its military will have been humbled.

In several of our previous papers we adverted to the Brutus Option. This is a strategy designed to bring the US under the control of a dictator. It was set out in fictional form in an essay by Charles J Dunlap Jr in 1992. Dunlap, who attained the rank of major-general in the US Air Force, attributed the coup primarily to a failure of government, notably corruption and inefficient administration. This contrasted with the (rather implausible) can-do, problem-solving capacity of the military. The latter were able to step in and keep the country functioning normally. Apparently the essay, whose author was given a public honor by General Colin Powell, was circulated around the Pentagon and made a subject of discussion among aspiring cadets.

If we examine the essay in detail and look beyond its incidental elements, we will find the bones of the Brutus Option. A strong man emerges from the military to take control of the country and prevent it from falling into chaos due to corruption and appalling financial mismanagement. This strong man, General Brutus, offers to step down once order is restored. However, most of the population fear for the future, especially in the wake of a stock market collapse, and beg him to stay in office a little longer. He agrees to do so only on condition that he is given the exceptional, albeit temporary, legal powers that he needs to deal with the layers of corruption and corporate criminality that had caused so much harm to the country. He promises, in effect, *to drain the swamp*. (Sound familiar?)

### **The referendum on ‘Special Powers’**

In the lead up to the ‘special powers’ referendum there was considerable public debate over the wisdom of giving so much power to one man, even if only for a few months. Those who supported the proposal pointed to his integrity to date and the effective way he stepped in and restored order. On polling day he secured a high level of support from older voters – who were greatly concerned about the possible loss of their savings and 401Ks. This swung the ballot in his favor and his ‘special powers’ were approved.

Brutus then showed his true colors. In the absence of any judicial or Constitutional impediments, he immediately shut down Congress and dissolved the Supreme Court. A severe censorship code hid from public view the round-up and execution of all influential persons who opposed the Deep State. Anyone who made a public stance in defense of democracy or Biblical values met the same fate.



The scenario presented by Dunlap, where the military were deemed to be in a position to solve a crisis of governance, would not have been taken seriously in 1992. And it is even less believable today. However it provided an excuse to explore the Brutus Option. It may also have been an exercise in predictive programming aimed, not at the general public, but at the Pentagon and the military industrial complex.

### **The *Brutus Option* is coming into view**

Were it not for the rise of Trump, the Brutus Option would still be seen by most as a purely fictional scenario. Current events, however, are surprisingly reminiscent of the circumstances that led to the military coup envisaged by Dunlap. Consider the following:

1. The rise to power of a leader whose management style differs utterly from any of his predecessors. His imperious, dictatorial tone is completely at odds with a system based on ‘checks and balances’, where presidential decisions must have regard to the views expressed by Congress and meet in full all legislative and Constitutional requirements. The existing incumbent frequently announces decisions which could not possibly have been weighed in this manner. His maverick approach is more akin to that of a monarch who is impatient with underlings and courtiers who drag their heels or hinder the execution of his plans.
2. President Trump has stated many times that he intends to “drain the swamp.” This was a reference to the parasitic and wasteful dimension of Federal government, where huge sums are siphoned off by middle men or wasted through ineffective management controls. The *swamp dwellers* are those who exploit these weaknesses in a systematic way and continue to make enormous profits at the expense of the taxpayer.

3. President Trump is the only President to refer many times to what is sometimes called the Deep State. The following statements have been attributed to him:

*“I’m fighting the deep state – those corrupt bureaucrats and intelligence officials in Washington who are trying to undermine my presidency and steal our country from the American people. They will not succeed!”*

*“The deep state is a cancer on our government. They’re a hidden enemy working behind the scenes to destroy everything we’ve built, and I will not let them take our country away from us.”*

*“I’ve seen the deep state at work, and let me tell you, they are the most corrupt group of people in Washington. They’re out to bring me down, but we are fighting back – and we are winning!”*

He is urging his followers to support his fight against the deep state, the shady cabal that exercises great political influence over America. His agenda, he claims, is opposed to theirs. They are *“a hidden enemy working behind the scenes to destroy everything we’ve built.”*

While other presidents (e.g. Kennedy and Eisenhower) have referred to the existence of this Cabal, Mr Trump is the only president to point directly at them and declare that they are the enemy. He even goes further and pledges to fight and defeat them.

Given his various remarks about both, it is clear that the swamp dwellers are not the same as the deep state, though they obviously overlap. The swamp dwellers are not working together to *“take our country away from us,”* but the members of the deep state are.

4. The organized attacks on Mr Trump – the FBI raid on Mar-a-Lago, the Russian collusion allegations, various highly-publicized court appearances, and a staged assassination attempt – are all designed to suggest that the deep state Cabal both fear and detest him and are trying to bring him down. The corporate media is assisting in this campaign and even portrays his followers as right-wing extremists.

No presidential candidate has ever been subjected to such a long-running fusillade of abuse. Through it the public is being conditioned to believe that Mr Trump is special, a real champion of truth, a man of integrity and a leader whom the people can trust.



5. President Trump is constantly reminding the public that he is a great deal maker, someone who can cut through the red tape and get things done. By doing this he is implying that his leadership ability exceeds that of any of his predecessors. This reinforces in the public mind the belief that he is the ideal man to lead the country in a crisis. His unorthodox management style, his flamboyant rhetoric, and his over-sized personality all contribute to this perception.
6. The market has not undergone a major correction since 2008. By any measure this continual rise in equities, over a lengthy period of 16 years, is without precedent. It is even more surprising in light of the high level of real unemployment over this time and the pain caused by inflation and rising interest rates. The entire economy could virtually shut down for several months in 2020 and still not trigger a correction! The only reason such a long period of artificial market growth could be sustained is through a massive increase in the money supply. The market is rising in step with a phenomenal expansion in the national debt, which trebled between 2008 and 2024! The Federal Reserve and the Treasury have used this 'unearned' money to finance a rising stock market and thereby mollify and mollycoddle the American public.

A stock market sell-off could be triggered at any time by the authorities themselves. It could even be manipulated to take place in phases, with an initial fall of 10 percent say, then a further fall of 15 percent two months later. The President could use the threat of a further significant fall to coerce the public into approving whatever measures he deemed necessary to maintain financial stability. (This is the kind of pressure that enabled Brutus to obtain the special powers that brought the Republic to an end.)

Since taking office in January he has signed Executive Orders reversing many of the policies of the outgoing Biden administration. These related to such matters as:

...enhanced border protection, ...the eviction of illegal immigrants, ...the banning of transgender participation in women's sports, ...the banning of gender transitions for persons under age 19, ...the withdrawal of funding from the UN agency for Palestinian refugees, ...setting in motion the creation of a sovereign wealth fund for the US, ...removing DEI (diversity, equity and inclusion) requirements from the military, ...reinstating soldiers who were expelled from the military for refusing Covid vaccines, ...setting in motion the creation of a next generation missile defense shield ('Iron Dome'), ...ordering a review of FEMA, ...setting in motion a process to withdraw the US from the World Health Organization, ...requiring health service providers to publish healthcare costs for greater price transparency, ...ordering the fast-tracking of permits to build new petroleum infrastructure, ...setting in motion a process to end federal benefits for illegal immigrants, ...affirming that there are only two genders, ...issuing pardons for January 6<sup>th</sup> defendants, ...withdrawing the US from the 2015 Paris climate agreement, ...and directing DOGE (Department of Government Efficiency) to review the regulations of all government agencies and to introduce a transparent centralized federal payment system to accurately track all contracts, grants and loans.



There is no doubt that these steps were intended to make a very favorable impression on the American public and to showcase the President's putative talent for getting things done. However, he also signed Executive Orders which, despite their wide ramifications, received relatively little media attention.

## Stargate

One of these related to the so-called Stargate project which involves building a number of very large data centers to support the national roll-out of AI systems and services. The project will be led by a partnership comprising OpenAI, Oracle and SoftBank and will have a colossal budget of \$500bn over the first five years. The source of these funds was not addressed but it is safe to assume that, if the government is tied to this venture, it will end up underwriting much, if not all, of the cost.

The President did not reveal that Stargate will not achieve its full potential unless all Americans – and in due course all humanity – receive a digital ID.

The press briefing was attended by the President, Sam Altman of OpenAI, and Larry Ellison of Oracle. According to Associated Press the latter said “the project was also tied to digital health records and would make it easier to treat diseases such as cancer by possibly developing a customized vaccine.” This cure-all promise has no foundation in reality but it definitely points to a dystopian future where everyone will have a digital ID and the vaccine industry will monopolize healthcare.

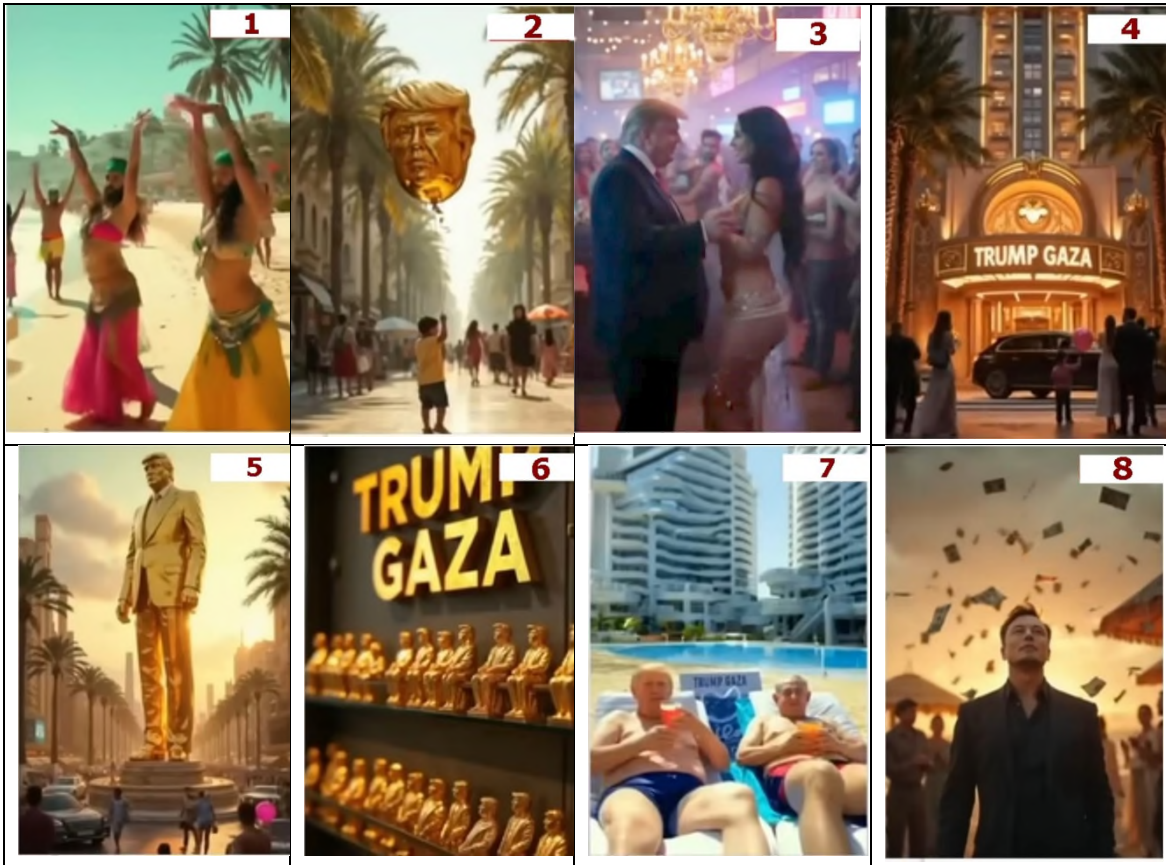

In a half minute AI-generated video [26 February], we are shown the transformation of Gaza from a bloody, war-ravaged land into "the Riviera of the Middle East" which President Trump promised during a joint press conference with Netanyahu on 5 February 2025.

For sheer vulgarity, gross insensitivity, and a pathological contempt for humanity, this revolting little video is difficult to beat. And yet the President saw fit to identify himself with its message and to share it on the Internet. Only a very wealthy sociopath would do something like this. Alas, the sad reality is that both America and Israel today are controlled by very wealthy sociopaths.

## Tariffs

Other Executive Orders signed by the President were equally ominous. They imposed significant tariffs on a range of imports, including 10 percent on imports from China, 25 percent on imports from Canada and Mexico, and 20 percent on imports from Europe (Note that the tariffs may not apply to all goods and in all circumstances). The President justified these in part on the grounds that America was a victim of unfair trade practises and intellectual property theft, and in part on what he is now calling a “national emergency” -

“The extraordinary threat posed by illegal aliens and drugs, including deadly fentanyl, constitutes a national emergency under the International Emergency Economic Powers Act (IEEPA).”

He also stated that “tariffs are a powerful, proven source of leverage for protecting the national interest” and that he is “using the tools at hand and taking decisive action that puts Americans’ safety and our national security first.”

This may sound very patriotic but the “tools” he is using are extremely dangerous in economic terms. The World Trade Organization – which was initially known as the General Agreement on Trade and Tariffs – was set up in 1947 precisely to combat barriers to world trade. Under its WTO remit in 1995 it gained enforcement powers which are applicable to each of the 164 participating nations. Over a period of several years and protracted negotiations, a whole range of tariffs and trade barriers were removed.

For the past seventy years or more the US has actively sought the removal of trade barriers worldwide. Its remarkable economic success over that period is due in part to this strategy. The President has now reverted to the tit-for-tat system employed before 1947. The problem with tariffs is that they invite reprisals, where the countries affected impose counter-tariffs. In economic terms this is immensely destructive. When two countries target one another in this way, both suffer. Output in both countries falls because their goods are no longer priced competitively. Redundancies and lay-offs are inevitable. The higher the tariff and the larger the foreign market, the greater the impact.



Any schoolchild can see this. Alas, the American public are being lulled into a false sense of security. The ‘might is right’ approach that the President is taking is certain to turn out badly. World trade is too diverse to enable a big player to bully all the rest. In the past a few dominant players could make all the rules, but this is no longer feasible.

In short, tariffs are the economic equivalent of self-harm. World GDP grew enormously after the general removal of international trade barriers. Their reintroduction on such a grand scale – affecting trade between three continents – is certain to have a serious impact on all concerned. What is more, it creates an environment where coercive measures tend to escalate and a solution based on negotiation and consensus becomes harder to achieve.



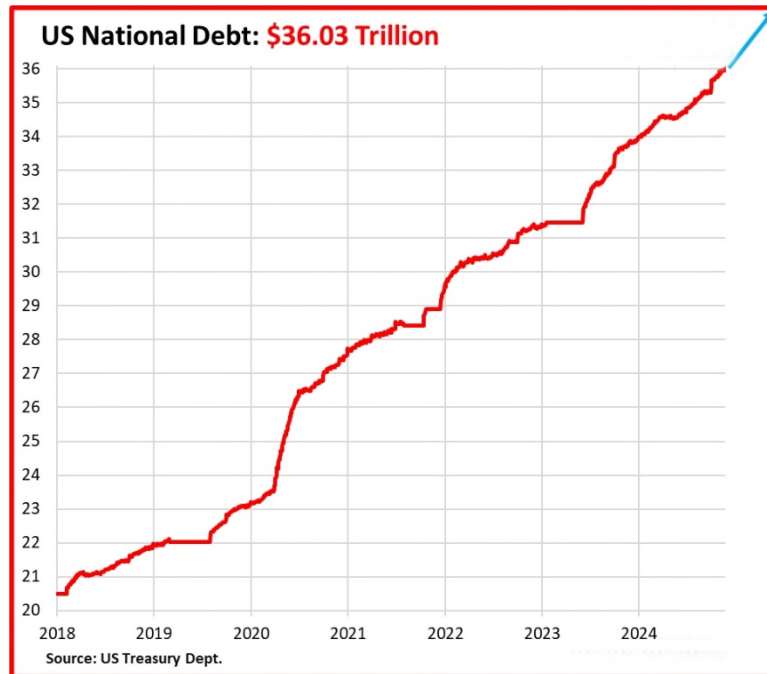
### **False patriotism**

It is notable that President Trump failed to advert to one of the main sources of the trade imbalance between the US and China, namely the low rate of exchange that the Chinese Yuan has consistently maintained against the US dollar. As an economy expands, its currency would normally increase in value – such as the huge increase in the value of the Deutschmark in the decades following the Second World War – but the Chinese have inexplicably been allowed to peg their currency far below its real value. In fact, according to the World Bank, the Yuan is currently undervalued by 40 percent in PPP terms (purchasing power parity).

The President also failed to mention that the US trade imbalance with China has been caused by the “off-shoring” of US industry, to the point where the manufacturing base within the US itself is only half of what it was in 1980. Furthermore, the main beneficiary of this off-shoring was – China!

We can see from this that the plan to destroy the US economically goes back a long way. What the President is now doing, in effect, is pressing the button. He is allowing the full impact of this multi-decade strategy to hit America before genuine corrective measures can be taken.

The tariffs on European goods are insane. They make no sense whatever, either economically or diplomatically. They can easily be interpreted as a deliberate attempt by America to hurt the European Union, notably Germany. They also invite a strong response from EU member states and risk damaging the smooth commercial relations that currently exist between the two regions.



And who will pay these tariffs? The American people of course! The President has effectively increased the price that the average American will have to pay for a wide range of goods. He is also driving up the price of many of their own exports on foreign markets, thus harming American industry. The twin scourge of high inflation and high unemployment appears inevitable. This is the brand of ‘patriotism’ that destroys nations.

## CONCLUSION

The American people need to look more closely at Donald Trump and his background. They need to ask who exactly he is working for. The Ruling Elite need someone like him in office to trigger a series of economic calamities and embroil the nation in fresh conflicts overseas. He must look as though he is working in the best interests of America – an impression that is strongly reinforced by sections of the corporate media – while at the same time taking double-edged decisions whose implications are poorly understood by the American people.

For decades the average American has relied on the corporate media to “explain” the purpose and rationale behind major political decisions. If the media is not sounding a warning or calling into question the basis for these decisions, then the public invariably take at face value whatever they are told.

In our paper #187, we showed that Donald Trump is NOT a Christian, even though he frequently tries to give that impression (just like his Vice-President, J D Vance – see [below](#)). In our paper #183 we showed that he is co-operating with the Jewish ‘nascent’ Sanhedrin in their plan to impose the Seven Noahide Laws on the American people.

The Sanhedrin even wrote to him just after he commenced his second term and invited him to Jerusalem to discuss the creation of an International Divine Court (!) to rule on the application to all Gentiles of the Seven Noahide Laws. 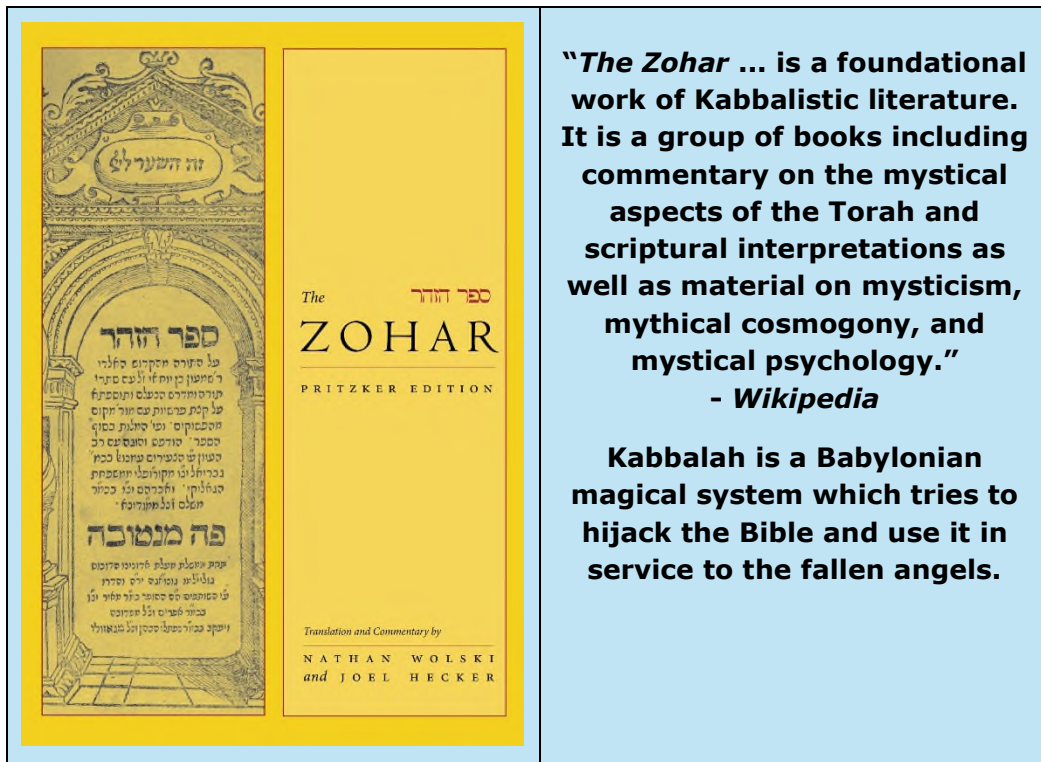


Donald Trump visited the *Ohel* or resting place of the Rabbi Menachem Schneerson, known as “the Rebbe”, on 7 October 2024 (See photos [above](#)). The text on YouTube relating to this event states:

“Recognized as the most influential rabbi in modern history, the Rebbe has been honored by every U.S. president since Jimmy Carter, who in 1978 began the tradition of proclaiming the Rebbe’s birthday as Education and Sharing Day, U.S.A. In 1994, the Rebbe was posthumously awarded the Congressional Gold Medal in recognition of his “extraordinary life and work.”

Mr Trump, who is wearing a *kippah*, is seen placing a small stone on the Rebbe's headstone, a traditional gesture of respect among Jewish mourners.

He has admitted that he studies Kabbalah and that he has a Kabbalah teacher. He wears a *kippah* and pays homage at the tomb of one of the most highly esteemed Kabbalists of the modern era. Both his daughter, Ivanka, and son-in-law, Jared Kushner, are members of the supremacist Chabad Lubavitch cult over which the Rebbe once presided. We know from this that he holds beliefs that are utterly antithetical to Christian doctrine.

For example, in the letter from the Sanhedrin [see **Appendix A**] reference is made to the three “divine blessings” that are allegedly bestowed on a person who “accepts” the Seven Noahide Laws. The first states that he receives a *neshama* or soul which “animates the body and connects a person to Hashem [God]”. This is a blasphemous rejection of Biblical truth! Not only does it denigrate the work of Christ on Calvary but it implies that Jews alone have a soul and Gentiles are a lower order of being, akin to an animal.

In passing we would draw attention to the repeated use of the word *Hashem* in the Sanhedrin letter (It appears ten times, one for each of the *sefirot* on the so-called *Tree of Life*). We are to understand that it is simply a way of referring to God without actually stating His Name (*Hashem* literally means The Name). However, this is deceptive. When a Kabbalist uses this device, he is not referring to the LORD God of the Bible but to the supreme infinite divinity of Kabbalah known as Ein Sof.

Christians need to understand that practitioners of Kabbalah are trained to be proficient in the dark art of deception. Donald Trump himself is an arch-deceiver. That's why they picked him for the job.

Kabbalah is an ancient magical system which can be traced all the way back to Babylon. Just about every occultic and esoteric teaching in the world today draws on the doctrines of Kabbalah. **Letter from the Nascent Sanhedrin to President Donald J. Trump**

**Jerusalem, Wednesday, February 12, 2025**

**Dear Honorable President Donald Trump,**

May Hashem, the Creator, bless you and your nation!

We extend our heartfelt gratitude for bringing faith to the forefront of American and global culture through the establishment of the Faith Office in the White House. Your recognition of the importance of religion in public life is a step toward restoring moral values and spiritual leadership in the world.

**The Universal Moral Code**

The Book of Genesis has a profound message of unity and divine purpose for humanity through three fundamental principles:

1. One God – To recognize the cause of all causes (Genesis 1:1).
2. One First Man – To affirm the basic equal rights of humanity (Genesis 1:26).
3. One Basic Law – To establish universal principles of justice (Genesis 2:16).

Without a constructive moral framework, humanity descends into violence and destruction, as exemplified by Cain's murder of Abel (Genesis 4:8). Every nation has unique strengths and resources, yet no nation is self-sufficient. Without a Universal Ethical Common Code, people resort to war and oppression to obtain what they need. With such a code, nations engage in spiritual commerce and a race for virtue.

### **The First Commandment and the Seven Laws of Noah**

- The first time the word "commandment" appears in the Bible is when Hashem commanded Adam: *"And the Lord God commanded the man, saying: Of every tree of the garden you may freely eat."* (Genesis 2:16) This verse alludes to the seven universal laws that form the foundation of ethical behavior for all humanity. These laws reflect seven of the Ten Commandments.
- These ethical principles were reaffirmed at Mount Sinai when Hashem revealed Himself to the world, and our ancestors witnessed this divine event.
- The Jewish, Christian, Muslim and all monotheistic traditions recognize the divine revelation at Mount Sinai as a foundational moment in history.
- When Hashem gave the Children of Israel the Torah, He provided an ethical standard for the entire world. This standard is known as the Seven Commandments of Noah, which form the basis of universal morality.
- When a person accepts the Seven Noahide Laws, they receive divine blessings:
  1. A Neshama (Soul) – The soul that animates the body and connects a person to Hashem.
  2. Righteous Among the Nations – A person who upholds these laws is considered righteous and honored before Hashem.
  3. A Share in the World to Come – Those who follow these principles merit a place in the hereafter.

**Enclosed** with this letter, we have included the Universal Ethical Common Code (UECC), which outlines the benefits of adopting the Seven Commandments of Noah.

### **The Role of Ethics in Business**

A businessman who commits to being Honest and Good in the Eyes of Hashem will seek trustworthy partners.

- Who would he prefer to do business with? An atheist who may cheat and deceive? Or someone committed to Hashem, who upholds honesty and integrity?
- A business owner will seek to hire workers who are loyal and committed to the success of the enterprise.
- A worker will prefer to work for an employer who ensures fairness and ethical treatment. By aligning economic relationships with divine morality, business and ethics become intertwined, fostering prosperity and trust.

### **The Cyrus-Trump Coin and Your Historic Role**
