

# Besieged and Betrayed: A Nation in Peril

We know (or think we know) where we are now. Ireland is under its second lockdown and the Marxist government that is destroying our country is still firmly in power. The economy is rapidly deteriorating and serious social tensions are developing behind closed doors. The strain for many is intolerable.

Alas, the Irish are too timid to come out in public and protest against the dreadful abuses to which they are now being subjected. Their religious leaders have betrayed them, refusing throughout to compare the tyrannical behavior of the government with the immutable standards of equity and justice expressed in God's Word. When those who profess to be shepherds in Christ are prepared to stand back and let the wolves do their worst, then we know we are facing a grave situation.

## **Marxists and Freemasons**

Marxists and Freemasons have infiltrated the churches and secured the highest leadership positions, appointing along the way weaklings, yes-men and toadies to 'minister' to the people. ## **Jesuit Deceivers**

There was a time when Catholics in Ireland might have said, “Oh, the Jesuits would never allow this kind of moral collapse to occur.” But not anymore. Many Catholics are starting to realize that they were tricked and deceived by the men in black. The Jesuits are traitors who actively support the New World Order and the systematic subjugation of countries like Ireland. As far as we can tell, the only church ministers in Ireland who have openly challenged – or at least contested – the oppressive and immoral policies imposed by the government are Pentecostal.



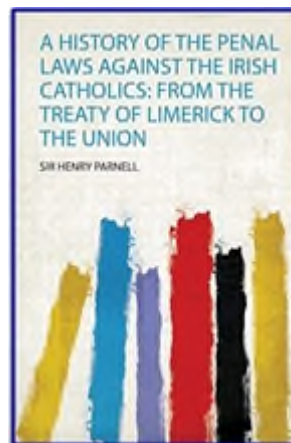

## The Penal Laws

Depending on how one interprets existing legislation – the tyrannical Covid rules imposed by the government – a pastor or priest can now be fined or imprisoned for celebrating a religious service. In a country where 78% of the population identify as Roman Catholic, priests are prohibited from celebrating the Mass. Not since Penal times have Catholics in Ireland been forbidden under the law to worship God in this way!

The regime known as The Penal Laws was a very nasty system that the British Crown used to subjugate the Irish. The purpose of the code was to deprive the native population of any role in the political process or in productive economic activity. The Penal Laws were very harsh, even by the standards prevailing across Europe at that time, and they were applied with rigor. The Crown was ruthless. The Masonic jackboot kept the impoverished Irish peasants in their place.

The Penal Laws were to a large extent an experimental application of the system that the British would later use to control and exploit other Crown colonies. They relied heavily on fear, intimidation, random arrest, routine beatings, confiscation of goods, economic oppression, sexual violation, and careful infiltration of any group or community that might try to resist the ruling regime. The Irish weren't even allowed to educate themselves: "No person of the popish religion shall publicly or in private houses teach school, or instruct youth in learning within this realm, upon pain of twenty pounds fine and three months in prison for every such offence."



The Penal Laws were passed in the period 1691 to 1760, during the reigns of William and Mary, William III, Anne, George I and George II, and were not repealed until 1829. During that time – 138 years – Irish Catholics were an oppressed and impoverished caste in their own country, ruthlessly exploited by British landowners (who took everything), and in many instances were barely able to eke out an existence. Visitors from the continent, who were familiar with the poverty then common in many parts of Europe, were taken aback by the grinding destitution that the Irish had to endure under the British.

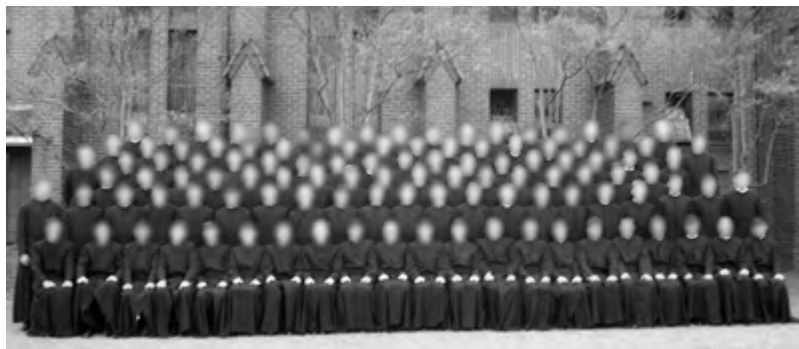
The Educational system in Ireland is run by the same Crown agents who control the Dáil. They make sure our young people receive only a watered down account of British tyranny in this country. For example, the Great Famine, which caused untold social trauma and killed over a million people, is never described as a work of genocide.

### **The Round Table System**

Around the end of the 19<sup>th</sup> century the British decided that the cost of controlling so many remote colonies was too high. The direct rule method has serious limitations. So they began using a method of indirect rule, known as the Round Table system, where a secret council would run each dominion nation, controlling a local puppet regime which the public believed was “their” government. Ireland was the first country in the Commonwealth to be given “independence.” In this way the exploitation could continue, but at much less cost and considerably less hassle. The Crown got a breadbasket nation to bolster its food supply, along with a cheap source of labor and raw materials. A steady inflow of indigent Irish workers would keep wages down.

This transition was greatly helped by the system of “education” which the British introduced in partnership with their nefarious allies, the Jesuits. Well over 90 percent of all males in Ireland who received a basic education between 1830 and 1960 did so via the network of primary schools run by the Congregation of Christian Brothers, an organization founded and controlled by the Jesuits with Crown approval. The first school was opened in Waterford in 1802.

Modern accounts of the founder, Edmund Ignatius Rice, often fail to mention that Rice was a Jesuit. You won’t find this fact on Wikipedia or in *Encyclopaedia Britannica*. To its credit *historyireland.com* records that “There is a tradition too that Edmund managed the finances of the suppressed Jesuit Order until their restoration in 1814.” His middle name, Ignatius, would have been widely recognized at the time as a sign of his family’s affiliation with the Jesuit Order (The founder of the Jesuits was a Spaniard named Ignatius Loyola).



The 'education' provided by the Christian Brothers was primitive and the classroom regime brutal. Violent physical beatings were commonplace, right up to the 1960s. The 'brother' who presided over a class of 50 boys could treat them however he wished and no boy would dare go home and complain to his parents. Anyone growing up in this atmosphere of fear and daily intimidation would carry the mark for the rest of his life, bowing meekly to authority and doing as little as possible to draw attention to himself. Thus the Crown and the Jesuits between them produced a race of emotionally oppressed, servile people, possessing only as much literacy and numeracy as the landowners, the merchants and the rentier class required.

### **The brutal Reformatory system**

The Christian Brothers also set up the infamous 'Reformatory' system, where boys as young as ten were taken by force from their families for very minor offenses and sent to institutions run by brutal members of this Jesuit-controlled organization. Tens of thousands were subjected to a terrible regime of abuse and malnutrition until they reached the age of 18. These institutions were also known as 'Industrial Schools' since the boys were used as slave labor. The beatings in the Reformatories were much worse than those given in the schools, and sexual abuse was widespread. The emotional and physical injuries inflicted on these unfortunate children left them damaged for life. Most were so traumatized by their time in the reformatory that they were unable thereafter to speak about their experiences.

Edward Flanagan, a Catholic priest, opened 'Boys Town' in Nebraska in 1917. He later became famous for demanding that children in similar institutions in America be treated humanely. When he heard damning reports of the way Irish children were being treated in Reformatories in Ireland, he paid a visit to the country in 1946. The authorities went out of their way to hide what was happening. Flanagan guessed he was being duped and arranged a return visit in 1948, but before he could expose the regime of physical and sexual abuse that was endemic in the Reformatory system, he was poisoned by the Jesuits – via the notorious *cup of Borgia* – and died of a "heart attack."

## **The spirit of 1691 is still at work today**

We need to recognize the dark pattern in Ireland's past if we are to understand what is happening in Ireland today. The antichrist spirit of the British Crown – the real *Corona* virus – is still doing the same insidious work that it began in 1691.

Its agents control Dáil Eireann and take their orders from Westminster. The 'New World Order' is being implemented in Ireland – an imposed program of change that will entail, among other things, the destruction of natural morality and the true Christian tradition. Two national 'lockdowns' in less than a year are stark evidence of their real affiliation and their destructive intentions.

This is why the churches have betrayed the people. The process of infiltration has spread like a web across all areas of public life. If those in control of the various churches are Jesuits, Freemasons and Marxists, then the people are being deliberately deceived. They have no-one to guide them, to issue timely warnings, or to shine a light on the filthy lies told by our government and the state-controlled media. The Bible is forgotten, as are the words of Jesus: **"If ye love me, keep my commandments" (John 14:15).**



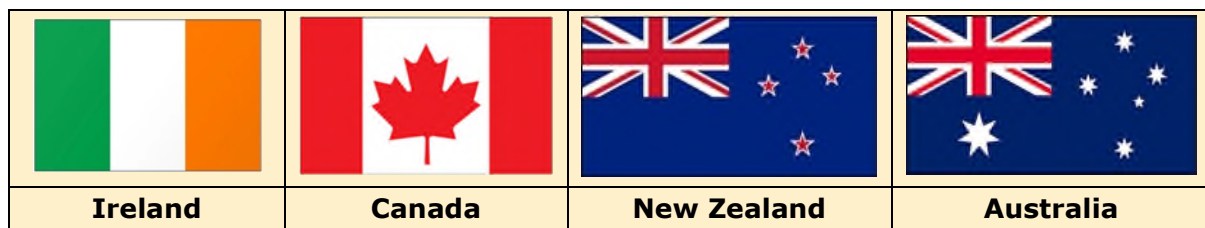
### **They turned their backs on their Maker**

With their brazen rejection of God on 22 May, 2015, when they abolished Christian marriage, and again on 25 May, 2018, when they approved the murder of a proportion of their unborn children for social and economic convenience, the people of Ireland proclaimed their right to frame their own moral laws. They told their Maker that He wasn't needed anymore.

Now look at them! Satan is on the rampage. Their economy is falling apart. Their leaders are liars of the worst kind. Breadwinners can't earn a living! Families can't attend church! Businesses are failing. No-one may wander more than 5kms from their own homes. Everyone has to wear a mask of servitude if they want to buy anything in a shop, and the only things they are allowed to buy are those items which their Baal-worshipping leaders say are "essential". It is even a crime to visit one's neighbors or shake their hands!

And this wickedness is set to continue. It won't end until the people of Ireland turn to God and ask His forgiveness. And that won't happen while the churches remain shut and a cowardly, covetous clergy continue to serve the wolves.

So let's take a moment and look a little further down the road. We need to see what the people of Ireland have actually chosen for themselves.



## The road ahead

The International Dictatorship will very likely impose on Ireland the same policies that it is imposing in other English-speaking colonial countries, notably Australia, New Zealand, and Canada. Like Ireland, these are countries where Scottish Rite and Royal Arch Freemasonry have had an iron grip for a very long time. Each is controlled from London and each is seemingly scheduled to come under totalitarian rule in the very near future.

I'd like to insert here a short piece which opened my eyes to the Satanic nature of Freemasonry. When I was in the New Age I flew to London in April, 1983, to attend a musical performance by a certain American guru. The concert was scheduled to take place in the Town Hall in Kensington. However, the custodians of the Town Hall decided at the last moment to cancel the concert. The organizer, a high-level Freemason, managed to get permission to have the concert held instead in the Freemasons' Hall in Great Queen Street in Holborn. When we all arrived at this imposing building, we were led up the steps into a large, dimly lit auditorium. The walls appeared to be black. It was hard to tell for sure because of the poor lighting. The atmosphere in the place was filled with a dark, deathly supernatural presence. Words like 'creepy' and 'strange' would not begin to describe the weight of evil that exuded from the walls. I doubt whether even one person present was not greatly relieved when the concert finally ended and we escaped into the street. Remember, I was not a Christian at the time, and yet the evil in that building was palpable.



The people behind the coming New World Order worship and serve this supernatural darkness. The fallen angels that control them will stop at nothing to destroy humanity. They are now at the stage in their plan where, using advanced technology and cunningly contrived lies, they will lure entire nations into a devastating trap. Millions will die.

Now that the people of Ireland have twice voted – by a wide margin – to reject the authority of God and manage their own affairs without recourse to His protection and mercy, they are on their own. The evil I saw in Great Queen Street has come to their shores.

Christ went to Calvary to defeat that evil, to neutralize utterly the power of Satan in the lives of anyone who believes in his saving sacrifice. It brought complete and perfect spiritual freedom. But if anyone rejects this most precious and most holy gift, then he is entirely without hope in a world where darkness reigns.

### **A possible, and very plausible, scenario**

So what will tomorrow bring? The so-called pandemic, a monstrous lie, will continue to destroy our economy and our social fabric. As the crisis deepens, as more jobs are lost and people are forced to submit to the many degrading regulations imposed by the government, national desperation will reach a critical pitch. The growing frustration will explode into social unrest and violence in our streets. A great divide will open up between those who demand that everyone receive the Covid vaccine and those who absolutely refuse to take it. This tension could be greatly inflamed by a sudden increase in mortality, a spike which nearly everyone will blame on a new, mutated strain of the so-called virus. (We will return to this topic below.)

The government will follow the same path as those of Australia, Canada and New Zealand. As we stated in #241, “A paper like this is easier to understand if it is seen in the context of an evolving world situation where a family in New Zealand can be locked away in a state quarantine facility because one member ‘tests positive’ for a virus that doesn’t exist...” Similar mandatory quarantine facilities are being set up in Australia and Canada. Have no doubt, Ireland is on the list.

When the next wave of the ‘pandemic’ starts to bite, no-one will be allowed to self-quarantine at home. As we warned in #231 and #234, the pseudo-virus will be used as an excuse to break up families and take children from their parents. There will only be one way to escape indefinite detention in a state-run facility. Those who agree to take the vaccine will be released. Everyone else will be tested every ten days or so. Perhaps one or two will be allowed to pass the test – assuming they take it – but the rest will ‘fail’. In fact, many of those in detention will refuse to take the test, suspecting (quite rightly) that the test itself may be used as a vector of infection (We will discuss this further below.)

### **The troublesome minority**

Out of the entire population it may be expected that 3-5 percent will not agree to be tested or to take the vaccine. Everyone else will co-operate with the authorities. But 3-5 percent is still a lot of people. Even if we take the smaller number, it means the state will have to incarcerate 150,000 people. Many of these will resist vigorously and use whatever means they can to escape. The Gardai may not be comfortable brutalizing so many fellow Irish men and women. The Army, too, may have similar scruples. But the problem is easily solved. The government will simply bring in thousands of UN peace-keeping troops to maintain order. After all, that’s what the UN is for, isn’t it?

They will likely use troops who cannot speak English and have no familiarity with Ireland, its culture, or its people. If they are indoctrinated with Communism, better still. These guys and gals will do what they have to do. So, get set to welcome – at some unspecified time in the near future – tens of thousands of Chinese military personnel wearing the blue beret of the United Nations.

Perhaps some readers will think this is farfetched. After all, we are a civilized country with a long Christian tradition and a proven love of liberty. We would never tolerate such things.

To these I say: At the end of 2019 you would never have guessed that the entire country could be ‘locked down’, not once but twice, and our economy ravaged by insane government policies. We would never have guessed that we would be confined in our own homes for months on end and not even allowed to attend church services. We would never have guessed that small and medium-sized businesses up and down the country would be forced to close. We would never have guessed that educated, rational adults would drive about in their cars wearing silly rags on their faces. We would never have guessed that all medical services would be cancelled other than those relating to a ‘disease’ which virtually no-one seems to have.

### **Nationwide quarantine facilities**

A year from now we could see dozens of quarantine facilities in operation across Ireland, with tens of thousands of Irish men and women under lock and key (for their own protection!), guarded – and where necessary beaten – by Chinese military personnel wearing blue berets.



Seen in this light, the events of 2021 are looking much more predictable than those of 2020.

While we have no way of knowing whether the future will play out in this fashion, we would be very foolish to ignore the evidence before us, not to mention the stated intentions of Marxism, the rapacity of the British Establishment, and the ever-repeating lessons of history. Most important of all, we dare not take lightly the many warnings in the Bible which reveal a highly organized, worldwide tyranny in the End Time which greatly exceeds, both in its callous brutality and the scale of its carnage, anything seen before in human history.

Our government works for the International Dictatorship. They have no more regard for the welfare of the Irish people than they have for the slaves of Timbuktu. They will do whatever they are asked to do by the Crown, even if it means locking away – and perhaps killing – many thousands of Irish patriots.

## **The power of new technology**

Many doubt whether they have the necessary coercive powers to do this, but they are mistaken. History has shown that advances in technology can confer a decisive advantage on those who use it to best effect on the field of battle. The International Dictatorship has developed many “silent weapons” to debilitate the masses and lead them by stealth into slavery. Since we have dealt with this in previous papers, we won’t review these weapons here. However we would draw attention to a video presentation on YouTube which gives a stellar account – by an insider – of the way nanotechnology and micro-devices can be used, and are being used, as weapons against civilian populations.



The talk is by Dr James Giordano of Georgetown University, a Jesuit stronghold. This man’s resumé shows that he is highly qualified to describe what is really happening behind the scenes. He is the author of over 300 publications, 7 books, and 20 government white papers on neurotechnology and biosecurity. Currently he is a fellow at the US Naval War College at Newport, specializing in biosecurity; chair of the neuroethics program of the IEEE Brain Initiative; senior science advisory fellow at the Strategic Multilayer Assessment Branch of the Joint Staff at the Pentagon; and a member of a high-level advisory panel at DARPA.

According to his bio on the Georgetown website, “His ongoing research addresses the neurobiological bases of neuropsychiatric spectrum disorders; and neuroethical issues arising in and from the development, use and misuse of neuroscientific techniques and neurotechnologies in medicine, public life, global health, and military applications.” In short, this guy works for the Pentagon and DARPA developing military applications based on neurotechnologies, with a special interest in the possible misuse of such weapons.



## **Neuroweapons**

The talk was given before an invited audience at the Center for Global Security Research at the famous Lawrence Livermore National Laboratory in California on 12 June, 2017. It was titled “**Brain Science from Bench to Battlefield: The Realities and Risks of Neuroweapons**” and may be found at:

Starting at 43:26 he describes a type of psychological weapon which exploits the fact that 10 percent or more of the general population are borderline hypochondriacs, often called “the worried well.” A few small groups here and there among the general population are selected and secretly given a toxic substance which makes them seriously ill. News begins to spread about these unexplained “outbreaks.” The public is then told via various sources on the Internet that a dangerous virus has been released which causes anxiety, paranoia, and sleeplessness. The CDC denies that the virus exists but the “worried well” are convinced that it does. They all experience the paranoia and anxiety that the “virus” is supposed to cause and have difficulty sleeping. They flood emergency rooms and clinics looking for treatment.

## – Australian Bill –

### Defence Legislation Amendment (Enhancement of Defence Force Response to Emergencies) Bill 2020

- b. providing ADF members, other Defence personnel and members of foreign forces with similar immunities to State and Territory emergency services personnel in certain cases while performing duties to support civil emergency and disaster preparedness, recovery and response (Schedule 2)

#### SCHEDULE 2 – IMMUNITY

24. This Schedule inserts a new provision in the Act to give ADF members, other defence personnel and foreign armed forces immunity from civil and criminal suit in relation to actions done in good faith performance of their duties, where the duties are in relation to certain assistance provided in the context of a natural disaster or other emergency.

#### Items 2 and 3

26. These items amend the delegation power in section 120A of the Act. New subsection 123AA(4) provides for the Secretary or the CDF to authorise a Commonwealth employee or member of a foreign armed force to provide relevant assistance under new subsection 123AA(1). This has the effect of these individuals becoming a ‘protected person’ for the purposes of subsection 123AA(1).

**The above are extracts from a Bill currently working its way through the Australian parliament.**

**It enables the government to authorize the use of “foreign armed forces” on Australian soil and gives them the same immunities as members of the ADF. The government may do this in response to a natural disaster or “other emergency.” The latter is not defined. What kind of emergency requires foreign armed forces?**

He is actually describing – back in 2017 – how Covid-19 hysteria works. It began with an engineered spike in morbidity and mortality. Then simple symptoms were taken as evidence of a deadly contagious disease by the “worried well.” Those who were most anxious suffered shortness of breath and asked to be put on ventilators, of which 97% died.

Since the worried well are never able to set aside their irrational anxiety, they will continue to spin in this hamster wheel as long as the media keep the hoax in motion. Add a steady flow of government lies and the ‘pandemic’ could run for years.

The next part of his talk takes this scenario to a whole new level. A phony pandemic could be turned into a full-blown public health disaster by secretly killing even more people and attributing their demise to a dangerous mutation of the original ‘virus’. This will terrify everybody, not just the worried well, and enable the authorities to isolate and quarantine large numbers of innocent people. Virtually everybody will do what they’re told.

### **What will cause the next ‘spike’ in mortality?**

This is roughly where we are now in the pandemic scam. The question we need to ask, therefore, is how exactly the next spike in mortality will be produced. Dr Giordano provides a possible answer in the segment of his talk between 44:52 and 46:30 [Note: The acronym CNS refers to the Central Nervous System]:

If I wanted to do something that’s a little bit more proximate I can utilize nano-particulate matter. We can utilize nanoscience to create much better drugs to get them where they got to go in the brain. I can create nanoscience and nanotechnology that will escort certain drugs across the proliferate barrier, which is the blood brain barrier, or through the spinal fluid barrier, so I get these things where they got to go.



But I can also utilize nanoparticulate matter in a very indiscriminate way. The idea here is that I can get something called high CNS aggregation material that is essentially invisible to the naked eye, even to most scanners, because it is so small that it selectively goes through most levels of filter porosity. These can be inhaled, either through the nasal mucosa or absorbed through the oral mucosa. They have high CNS affinity. They clump in the brain or in the vasculature, and they create essentially what looks like a hemorrhagic diathesis, in other words a hemorrhage predisposition or a clot predisposition in the brain. What I've done is I've created a stroking agent. And it's very, very difficult to gain attribution to do that.

I can use that on a variety of levels, from the individual to the group. Highly disruptive. And in fact this is one of the things that has been entertained and examined to some extent by my colleagues in NATO and by those who have been working on the use of neurobiological sciences to create populational disruption. [I am] very, very worried about the potential for these nano-particulates to be used as CNS aggregating agents to cause neural disruption, either as hemorrhagic and vascular disruptors or as actual neural network disruptors, because they interfere with the network properties of various neural nodes and systems within the brain.

Let's put what he said in plain language: Tiny, undetectable particles can be released as an aerosol above a town or city and absorbed unknowingly by the general population. These particles will migrate to the brain and form clusters that will block the flow of blood. Many will suffer a serious or fatal stroke, but no doctor on earth will be able to identify the real cause. These 'nanoparticles' have already been developed and may even have been tested in a live situation by NATO.

Dr Giordano says he is "very, very worried" that this weapon could be deployed on a wide scale against innocent civilians. I would take this comment to mean that he has already heard rumors that parties unknown intend to do just that.

### **Using 5G as a weapon**

The other main stealth weapon that can be deployed "in a very indiscriminate way", to use Dr Giordano's term, is an EMF projector, specifically 5G operating in the 60GHz range. This can be used to stimulate the oxygen molecules in the air around us and prevent our lungs and our blood from extracting it in sufficient quantities. This artificially induced hypoxia will immediately disable the target and can prove fatal.

With 5G antennas being installed all over Europe and America in 2020, the scope for producing serious adverse, undetectable health effects in an “indiscriminate way” is simply limitless. With wingspans of a hundred feet or more, the Google drones can work in a phased array to deliver powerful millimeter beams at ground level. In 2019 NASA tested one of its own at 65,000 feet, using it to direct 5G to any part of the earth’s surface. A dose of 5G radiation produces symptoms that are very similar to those of ‘Covid-19’.
