Bible-ban Pending in Ireland and California

The scale and intensity of the attack on Christian values continues to increase. The arrogance of the architects of the New World Order and the retinue of toadies who follow and support them is truly jaw-dropping.

The implementation of the NWO depends for much of its devious and deceitful work on the input of these toadies. Many can be found in the political realm. Their role is to push through laws and regulations which advance the NWO agenda, usually by crowing over their supposed merits and unspecified benefits.

These laws and regulations are often disguised as something else, and are laden with weasel words whose real meaning only becomes apparent when they are "interpreted" by their cronies in the judiciary. A piece of draft legislation, which appears to mean one thing during the passage of a Bill, can mean something quite different once the Act is passed and the courts proceed to fashion from its seemingly innocent provisions yet another weapon to attack and undermine traditional Biblical values.

All of the main political parties in western democracies are working toward a New World Order. They are marching in step with a plan imposed from above, where one civil liberty after another is being legally redefined in accordance with the humanist values of the NWO. In this way traditional Biblical values are being deliberately and systematically erased from the constitutional and statutory provisions of western democracies.

Marxism

Their aims are very similar to those expounded by Marxist theoreticians of the early 20th century, namely, to 'redefine' marriage and the family; separate sexuality from procreation; place children under state-controlled care from an early age; eliminate private property; abolish inheritance rights; outlaw religion other than creeds and institutions approved by the state; legalize abortion and divorce; restrict freedom of speech; restrict freedom of movement; restrict freedom of assembly; restrict or eliminate the accumulation of capital; and make fundamental human rights subservient to the goals and aspirations of the state.

They have since identified gender as a key target in this program. As a basic building block in all social relationships, a foundation that remains constant throughout life, it enables viable and productive social institutions to remain stable from one generation to the next. However, if gender is fluid – or perceived to be fluid – then those same institutions suffer accordingly and lose the integrity and permanency they once enjoyed.



Some of the blows inflicted to date have been grievous. Under Irish law, a husband can now register his gender as 'female' and even have his birth certificate changed retrospectively. He is not required to consult his wife in this matter; neither is he required to submit any medical evidence in support of his application. Once his request is placed in the mail, his marriage and family relationships have effectively been obliterated.

Or take the case of a boy who, at age ten, becomes convinced on foot of a program he saw on television, that he was "born in the wrong body." He now believes he is really a girl "trapped" in the body of a boy, a condition he greatly resents. Following legislation introduced in many countries in recent years, the parents of that child will have great difficulty finding suitable professional help for him. Many psychiatrists and counsellors will actually reinforce the boy's delusions, and in some jurisdictions the parents may be penalised in some manner if they continue to insist that the gender of the child was fixed at birth and cannot be changed.

Sinn Féin

Modern Marxists no longer operate under their old moniker. They have learned that far more damage can be inflicted on society if their Marxist credentials are hidden from view. So, while masquerading as progressive socialists, social democrats, or one of many similar titles, they have wormed their way into the heart of most western democracies.



The Irish Marxist party is better known as Sinn Féin. The people of Ireland rather foolishly think of Sinn Féin as the civil (or civilized) wing of the IRA, when in reality the IRA is the ever-ready military arm of Sinn Féin. These cunning individuals have worked their way across the Irish political spectrum over the past three decades, disguising themselves in turn as the Workers Party, the Democratic Left, and the Labour Party, respectively. Today its most prestigious members are able to market themselves directly as Sinn Féin, a party of the people. This strategy has been so successful that it recently surpassed Fianna Fáil as the second most popular political party in the state.

Like every national Marxist party, Sinn Féin is a tool of the New World Order. As a subversive change agent it scorns national identity while pretending to defend it. It has now secured a strong foothold in the Irish parliament and is starting to sponsor legislation under its own name.

Its most outrageous contribution to date is a Bill introduced in the Seanad (the Irish senate or upper house) called The Prohibition of Conversion Therapies Bill 2018. Since it appears to be modelled on a similar bill currently before the state legislature of California, we will look first at the latter and its development.

California

The state of California introduced a sweeping piece of legislation in 2012 [SB 1172] which banned the provision of conversion therapy to minors on a commercial basis. It is now no longer possible for concerned parents to secure professional counselling for a son or daughter who thinks he or she might be homosexual. A Bill [AB 2943] is now before the legislature which seeks to extend this ban to the provision of all such services in the state of California.

AB 2943

The Californian Bill – AB 2943 – begins by naming a long list of professional bodies which have condemned conversion therapy, including:

The American Academy of Pediatrics (1993) The American Medical Association (1994) The National Association of Social Workers (1997) The American Counseling Association (1999) The American Psychiatric Association (2000) The American Psychological Association (2009) The American Psychoanalytic Association (2012) The American Academy of Child and Adolescent Psychiatry (2012) The Pan American Health Organization (2012) The American School Counselor Association (2014) The American College of Physicians (2015).

Amongst the many claims made by these bodies, conversion therapy or "sexual orientation change efforts" are "coercive" and "fraudulent" and can cause "serious harm" to the individual. Indeed, the preamble to the Bill, which seeks to justify this draconian measure, gives a dramatic summary of the effects that this treatment is alleged to cause:

"...sexual orientation change efforts can pose critical health risks to lesbian, gay, and bisexual people, including confusion, depression, guilt, helplessness, hopelessness, shame, social withdrawal, suicidality, substance abuse, stress, disappointment, self-blame, decreased self-esteem and authenticity to others, increased self-hatred, hostility and blame toward parents, feelings of anger and betrayal, loss of friends and potential romantic partners, problems in sexual and emotional intimacy, sexual dysfunction, high-risk sexual behaviors, a feeling of being dehumanized and untrue to self, a loss of faith, and a sense of having wasted time and resources."

Ironically, this list could just as easily be taken as a description of the consequences of living a homosexual lifestyle. How can the professional bodies in question possibly tell the difference?

More NWO pseudo-science

Much of the 'science' behind this research is purely speculative, based largely on the political and moral convictions of its authors, as well as, in many instances, their sexual orientation. The psychiatric profession never seems to have difficulty finding data that proves its pet theories. Since they also exercise a monopoly in this field, we have no way of refuting their claims (in accordance with *their* standards of proof), other than citing anecdotal evidence to the contrary. We have all heard of cases where, through effective intervention ("conversion therapy"), a person with strong homosexual leanings was able to rediscover and express his true heterosexual nature.

We also know that many young people, especially adolescents, go through an emotional phase characterized by same-sex attraction and some degree of gender confusion. This transient condition usually passes quite normally and no intervention is required. However, if the person becomes fixated on his feelings and seeks professional guidance, he or she has – until now – been able to obtain it.

SB 1172

The Act of 2012 - SB 1172 - completely changed all of this. It made it illegal for any professional to provide counselling to a person under the age of 18 with a view to changing his or her sexual orientation. The civil servants who prepared the explanatory memorandum that accompanies the 2018 Bill explained the prohibition as follows:

"Specifically, SB 1172 prohibits a "mental health provider" (defined as a physician and surgeon specializing in the practice of psychiatry, a psychologist, a psychological assistant, intern, or trainee, a licensed marriage and family therapist, a registered marriage and family therapist, intern, or trainee, a licensed educational psychologist, a credentialed school psychologist, a licensed clinical social worker, an associate clinical social worker, a licensed professional clinical counselor, a registered clinical counselor, intern, or trainee, or any other person designated as a mental health professional under California law or regulation) from conducting any "sexual orientation change efforts" with any patient under 18 years of age. SB 1172 also provides that any such sexual orientation change efforts by a mental health provider involving a patient under 18 years of age is unprofessional conduct and subjects the provider to discipline by the provider's licensing entity."

So, if you are aged 17 and you seek wise counsel from a qualified professional regarding your sexual orientation, any professional who offers to assist you will risk being struck off.



This draconian law was challenged in the courts. The first challenge related to freedom of speech (which is guaranteed by the First Amendment). The court rejected this argument on the grounds that "doctors are routinely held liable for giving negligent medical advice to their patients" without any suggestion that their First Amendment rights were being violated. In other words, the court accepted as self-evident the claim that conversion therapy is a harmful practice and should not be permitted.

It stated, furthermore, that the individual's religious freedom (also guaranteed by the First Amendment) was not infringed because the policy enforced under the law was "generally applicable, neutral, and does not regulate [the] plaintiffs' beliefs as such." This involves a serious corruption of what we normally understand by the term 'religious freedom'. The court applied it to one's beliefs <u>only</u>, and took no account of the fact that religious freedom also entails activities and practices which cannot be reduced to "beliefs as such." This is a stark example of the way the NWO is twisting traditional legal concepts to fit their own agenda.



By this and similar means the right of parents to care for their children without undue interference from the state is being continually eroded. In this instance the court ruled that the state is entitled to restrict access to certain services that it deems unsafe in just the same way that it can mandate parents to have their children vaccinated. In other words, an unlawful intervention in one set of circumstances is being used as a legal precedent to justify an unlawful intervention in another. This is typical of the tactics used by the NWO.

How AB 2943 differs from SB 1172

Rather than offering our own interpretation of what the current Bill, AB 2943, is designed to achieve, we give here the analysis provided in the official explanatory memorandum (Note that SOCE means 'sexual orientation change efforts' or conversion therapy):

"This bill seeks to extend SB 1172's prohibition on sexual orientation change efforts. While existing state law makes it illegal for licensed mental health providers to engage in SOCE with minors, the practice is lawful for mental health providers (and all other lay and professional practitioners) to conduct with consenting adults. This bill seeks to extend the prohibition of SB 1172 in several ways. First, it seeks to apply the prohibition on the performance of SOCE to all persons, regardless of age. Second, it seeks to extend SB 1172's prohibition – limited to therapy efforts by mental health providers and with minors – to all persons who engage in SOCE. Finally, this bill seeks to prohibit the "advertising or offering" of SOCE, as well as SOCE itself.

"Thus, unlike the SB 1172, this bill would apply to all persons, including but not limited to mental health providers, who engage in SOCE on a commercial basis, as well as the advertising and offering of such services." So the 2018 Bill is designed to extend the prohibition of 2012 to <u>all persons</u>, not just minors (as recipients) and mental health providers. However, due to the way the Bill is worded, this sweeping prohibition may not be apparent to many readers. This is due to the inclusion a highly unusual double prohibition in the Bill, where the service itself is banned, along with all advertising of the service. One would naturally assume that, if a service is banned, then there would be no need to also include an explicit provision to ban advertisements that offer the service. By means of this unnecessary device, the Bill gives the impression that it is only designed to ban advertising and that the service itself is still legal. As we have seen, this is not the case. The Bill ensures that no mental health provider (or anyone else for that matter) in the state of California can provide this service to anyone, regardless of their age.

Religious Freedom

The explanatory memorandum touches on a question of great importance to pastors and ministers of religion. Does the Bill pertain only to the service when it is provided on a commercial basis (where the counsellor is paid for the service) or is it applicable even in cases where no payment is involved? The authors of the memorandum comment as follows: "Here, the bill does not apply to non-commercial activities, and therefore **would seem** to exempt religious and moral counselors who are unpaid." [*emphasis added*]

It is hard to find comfort in the words "would seem".

They go on to say:

"Furthermore, the bill **should** have no impact on the ability of unpaid would-be counselors, including religious or spiritual advisors and anyone else who attempts to counsel other persons to change their sexual orientation, as long as such efforts are conducted on an unpaid basis." [*emphasis added*]

"Should"?

Clearly the Bill leaves open the possibility that pastors and clergy could be charged with a criminal offense. No-one will know for sure until it is tested in the courts, but the outcome is predictable since the courts in California have shown time and again a marked hostility toward traditional Biblical values.



This approach is clearly deliberate. The question could have been addressed simply by defining <u>who</u> exactly constitutes an SOCE provider, but it doesn't. As the memorandum states: "The only difference between the two definitions is that SB 1172 includes a description of *who* provides the SOCE and this bill does not." [*emphasis in the original*].

The Bill effectively bans certain passages in the Bible

So those who have argued that the Bill [AB 2943] is intended to prohibit Christians from upholding and observing certain passages in the Bible are correct. In effect, the Bill makes illegal those verses of Scripture which condemn or proscribe homosexuality and criminalizes anyone who – under the circumstances described in the Bill – acts in obedience with those verses.

It should be understood that an Act that bans part of the Bible is actually banning the entire Bible since no verse in Scripture can be deleted or amended. God's Word is given to us as an indivisible statement of His will for mankind. Thus any Christian who upholds His Word upholds it in its entirety.

The Bill will make it extremely difficult for Christian pastors and ministers to counsel homosexuals in a Biblical manner. Preachers, too, will be greatly constrained. Since the line is not clearly drawn, many will err on the side of caution. Few will openly condemn homosexuality and the homosexual lifestyle lest their words be construed as an attempt to counsel or influence one or more members of their congregation.

The Bill will also put great pressure on booksellers and publishers to make available only those translations of the Bible which have significantly modified and watered down the original meaning of the passages that condemn homosexual behavior. This would suggest that one of the main objects of the Bill is to put the Authorized or King James version of the Bible out of circulation.

The New World Order is Satan's chief ally on earth in his war against God. Like the Amalekites, it will continue to prey on the hindmost, snapping and snarling at those who are lagging behind. Christians whose faith in God and His Word is weakest will fall first. This Bill will greatly accelerate this process by allowing the enemies of Christianity to sit in the pews and watch for an opportunity to strike at the very heart of the church. A pastor who is truly faithful to God's Word could soon find himself before the courts, expending precious time and energy and scarce financial resources defending himself against unfounded and despicable charges as a result of this Bill.



The Irish Bill

The Irish Bill is even more extreme than its Californian counterpart. In typical Sinn Féin style, it is entirely without subtlety. It baldly stipulates that an Irish citizen may be imprisoned for up to 6 months and/or fined up to €5,000 if he/she (a) offers to perform conversion therapy on a person, (b) advertises such a service, or (c) takes a person to another country to receive conversion therapy. (The penalties are doubled for professionals.)

It should be noted that the mere <u>offer</u> of conversion therapy is an offense punishable by imprisonment. There is no requirement under the Bill for the person making the offer to have the necessary professional skills. Thus a concerned pastor who refers to conversion therapy as a real option (to be secured on the person's own initiative outside the country) could be construed to have "offered" the service. The burden of proof is so vague that virtually any positive mention of conversion therapy could be construed as an offense under the Bill as it currently stands.

Significantly, the Bill makes it perfectly plain that an offense is committed <u>even if no</u> <u>financial payment is offered or made</u>.

The Bill also includes a provision worthy of a Gulag state. Any person who tries to leave the country with another person, with a view to procuring conversion therapy elsewhere for that person, is guilty of an offense. Stalin would have been proud of the twenty senators who put their names to this despicable document.



If anyone doubts the venality of the New World Order and its wicked agenda, they should reflect on this provision. Bear in mind that the twenty senators behind the Bill represent all of the main political parties in Ireland. It is solid proof, if proof were needed, that the country in controlled by a single political entity, and that the various 'parties' are merely the façade through which it operates.

When pastoral care is a crime

We can see that, by including a travel ban, the Bill goes even further than its Californian counterpart. A church pastor or minister in Ireland will almost certainly be found guilty of an offense if he urges any member of his congregation to seek conversion therapy. A parent who takes his son or daughter abroad to receive such therapy would also be guilty of an offense. It is immaterial whether the recipient actively sought professional intervention and pressed his parents to assist him.

Ireland differs little in many respects from a one-party Marxist state. Behind a multiparty façade, an organized assault is being conducted against traditional Biblical values. The institution of marriage was destroyed in 2015 when the nation, directed by the government, voted overwhelmingly to legalize 'marriage' between two homosexuals. With the passage of the Gender Recognition Act in the same year, a man could become a 'woman' in law, and a woman could become a 'man'. Ireland's genderinversion law is probably more liberal than that of any other country. Just yesterday, May 25th, following immense pressure from politicians of all parties, the people of Ireland voted by an astonishing margin to legalize the murder of a significant proportion of their unborn children. And with this draconian Bill, courtesy of the Marxists in Sinn Féin, anyone who tries to uphold the Biblical position on homosexuality will be guilty of a criminal offense and liable to receive a 6-12 month prison sentence.

If this nasty piece of draft legislation is passed by the Irish parliament, it will make Ireland the most oppressive political regime in western Europe for born-again Christians. Anyone who preaches the Bible as it should be preached will run the risk of committing a criminal offense. Anyone who expounds the Bible as it should be expounded, even in writing, could be charged with promoting ("advertising") conversion therapy. Even if he or she is not advocating a specific provider, the open endorsement of a proscribed service would likely constitute an offense under the proposed legislation.



CONCLUSION

Events are developing rapidly. The NWO is deliberately promoting sexual perversion, gender inversion, sodomy and pornography in grand style, all with a view to attacking and destroying Biblical Christianity. Certain countries appear to have been chosen to spearhead this agenda, notably Masonic strongholds like Scotland, Canada, Ireland, New Zealand, and Australia. Scotland has its 'named person' law, which enables a designated public servant to raise with one's son or daughter the possibility that they might be homosexual or that they were born in the wrong body and ought to change their gender. Canada has made it illegal to disseminate literature which is critical of transgenderism or warns of its dangers. The parliament in New Zealand recently displayed the so-called Intersex Flag, the first national parliament to do so. The Australians are making it illegal to give to children any book or toy which implies the recipient is definitely a boy or definitely a girl. All books and toys will be required to pass a gender-neutrality test. And Ireland is leading the way in gender inversion, Bible censorship, and religious intimidation.

This is more than just a 'trend'. It is a deliberate worldwide program of moral subversion, financed by the Elite and driven forward by the cabal of generational Luciferian families that currently control most western nations.

The Irish Dáil and Seanad are filled largely by members of 'royal' bloodlines, the selfappointed ruling dynasties which from time immemorial have worshipped Baal. The same sinister clique set up the shrine to Baal in the center of Dublin in 2003 known as the Millennium Spire. Many of them are secretly transgender.

Regardless of whether or not this Stalinist Bill is passed in its current form, its very existence is proof that Ireland's ruling elite despise Christianity and that they are determined to impose the perversions of the New World Order on a shameless and impenitent population.
