# **Controlled Demolition:** The Coming Constitutional Crisis


# **Controlled demolition**

The premise behind those papers was basically as follows: The Elite have long planned to replace the existing system of constitutional democracy in the United States with a permanent oligarchical regime. Over several decades they have been installing here and there, in strategic locations, the 'explosives' that will bring down the existing system. To be certain of success, this controlled demolition must reach as far as the President. His Office must be undermined and its credibility destroyed. This is best achieved, not by bringing down the incumbent, à la Nixon, but by sabotaging the legitimacy of the electoral process itself. Unless the public is satisfied that victory was secured by fair and honorable means, a substantial proportion of the American people will reject the result and call for a fresh election.

Serious social unrest is inevitable, bringing street riots, looting, and immense economic uncertainty. If the result cannot be established for several months, then the public will lose confidence in the ability of the system to produce a clear winner, even if a fresh election was called. The longer the matter is allowed to drag out, the louder and more strident the calls will be for the Military to intervene and restore order. An interim 'Administrator' could assume executive power – possibly following a plebiscite of some kind to give a semblance of legitimacy to this revolutionary act. Securely in situ, the autocrat would move immediately to arrest all who opposed him. Congress would be suspended and martial law imposed.



We give below the scenario that we projected in June 2016 (#97), with relevant changes in respect of 2020 shown in the margins:



Much of our analysis in that paper was based on an earlier one published on our website on 8 August, 2012, which was later included as an Appendix to #141. In it we showed how the Constitutional crisis had already been "predicted" in a prize-winning military essay by Lieutenant Colonel Charles J Dunlap, *The Origins of the American Military Coup of 2012*, which was published in 1992.

# **Shattered Union**

Another predictive exercise was conducted in 2005 when a video game called *Shattered Union* was released. Here is how we described it in our earlier paper, #97:



Video games are being widely used to desensitize young people to violence, especially gratuitous brutality and conflict in an urban setting. A game called Shattered Union was released in 2005 which took this theme a step further and based it on the destruction of the United States by its own population. As an exercise in predictive programming is very compelling. It builds on the premise that the United States slips unexpectedly into civil war when a disputed Presidential election gives rise to intense social unrest, with widespread rioting and looting in cities across America. The count in the Electoral College resulted in a tie between the two main Presidential candidates. When Congress stepped in and arbitrarily picked a 'winner' the supporters of the losing candidate were extremely upset. In their eyes the election had been stolen. The new President was immensely unpopular, implementing martial law in the areas worst affected, and even subverting the Supreme Court in order to stay in office. A terrorist attack on Washington DC about this time was so destructive that it wiped out the entire government. In the ensuing chaos, several states seceded from the Union, and more followed later. Before long the nation was divided into six autonomous territories, each of which sought to extend its control into neighboring states and rebuild the shattered union.

Both the Dunlap essay and the video game anticipate, with surprising accuracy, the scenario that we see unfolding today.

In paper #97 (June 2016) we looked briefly at the disruption and turmoil, both national and geopolitical, that could spring from a protracted Constitutional crisis involving the Office of the President of the United States:

It is not difficult to see how a Constitutional crisis of this magnitude could lead to rioting in the streets and immense social unrest. The anxieties caused by an economic collapse, in particular its impact on 47 million recipients of food stamps, would add even more fuel to the fire. Home-grown anarchists, ghetto gangs, and various disaffected groups would rush to exploit the situation. A 'what have we got to lose?' mentality could spread very rapidly and cause social unrest to escalate to the point where the President – the very unpopular Mrs Clinton, viewed by many as an unconvicted felon – would introduce martial law in the cities most affected.

If, as the Shattered Union video game suggests, Putin sends his troops into Alaska, the American people may not offer any serious resistance. The loss of sovereign territory on the Arctic Circle would mean little or nothing to the average American struggling to feed and protect his family. This could embolden China to seize Taiwan and, very possibly, the Hawaiian Islands. At that stage the Illuminati would have what they have been building toward for several decades, another World War.

# Conditioning the public

The planned crisis will have greater momentum if the public already believes it could actually happen. Humanly we tend not the question the real cause behind a disturbing turn of events if we have been told in advance that it cannot be ruled out. This advance conditioning may reduce the shock to some degree but, for the Elite, it is a small price to pay if it means the vast majority of people will tamely accept the official explanation.

One of the earliest hints that this crisis scenario was being seriously considered came via *The Daily Show* on 11 June, hosted by Trevor Noah. Presidential candidate, Senator Joe Biden, was asked for his views about the upcoming election. He replied, "My single greatest concern? That the President is going to try and steal this election."

He was then asked if he had considered what would happen if President Trump refused to relinquish the presidency and vacate the White House if he lost the election. He said he had considered this possibility but was confident that senior figures in the <u>military</u> would not tolerate such conduct: "'I am absolutely convinced they will escort him from the White House with great dispatch [i.e. quickly and efficiently]."

Given that Biden has trouble with plain English, his reply, with its use of the archaic phrase "with great dispatch," sounds like a prepared answer to a prepared question. The Elite are planting in the minds of the electorate the otherwise unthinkable possibility that a defeated President would actually refuse to leave office.

President Trump added to this bizarre speculation when, in an interview with Chris Wallace of *Fox News Sunday* on 19 July, he refused to confirm that he would facilitate a peacful transition: "I have to see... No, I'm not going to just say 'Yes'."

A few days later he issued the following Tweet, calling for the 2020 Presidential election to be <u>postponed</u> on the grounds that, with universal mail-in voting, it could become the most inaccurate and fraudulent election in history:



Ever since then he has repeatedly questioned the legitimacy of the November election. Just a few days ago, in his televised debate with Biden on September 29<sup>th</sup>, he declared – perhaps to the horror of millions of Americans – that "This is going to be a fraud like you've never seen."

He's following the script. The scenario envisaged by Lieutenant Colonel Dunlap and the makers of *Shattered Union* is being played out before our eyes.

# Adding fuel to the fire

Other parties have become embroiled in what is looking increasingly like a coordinated move by influential figures to add fuel to the fire. For example, on 11 August, in a lengthy warning to General Mark A Milley, Chairman of the Joint Chiefs of Staff, two retired senior officers in the US Army — Lieutenant Colonel John Nagl and Lieutenant Colonel Paul Yingling — stated that the Military must decide in advance how it will act if President Trump refuses to vacate the White House on January 20. Here is how they sketched the critical moment:

"Then the clock will strike 12:01 PM, January 20, 2021, and Donald Trump will be sitting in the Oval Office. The street protests will inevitably swell outside the White House, and the ranks of Trump's private army will grow inside its grounds. The speaker of the House will declare the Trump presidency at an end, and direct the Secret Service and Federal Marshals to remove Trump from the premises. These agents will realize that they are outmanned and outgunned by Trump's private army, and the moment of decision [for the Military] will arrive."

More remarkable still is an initiative known as the Transition Integrity Project (TIP), a bipartisan consortium which came together late last year to examine the factors – all Trump-related – that might threaten the legitimacy and outcome of the 2020 Presidential election.

It consisted of more than a hundred senior political figures, academics, social media experts, journalists, campaign managers, and former career officials from the intelligence community, the Justice Department, the Military, and the Department of Homeland Security. All were Democrats or disaffected Republicans.

One might wonder why such busy professionals would come together in this way and give of their time over a period of months to a matter that was purely speculative and, most importantly, of no immediate relevance to most of those involved. Indeed, one might ask why they would even undertake a task which many Americans would regard as potentially subversive in nature.

Here is how one conservative commentator reacted to their report, which was published on 3<sup>rd</sup> August:

"This thoroughly disgusting, anti-American, seditious and treasonous document pretends to be of scientific character [and] to foresee the future, making claims at simulations and game scenarios. This veneer is false because, for one thing, the results are crafted by leftists, radicals, former government officeholders and campaign officials, united against Trump."

# The people behind TIP

We'll begin with the people involved. TIP was 'founded' by two closet communists, Rosa Brooks and Nils Gilman:

### **Rosa Brooks**


Brooks is Schwartz Senior Fellow at *New America* and Professor of Law at the oldest Jesuit law school in the US at Georgetown University. *New America* is a think-tank funded by the NWO Elite, including Bill Gates, Eric Schmidt (CEO of Google), Pierre Omidyar (eBay founder), the Rockefeller Foundation, the Ford Foundation, and even the State Department.

It says a lot about America today that the State Department is funding an organization with direct links to a high-level initiative to undermine democracy.

Shortly after Trump took office, Brooks wrote an essay for *Foreign Policy* magazine in which she suggested four ways to remove him before his term expired. The last of her options was not just unpatriotic – it was seditious: "The fourth possibility is one that until recently I would have said was unthinkable in the United States of America: a military coup, or at least a refusal by military leaders to obey certain orders."

#### Nils Gilman

Gilman is a vice president at the Berggruen Institute, which Wikipedia describes as "an independent think tank aimed at reshaping political and social institutions in the face of the great transformations of the 21<sup>st</sup> century." (Great transformations?) The Institute includes the 21<sup>st</sup> Century Council, a behind-the-scenes version of the G20 which comprises former heads of state. Attendees at its meetings have included Henry Kissinger and Xi Jinping, now permanent Chairman of the Chinese Communist Party. The Institute was endowed with \$500 million at its foundation by the French billionaire and CFR member, Nicolas Berggruen. In typical Illuminati style, his two children were born from two surrogates implanted with eggs from the same donor. Berggruen is also the co-author of a book published in 2012, *Intelligent Governance for the 21<sup>st</sup> Century*, which seeks to replace Western democracy with a 'better' form of government.



A complete list of all TIP members has not been released, but several names are known. They include:

#### John Podesta

Another Georgetown law professor. Podesta has close working ties to the Clintons.

#### William Kristol

Founding director of *Republican Voters Against Trump*. Cofounder of PNAC in 1997, whose members included Dick Cheney and Donald Rumsfeld.

#### Norman Eisen

An 'old friend' of Obama from Harvard Law School. Married to Lindsay Kaplan, associate professor at Georgetown University.

# **Colonel Larry Wilkerson**

Former chief of staff to Secretary of State, Colin Powell. In an interview on 29<sup>th</sup> June of this year, Wilkerson compared the political situation in the US today with that of Russia in 1917 and Iran in 1979, thus implying that sweeping regime change by revolutionary means could be expected.

#### **Michael Steele**

Graduate of Georgetown Law School. Entered a seminary for three years to prepare for the Catholic priesthood. Former Lieutenant Governor of Maryland.

#### **David Frum**

A former speechwriter for President George W Bush. Coined the phrase "Axis of Evil." Former fellow of the American Enterprise Institute.

#### **Max Boot**

Born in Moscow, USSR. Senior Fellow and staff writer with the CFR.

#### **Donna Brazile**

Former Adjunct Professor of Women and Gender Studies at Georgetown University. LGBT activist.

#### **Zoe Hudson**

Former senior policy analyst with the Open Society Foundation run by George Soros. [Hudson is the Director of TIP.]

## **Chuck Hagel**

Former Secretary of Defense. Former professor at the Edmund A. Walsh School of Foreign Service at Georgetown University.

#### **Michael Chertoff**

Co-author of the Patriot Act and former head of Homeland Security.

#### **Norman Ornstein**

Member of CFR. Resident Scholar at the American Enterprise Institute, which provided the main advisors to Bush Jr for the "war on terror" – John Bolton, Paul Wolfowitz and Richard Perle.

Anyone who is familiar with these people and the organizations they work for will see the pattern. A slew of Jesuit agents are working with secular Zionists, such as B'Nai B'rith and international Freemasonry, to advance the goals of the New World Order. Since this will necessitate a radical transformation in the way America is governed, there is ample scope for a group like this to influence the way the transformation is carried out. After all, there are few modes of political transformation as radical as a military coup – which, as we noted, was one of the options suggested by Rosa Brooks.




# **Evidence of treason**

We find plenty of evidence in the TIP report to support Michael Rozeff's opinion that the document is "thoroughly disgusting, anti-American, seditious and treasonous."

The TIP conducted several war-gaming exercises in June in which they tried to determine the immediate social and political impact of four possible election results. In three of the four possible scenarios they concluded that a Constitutional crisis was inevitable. A "peaceful" outcome could only be expected, they said, where Biden achieved a landslide victory (which we will call scenario (1)).

In each of the other scenarios that they considered – (2) where the election result remained unclear for several months, even to the date of the Inauguration; (3) where Trump had a clear victory in the Electoral College but was a clear <u>second</u> in the popular vote (as in 2016); and (4) where Biden achieved a narrow victory in both the Electoral College and the popular vote – supporters in one or both camps were so upset that violent street protests erupted all over the country and public confidence in the selection process evaporated: "The results…were alarming. We assess with a high degree of likelihood that November's elections will be marked by a chaotic legal and political landscape." (TIP)



The following quotations from the report reveal the extent to which the participants have veered from constitutional democracy and chosen instead to revel in its destruction. Throughout the report, which is 22 pages long, we find an almost infantile obsession with improper conduct, illegal activity, social unrest, intimidation and lies, systematic misrepresentation, obstruction and fraud, litigation, cyber crimes, street violence, media propaganda and bullying, disregard for accepted procedures, political paralysis, foreign interference, and emergency intervention by law enforcement, the national guard, and the military. Whatever legitimate concerns the participants may have had regarding possible violations of correct electoral procedure, they are wholly subsumed in a Gothic extravaganza which can only be seen as a mischievous attempt to spark the very crisis they claim to abhor.

The assumption throughout is that Trump is a dangerous demagogue who will resort to every trick in the book – legal or illegal, peaceful or violent – to ensure that he remains in office:

"We assess that there is a chance the president will attempt to convince legislatures and/or governors to take actions — including illegal actions — to defy the popular vote... Of particular concern is how the military would respond in the context of uncertain election results."

"Voting fraud is virtually non-existent, but Trump lies about it to create a narrative designed to politically mobilize his base and to create the basis for contesting the results should he lose. The potential for violent conflict is high, particularly since Trump encourages his supporters to take up arms."

"The exercises suggest that Trump and his supporters are likely to engage in an orchestrated disinformation campaign to shape the public's perception – in fact, misperception – of the "facts" underpinning a dispute over electoral results."

"In addition, the exercises suggest that there is a significant possibility of simultaneous street mobilizations by both Trump and Biden supporters, in which case the possibility for violence will increase significantly, and the actions of law enforcement will become critical."

"In some scenarios examined by TIP, Team Trump succeeded in invoking the Insurrection Act and sending active duty military troops into US cities to "restore order," "protect" voting places, or confiscate "fraudulent" ballots."

"Of particular concern are the President's ability to federalize the national guard; to deploy the military domestically; to launch investigations into opponents and to freeze their assets; and even to control communication in the name of national security."

"[Following one scenario] the country was in the midst of a full-blown constitutional crisis characterized by: 1) Political chaos; 2) Widespread threats of violence, and sporadic actual violence in the streets; and 3) A hostile, dangerous, highly-partisan, and frequently unconstrained information and media environment."

# **Secession from the Union**

The Elite are telling us what they are planning. Incredibly at one stage they even spell out some of the revolutionary political changes they expect to make:

"The Biden Campaign encouraged Western states, particularly California but also Oregon and Washington, and collectively known as "Cascadia," to secede from the Union unless Congressional Republicans agreed to a set of structural reforms to fix our democratic system to ensure majority rule. With advice from President Obama, the Biden Campaign submitted a proposal to 1) Give statehood to Washington, DC and Puerto Rico; 2) Divide California into five states to more accurately represent its population in the Senate; 3) Require Supreme Court justices to retire at 70; and 4) Eliminate the Electoral College, to ensure that the candidate who wins to the popular vote becomes President."

Remarkable! Before Biden would accept a Trump victory he would demand – on foot of "advice from *President* [!] Obama" – several concessions from the President, including the division of California into 5 states, the annexation of Puerto Rico as a new state, and the elevation to statehood of Washington D.C. If he did not get these concessions then he would push to have three states <u>secede from the Union</u> – California, Oregon and Washington State.

This is shameless political skulduggery! That any document should propose the breakup of the Union in this way is tantamount to treason, but we have here what effectively amounts to an 'Establishment' document making such a recommendation.

If the Democratic Party succeeded through the use of such threats in creating several new states, then, based on the demographics of the regions concerned, it would greatly expand its political power base and gain an unshakeable grip on both houses of Congress. There would be no way thereafter to constrain its far-left agenda.

The report is really a call to arms by the Elite to all of the disaffected groups, radicals, leftists, fascists, subversives, anarchists, and extremists across America. They are being told: "We are planning to make chaos – come and join in!"
