
# **Darien Then and Darien Now**

The Enemy continues to recycle his old tricks, so we need to be familiar with what they are. As the Apostle Paul implied in his Second Letter to the Corinthians we should not be ignorant of his devices. Humanly there is only so much we can understand but, to the extent that we are able, we should get to know how he works.

We have long been taught that countries subjugate their neighbors by waging war against them. Our history books are full of examples of this, but they usually omit another, less visible form of oppression. This involves economic sabotage, where the resources of the target country are damaged in some manner, usually by stealth, and its economy eventually collapses. It is a very cost-effective method of conquest. No expensive armies are required and the infrastructure of the defeated nation is left intact for future exploitation.


Our textbooks should have many examples of this, but they seldom get a mention. For example, when the German army was retreating from France and Belgium at the end of the First World War, it flooded hundreds of coalmines and stole huge quantities of industrial machinery. What it couldn't steal it destroyed.

This extreme action served no military purpose since the war was already over, but it gave Germany a huge economic advantage over its rivals in post-war production. German goods could flood the international market and garner substantial profits, while the economies of 'victorious' countries, like France and Britain, which were still trying to recover from the War, were unable to compete with the low-cost output of German manufacturers.

### **Peacetime treason**

One of the most cunning acts of economic sabotage in Europe was conducted by England in the late 17<sup>th</sup> century. The stability of the monarchy after the death of Queen Elizabeth I in 1603 was secured by inviting James VI of Scotland, the natural son of Mary Queen of Scots, to become James I of England through a union of the two crowns. James could legally inherit both crowns in a personal capacity by virtue of his descent from the royal families of both kingdoms. The countries themselves, England and Scotland, would continue to function as independent sovereign kingdoms with their own parliaments, judiciary and statutes.

The English establishment wanted full political union between the two countries but they were not prepared to engage in a costly, drawn-out military campaign in order to subjugate the Scottish people. They knew from bitter experience how difficult that would be. Instead they decided to bide their time and await a non-military solution.



This came with the grand plan to create a central bank – the Bank of England – in 1694, along with a similar institution for Scotland in the following year. The ruling elite in both England and Scotland welcomed the installation of the Prince of Orange as William III of England and William II of Scotland in 1688. This was in effect a bloodless coup where the two countries passed into the hands of their continental counterparts. The goal now was the political unification of the two kingdoms.


The same person who oversaw the creation of the Bank of England, William Paterson, also came up with a plan to remove all popular resistance within Scotland to a legal union with England. This is known to history as the Darien plan, an immensely ambitious scheme to establish a trading colony in the Darien Gap in the isthmus of Panama.

## **The Darien Deception**

Even though the Scots had little capital to spare for essential purposes, they still managed to invest more than 20 percent in this high-risk project. A small group of influential businessmen promoted the scheme as a sure path to wealth and success. They claimed the colony would open a gateway to the Pacific and enable the Scottish people to reap the benefits of international trade. The most optimistic projections were offered to investors and the many risks involved were carefully played down. Furthermore, the Scottish government, which was led by the Duke of Edinburgh, actively supported the scheme and invested a significant amount of public funds. This reinforced the popular perception that the project was a safe and profitable venture.

In reality, the entire scheme was a ruse to impoverish the Scots. Everyone who had cash to spare bought shares in the company. Public interest was intense and funds poured in. As an investment undertaking it far outstripped anything the kingdom of Scotland had ever attempted.

Only the foolish and uninformed could fail to see that the scheme was doomed to failure. Ships had to be purchased and then equipped with substantial provisions to support an expedition of 1200 men. Little account was taken of the risk of disease, the sourcing of materials to build a colony and erect effective defensive fortifications, the cultivation and storage of crops, and the threat posed by rival claimants in the region, notably the Spanish, who had long regarded this stretch of the New World as their own. It wasn't even certain that they'd have uncontested access to fresh water.



After just eight months, the colony was so severely debilitated by malaria, dysentery and malnutrition that it was abandoned. Of the initial cohort of settlers, only 300 survived. Around this time a small flotilla arrived from Scotland to support and resupply the colony, only to find hundreds of graves and a wasteland of ruined huts.

Before news of the calamity reached Scotland a second expedition set off for Darien, this time with 1000 men. Shocked by what they found on arrival, they quickly began to rebuild the huts and barricades. However, shortly thereafter a contingent of Spanish troops arrived and laid siege to the settlement. The Scots held out for a month under dreadful conditions but were obliged to surrender. Only a handful who survived from this second expedition returned to Scotland.

## Scotland was bankrupt


When the full extent of the Darien disaster became generally known across Scotland, the population was crestfallen. They probably knew they had been deceived by their leaders but there was nothing they could do about it. With over twenty percent of their capital invested in the project, a great many suffered calamitous losses.

The kingdom was effectively bankrupt and left with no option but to enter into full political union with England in 1707, a few years after the Darien disaster. This would give the mercantile class what they had always wanted, namely access to the international trade routes which England had already secured and the protection of their ships by a major naval power.

The Darien 'disaster' enabled the ruling caste in both England and Scotland to press forward with their plan to create a world empire. One might even call it the Darien Method, where the independence of sovereign states is undermined or sabotaged by 'peaceful' means, usually involving the active co-operation of agents within the target state. In short, organized treason.

## Darien again

We got a curious reminder of this recently when an independent journalist, Michael Yon, revealed the existence of a UN-sponsored camp in Panama dedicated to facilitating the passage of economic migrants into the United States. The camp is one of several along a route which spans the Darien Gap. Migrants from countries such as Venezuela and Colombia make this perilous journey through inhospitable jungle terrain on their way to the US. Darien would normally pose an insuperable barrier to migration were it not for the existence of these UN-sponsored camps.



The unfortunate people who make this journey must pay the drug cartels \$400 for the privilege. The journey itself is fraught with risk, especially for women. Between 2010 and 2020 the average number per annum who made this 70-mile trek across Darien was around 12,000. Last year, however, about 250,000 made the crossing. Remember, all are heading for the United States and this is just one of several routes that economic migrants and their handlers are using for this purpose.

CNN carried a report on the Darien migration route on 16 April but portrayed it as a humanitarian disaster which necessitated the intervention of the UN. The blame lay with the drug cartels, they said. However, it is obvious that the route could not remain open or cater for such an enormous number of migrants without the UN-sponsored camps located along the way.



#### The 'Darien Method'

In reality, the US authorities in Washington, plus top government officials in each of the countries along the migratory path, are working together to enable this massive influx of migrants to continue. This is indeed the 'Darien Method', peacetime treason designed to undermine American sovereignty.

The link between Panama and high-level treason by US politicians goes back to Jimmy Carter. In 1977 he negotiated a treaty with the President of Panama to hand eventual control of the Panama Canal to the nation of Panama. This treaty was ratified by the US Senate in 1978. As an act of betrayal it must rank among the most egregious in recent history. The US incurred the entire cost of building the canal and made it available for international trade. The Panamanian input was zero. Carter and his top officials knew the Panamanians intended to hand control of the canal in due course to the Chinese, which is exactly what they did.

Today a major strategic asset, which could play a vital role in any future conflict between the US and China, is controlled by China! And the Chinese Communist Party didn't have to lift a finger to obtain this remarkable resource. The Americans simply gave it to them, courtesy of peacetime traitors within the US administration.

# Governments are betraying their own people

# More Christian leaders need to wake up

#### The International Commission of Jurists

An organization known as the International Commission of Jurists (ICJ), which was founded in 1952 and comprises sixty "eminent judges and lawyers from all regions of the world," published a report in March of this year titled: *The 8 March Principles for a Human Rights-Based Approach to Criminal Law Proscribing Conduct Associated with Sex, Reproduction, Drug Use, HIV, Homelessness and Poverty.* 



In order to grasp the significance of this report, we need to appreciate the standing which the ICJ enjoys on the world stage. While it purports to be independent, it is funded by a slew of organizations dedicated to the advancement of the *New World Order* agenda. These include:

Open Society Foundation (headed by George Soros)

**European Union** 

United Nations Development Programme (UNDP)

United Nations Democracy Fund (UNDEF)

International Development Research Centre (IDRC)

Swedish International Development Cooperation Agency (SIDA)

Swiss Federal Department of Foreign Affairs

Government of Canada

The ICJ is clearly not a fringe organization but an integral part of the apparatus being used to undermine national and international legislation which incorporates and upholds traditional values and replace it with a New World Order. Their report of March 2023 is intended to provide "principles" to address "the problem of the harmful human rights impact of criminal laws that proscribe conduct associated with sex, reproduction, HIV, drug use, homelessness and poverty."

## A charter for pedophiles

Here is Principle 11 of the 21 principles enunciated in the report:

# PRINCIPLE 11 - LIMITATIONS ON CRIMINAL LIABILITY FOR PERSONS UNDER 18 YEARS OF AGE

No one under the age of 18 may be held criminally liable for any conduct that does not constitute a criminal offence if committed by a person who is 18 or older.

At first glance this may seem logical, but it has far-reaching implications for teenagers. According to this Principle, since sexual activity between consenting adults is not illegal, it should not be considered illegal when practised by consenting teenagers, either with other consenting teenagers or with consenting adults.

Lest our readers think we are exaggerating the scope and purpose of Principle 11, we would draw attention to two other principles, 16 and 18, which show conclusively that the report envisages the elimination of what we ordinarily understand as the age of consent. The crime of statutory rape will be removed from the statute books. An adult who coerces a minor into sexual activity, or who forcibly rapes or sexually abuses a child, will be able to claim that the child consented:

"Moreover, sexual conduct involving persons below the domestically prescribed minimum age of consent to sex may be consensual in fact, if not in law. In this context, the enforcement of criminal law should reflect the rights and capacity of persons under 18 years of age to make decisions about engaging in consensual sexual conduct and their right to be heard in matters concerning them. Pursuant to their evolving capacities and progressive autonomy, persons under 18 years of age should participate in decisions affecting them, with due regard to their age, maturity and best interests, and with specific attention to non-discrimination guarantees." – excerpt from text of Principle 16.

"No one may be held criminally liable for consensual practices aiming to assist others with the exploration, free development and/or affirmation of sexual orientation or gender identity, unless there was force, coercion, fraud or medical negligence, or a lack of free and informed decision-making on the part of the person concerned."

- excerpt from text of Principle 18.

The report doesn't even try to set a lower age of consent for minors but recommends instead that a child of any age should be deemed to have consented (a) if the child indicates after the fact that he or she gave their consent and (b) if the child can be considered of sufficient maturity to give his or her consent.

## This report is Satanic
