

Evidence of a Famine Plan

The Word of God speaks of mass mortality in the End Time. Half the population of the entire earth will die from various causes over a period of three to four years. We can infer from Revelation 6:5-8 that a large proportion of these will be due to starvation or to fatal diseases caused by severe malnutrition:

“And when he had opened the third seal, I heard the third beast say, Come and see. And I beheld, and lo a black horse; and he that sat on him had a pair of balances in his hand. And I heard a voice in the midst of the four beasts say, **A measure of wheat for a penny, and three measures of barley for a penny; and see thou hurt not the oil and the wine... And I looked, and behold a pale horse: and his name that sat on him was Death, and Hell followed with him. And power was given unto them over the fourth part of the earth, to kill with sword, and **with hunger**, and with death, and with the beasts of the earth.”**

(Revelation 6:5-8)

Scripture actually describes death by hunger as a punishment greater than death by the sword:

“Behold, O LORD, and consider to whom thou hast done this. Shall the women eat their fruit, children of a span [handbreadth] long?”

(Lamentations 2:20)

“They that be slain with the sword are better than they that be slain with hunger: for these pine away, stricken through for want of the fruits of the field. The hands of the pitiful women have sodden their own children: they were their meat [food] in the destruction of the daughter of my people.” (Lamentations 4:9-10)

The Great Day of the LORD

What we often call the End Time is “**the great day of the LORD (Zephaniah 1:14)** or “**the day of his wrath (Psalm 110:5)**. It is not to be confused with “**the day of Christ (Philippians 1:10 and 2:16; 2 Thessalonians 2:2)**”:

**“For the great day of his wrath is come;
and who shall be able to stand?”
(Revelation 6:17)**

Christ will come for his Bride *before* the great day of the LORD. The Bible calls this the day of Christ. Only after she is removed from the earth will the wrath of God fall upon those who remain, who know not God and obey not the gospel of our Lord Jesus Christ:

**“And I will execute vengeance in anger and fury
upon the heathen, such as they have not heard.”
(Micah 5:15)**

**“In flaming fire taking vengeance on them that
know not God, and that obey not the gospel of
our Lord Jesus Christ” (2 Thessalonians 1:8)**

The awesome holiness of God demands that all sin be punished. He sent His Son to take this punishment on our behalf, provided we repented of our sin and placed our faith in him. Through his substitutionary atonement our debt has been paid in full and thus, as believers, we are spared “**the day of vengeance of our God (Isaiah 61:2)**”

If, as Christians, we don't understand His righteous judgment, then we won't understand His incredible mercy. Those who rebel against God reject the concept of sin and, as a consequence, have no understanding of justice or mercy. They imagine that God is being capricious or unfair when He holds men accountable for their actions. But our wonderful Creator says otherwise:

**“For he doth not afflict willingly
nor grieve the children of men.”
(Lamentations 3:33)**

Even though the seven years of the Tribulation will be a time of great suffering, a time when the LORD’s righteous anger is poured out upon the earth, He will remain ever watchful for those upon whom He may bestow His great mercy:

**“Seek ye the LORD, all ye meek of the earth, which
have wrought his judgment; seek righteousness,
seek meekness: it may be ye shall be hid in the day
of the LORD’S anger.” (Zephaniah 2:3)**

The suddenness of the coming collapse

The horrors of the Tribulation will commence as though from nowhere. The world will muddle along much as it has for generations, oblivious to the accumulating weight of its sins, until the fateful day arrives. The Word of God describes the build-up to this tumultuous moment as follows:

**“Therefore this iniquity shall be to you as a breach ready
to fall, swelling out in a high wall, whose breaking
cometh suddenly at an instant.” (Isaiah 30:13)**



Many already have a clear sense of this impending event and are preparing for it in material terms. While born-again Christians remain steadfast in Christ, the ones who appear to be making the most extensive preparations are those who have rejected Christ and the gospel of salvation. The Wicked know this is coming because their leaders have planned their ‘great reset’ for centuries. They expect to survive the return of Jesus and to emerge victorious from their hiding places. They have convinced themselves that the regiments of hell, with whom they are bound by an oath to Satan, will enable them to escape what the Bible calls “the overflowing scourge”:

**“Because ye have said, We have made a covenant with death,
and with hell are we at agreement; when the overflowing
scourge shall pass through, it shall not come unto us: for we
have made lies our refuge, and under falsehood have we hid
ourselves:” (Isaiah 28:15)**

The LORD says they are gravely mistaken, that their plans are fatally flawed and that they will be utterly destroyed:

“And your covenant with death shall be disannulled, and your agreement with hell shall not stand; when the overflowing scourge shall pass through, then ye shall be trodden down by it.” (Isaiah 28:18)

There is a certain irony in the way this will come about. For most of the Tribulation period of seven years, it will look as though the military might and cunning of the Antichrist will prevail and that his ultimate victory is assured. Blinded by the false light of Satan, his followers will have no inkling of the fate that awaits them when Jesus returns and wields the Sword of His Word:

“Moreover the multitude of thy strangers shall be like small dust, and the multitude of **the terrible ones shall be as chaff that passeth away: yea, it shall be at an instant suddenly.” (Isaiah 29:5)**

The Tribulation will end as suddenly as it began.

The “terrible ones” and their hiding places

Before we discuss the impact of the planned hunger program on the world population, we need to consider the steps that the Wicked – “the terrible ones” – have taken to protect themselves. There have been many reports on the Internet of billionaires preparing huge underground shelters for themselves and their families should a major conflict break out. They would seem to be concerned about the social unrest that such a conflict would engender rather than the threat posed by an invading army. And the greatest catalyst of severe social unrest is hunger.

The ultra-rich are preparing for the turmoil ahead. Most of them will take refuge in secure underground bunkers until the conflict has ended and the coming world ruler, the Masonic Messiah, is in control. By that time they expect their genocidal program to have killed off most of the civilian population of the world. According to the Georgia Guidestones, they are aiming for a final tally of just 500 million people – all of whom will be required to worship the Antichrist and take the mark of the beast.

The 'Elite' have also built an extensive network of subterranean tunnels and caverns, mostly under the guise of the military, capable of housing hundreds of thousands of their own kith and kin, plus those who serve them. According to reports, these are scattered across N America and Europe, and possibly elsewhere (in places such as Russia, Turkey and Iran). Modern tunneling technology can easily cut through rock and carve out the extensive underground space that the "terrible ones" need to construct their secret domiciles.

The Illuminati conducted a famous occult ritual in June 2016 at the opening of the Gotthard Tunnel in Switzerland, the longest and deepest in the world. Many high-profile politicians and world leaders were in attendance. The various elaborate rituals, which took place over a 5-hour period, are understood to have required over 600 actors. This was a celebration in honor of the demonic entities that "allowed" the 35 mile tunnel to be constructed. Given its remarkable length and range of occult references, the celebration may also have applied to all similar projects, notably the extensive subterranean networks built by the 'Elite'.

This complex ritual was consistent with the occult belief that Satan and his demons rule the underworld and man is forbidden to enter this exclusive domain unless he obtains permission. The Gotthard event was held in public to advertise, in brazen but symbolic terms, the agreement that the ‘Elite’ had made with Satan. In our opinion it was also intended to highlight ‘above ground’ – that is, in public view – the important role that the underworld and its tunnel system will play in their dark plan to enslave mankind.



The Word of God appears to be referring to these underground tunnels and bunkers when, in passages concerning the End Time, it speaks of caves and holes in the rocks where the enemies of Christ, frightened by his terrible power, try to hide themselves:

“And they shall go into **the holes of the rocks, and into **the caves of the earth**, for fear of the LORD, and for the glory of his majesty, when he ariseth to shake terribly the earth. In that day a man shall cast his idols of silver, and his idols of gold, which they made each one for himself to worship, to the moles and to the bats; to go into **the clefts of the rocks**, and into the tops of the ragged rocks, for fear of the LORD, and for the glory of his majesty, when he ariseth to shake terribly the earth.”**

(Isaiah 2:19-21)

“They [*the nations*] shall lick the dust like a serpent, **they shall move out of their holes like worms of the earth: they shall be afraid of the LORD our God, and shall fear because of thee.”**

(Micah 7:17)

When Christ returns there will be no place to hide. Referring again to their subterranean places of refuge, the Word of God says:

“And the kings of the earth, and the great men, and the rich men, and the chief captains, and the mighty men, and every bondman, and every free man, **hid themselves in the dens and in the rocks of the mountains**; And said to the mountains and rocks, **Fall on us, and hide us from the face of him that sitteth on the throne, and from the wrath of the Lamb**: For the great day of his wrath is come; and who shall be able to stand?” (Revelation 6:15-17)

Do the Wicked understand any of this? Have they been so blinded by Satan that they cannot see what’s coming? Many of them have studied the Bible in great depth with a view to discerning the LORD’s End Time strategy and finding a way to defy it. It is incredible to think that He has set out His plan well in advance and revealed countless details about events that must come to pass – having been declared by Him to transpire just as He described – and yet Satan and his coterie of brilliant demonic minds will be unable to thwart His holy will in any respect.

The takeover plan is very detailed

The ‘Elite’ have planned the enslavement of mankind in great detail. Along the way they have recruited the most highly intelligent and talented graduates to develop aspects of their grand plan and devise ways to make the various pieces fit neatly together. This partly explains why the public is so depressingly unaware of what’s happening right under their noses, that there exists a worldwide plan to impose a totalitarian system of governance on all nations, that the system will be enabled by advanced computer technology, and that, after centuries of preparation, the final phase has been set in motion.

We cannot possibly explore all aspects of the plan in a paper like this, but we *can* pick one of its main components and provide hard evidence that their sinister agenda has been progressing in plain view for many decades. As already mentioned, the component we have chosen is food control and its eventual use in weaponized form to create mass starvation.




Agenda 21 – published 23 April 1992 (350 pages). Held in Rio de Janeiro, in June 1992, the so-called 'Earth Summit' was attended by the heads of 178 nations, all of whom signed the agreement. The '21' refers to the 21st century, while the 'Agenda' itself is a detailed action plan to transfer complete control of all of the earth's resources, including agriculture and food production, to a central governing authority. All the goals of Marxism are embodied in this wicked document. Had Satan himself been given a proof copy for his editorial approval, he wouldn't have changed a word.

The Hunger Games

Books that achieve a high ranking on the bookseller list often do so, not necessarily on their merits, but because they contribute to the Illuminati mind control program. The 'Elite' are especially interested in brainwashing today's youth and shaping the outlook of the next generation. The *Harry Potter* series – books and movies – were an incredibly successful tool for this purpose, introducing tens of millions of teens to witchcraft and inducing them to believe that 'good magic' is morally acceptable and even necessary in the struggle against evil. As a result very few of our younger generation understand that magic in *all* its forms is steeped in evil and that the occult is Satan's domain.

The only series – books and movies – to rival the *Harry Potter* franchise in this respect was *The Hunger Games*. It too was incredibly successful, selling over 100 million copies worldwide in book form and yielding several movie adaptations which attracted a huge following and won numerous awards. The series depicted a dystopian future for America, where the masses were close to starvation and the ruling elite were unusually cruel. By identifying emotionally with its lead characters, the teen fanbase was absorbing its dystopian imagery and accepting, if only subconsciously, the dark reality in which their heroes struggled to survive.

This process is sometimes called predictive programming, where the audience is trained to identify mentally or emotionally with a future scenario, thereby weakening their ability to oppose it.

<p>Agenda 21 mentions food 111 times and lists all the ways food and food production will be centrally managed: <i>food security, food self-sufficiency, food storage, food supply and demand, food safety, food contamination, food quality control, food production, food deficiencies, food transport and distribution, food availability, food losses, food chain, food requirements, and food scarcity.</i> The term 'food security' occurs no fewer than 22 times in the report.</p> <p>Now ask yourself, will all of these rules and regulations increase the supply of food or reduce it?</p>

A largely unspoken theme running through the movie was food. Teens from each region around the country were commissioned to fight to the death in an arena for the entertainment of the ruling elite. Those who survived won an additional supply of food for their own region. By arranging these 'hunger games' the ruling elite were conditioning the masses to accept their slavery. After all, if a region's candidate did not succeed this year, then maybe next year's candidate would emerge a winner – and obtain additional food for everyone in the region.

Here are some recent historical examples of the way dictators and tyrants have used famine and starvation for political purposes. The first two were cited in our earlier paper on the hoax known as global warming [#208]:

The Ukraine - *Holodomor*

As part of his program to contain the upsurge in Ukrainian nationalism, Stalin ordered his henchmen to go from village to village and commandeer all available food supplies. They confiscated the grain harvest, the seeds needed to plant the following year's crop, and all stocks of flour, tinned food, potatoes, beets and so forth. They left nothing. Huge parts of rural Ukraine were subjected to this atrocity, causing the deaths by starvation of at least 4 million men, women and children.

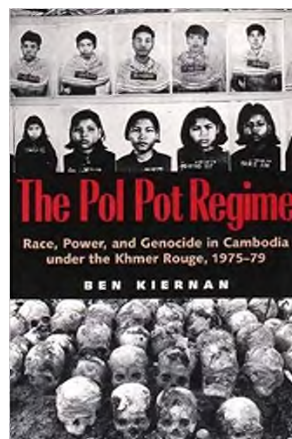


This crime was so abhorrent that even Stalin's enemies could not believe he was capable of carrying it out. It went far beyond the common understanding of what wicked men can do – and continue to do. Not until the 1990s or thereabouts, when the mass of documentation and first-hand accounts of all that had transpired in that troubled nation became generally available, did historians finally concede that it had actually happened – a manmade famine intended to kill millions of innocent people, all hidden behind a blanket of disinformation, propaganda and lies. The world had been led to believe that the loss of life was very much lower than it actually was and that bad weather had destroyed the harvest.

Journalists in the west, who were working for Moscow, filed reports which glossed over the tragedy and even suggested that anti-Russian sources had concocted these 'malicious stories' to discredit Stalin and his regime.

Cambodia

Pol Pot did something similar in Cambodia. When his communist thugs took control of Phnom Penh they forced the population to evacuate en masse to a remote jungle settlement. The hapless throng were told that all food and other necessities would be provided at this utopian compound. Meanwhile their homes were ransacked and anything of value confiscated by the regime. Over the course of a year or so huge numbers died of starvation, and anyone who tried to forage for food in the jungle was shot. This was deemed a betrayal of the Communist ideal since it implied that those who did so had lost confidence in the regime.



It is estimated that at least 1½ million died under Pol Pot in the period 1975-1979, mostly from starvation and diseases caused by malnutrition. This figure represented about 20% of the total population of Cambodia.

The Irish Famine, 1845-47

Even today, about 180 years after this awful event, the Irish are not keen to discuss what they call The Great Hunger. Our ancestors were starved to death by the British. At least a million people died of starvation – one person in eight – and nearly two million were forced to emigrate. The suffering endured by those who managed to survive can only be imagined. No other European nation in the 19th century suffered a catastrophe of this magnitude. And yet, in the main, it was avoidable. The bulk of the population were barely maintaining a subsistence existence when the potato blight struck. The crop failure had a devastating impact on impoverished families but the British elite, who ruled Ireland, did virtually nothing to help.

Worse still, they continued to export Irish cereals and other agricultural products for commercial gain. They owned most of the productive land – having stolen it a few generations earlier – and were determined to profit thereby. The attitude prevailing in Westminster was well expressed by Sir Charles Wood, Chancellor of the Exchequer, when he said the famine was “a calamity sent by Providence” and a “wonderful impetus” for social change. They regarded the population of Ireland as excessive and saw the famine as a useful means of reducing it to a more manageable level.

Bengal, 1943

The British took the same genocidal approach during the Second World War when famine struck the state of Bengal in India, which was then under British rule. Rather than allow the Indians to retain the cash crops grown by British colonists, they continued to export grain to England. Many historians believe the mass starvation that ensued resulted in the slow and painful demise of about three million Bengalis.

The Great Chinese Famine, 1959-1961

Possibly the most horrifying manmade famine in history took place in and around the province of Sichuan in southwestern China in 1959-1961. While historians have difficulty getting reliable data, it is generally agreed that about 30 million people died. The famine was the direct result of absurd economic reforms and restrictive agricultural policies imposed by Chairman Mao and his gang of Marxist psychopaths. For several years the Chinese government tried to maintain that the death toll was due in part to natural disasters, but following the Great Opening Up of 1981 they admitted that the famine was almost entirely manmade.

This catastrophe takes only a few sentences to record, but the underlying horror, in terms of human suffering, is almost impossible to comprehend. It is easy to overlook also the incredible fact that just 10-15 senior political leaders made the insane decisions that resulted in the appalling deaths of some 30 million people in only three years.



History shows that tyrants have always used starvation, or the threat of starvation, to maintain control over an oppressed people. When the Nazis imprisoned large numbers of Russian soldiers during World War 2 they let two-thirds of them starve to death. Again, reliable figures are not easy to obtain, but some historians put the total at around 2 million. The Nazis also subjected many of their civilian captives to forced labor, deliberately keeping their daily ration of food to 600 calories. This was designed to extract 3 months of hard labor from them before they died of malnutrition. The total number who succumbed in this way is uncertain but most historians put the figure at over a million. Stalin did much the same with those who were sent to the Gulag. During the time he ruled the Soviet Union it is estimated that over a million prisoners died of starvation in the Gulag system.

Another tyrant, General Franco, used the threat of malnutrition during the first decade of his dictatorship to oppress the Spanish people. This period, 1939-1949, is known in Spain as the Years of Hunger. In addition to incarcerating and executing hundreds of thousands of political prisoners, Franco used interventionist policies to manipulate the availability of food and keep the masses on the brink of starvation.

In an age of plenty...

Today, in an age of plenty, we have forgotten that famine is a weapon. Those who control the food supply, or who have the legal or administrative powers to restrict supply, possess a tool which, should they so choose, could be used to coerce or blackmail a population. The Bible warns that people will be unable to buy or sell unless they have the mark of the beast. This “mark” will enable them to purchase goods, and the product that EVERYONE will want to buy, without exception, is food. No mark, no food. The system is therefore a means of creating a worldwide famine.



We hope our readers will appreciate the significance of this. The Word of God is warning us in very stark terms that the Wicked intend to use the threat of starvation as a way of imposing their New World Order.

We see clear evidence of their intentions from steps they have **already** taken to gain greater control over the world's food supply. We could deal with each of these in detail but there is no need to. It is only necessary to identify the strategic approach they are taking to monopolize the food supply, suppress independent production, restrict the availability of resources, and substitute nutritionally deficient or even harmful alternatives.

We are not engaging in speculation. All of the information we cite can be found online and verified by mainstream news sources. No doubt the Cabal are engaging in many other illicit activities to extend their control over the food supply but we will confine ourselves to what is already in plain view.

1. Farmland ownership restrictions

It is well known that farmers are being put under pressure in many countries, notably the Netherlands, to sell their land. Various methods are being used to make farming unduly onerous or unprofitable. The UK is using a new inheritance tax to drive farmers off the land. Large farms that have been owned by the same family for generations are being hit with huge taxes which prohibit their transfer to the next generation. This has the effect of not only reducing the amount of arable land available for food production but also reducing access to farming by those who have the skills and motivation to get the best results.

It is well known that the Chinese have been buying up large tracts of agricultural land in America, while Bill Gates, following extensive purchases, is now believed to be the largest private owner of agricultural land in the US. Unduly onerous state and federal reporting regulations, which require reams of paperwork to be completed every month, is eating into the time available to farmers to maintain profitability. Environmental restrictions and water-use regulations are adding to these woes.

2. Biosludge and Biosolids

Following treatment, human sewage is rendered into a form known as biosludge. If the biosludge meets certain environmental standards, it can be reclassified as a “biosolid” and applied to agricultural land in place of fertilizer. About 60% of the sewage sludge produced by treatment facilities in the US in 2019 was spread on farmland and gardens.

In our earlier paper [#316] we examined the practise, now endemic in the US, of spreading biosludge on agricultural land, even though it is laden with pollutants and hazardous substances, notably PFAS, which will remain in the soil for decades. An outside agency commissioned by the Office of the Inspector General to audit the EPA (Environmental Protection Agency) concluded that the EPA was not fit for purpose; that it was deliberately deceiving the public regarding the safety of biosludge; that the method that it used to test the toxicity of biosludge was grossly inadequate; and that it did not propose to take any meaningful steps to redress these serious inadequacies.

We reproduce in **Appendix A** attached the full text of the section of paper #316 which dealt with the biosludge issue.



The addition of toxic material to agricultural soil would be rated a criminal offense by most people. However, the American people are not properly informed. The damning OIG report was glossed over and no serious consideration was given to its findings in the mainstream media.

Of the many despicable aspects of the Illuminati plan to take control of food production, this may be the most outrageous. It achieves two goals of lamentable depravity, firstly by channeling hazardous pollutants into the food chain and secondly by corrupting the soil and making it possible for the government to shut down polluted farms at some time in the future. This could be achieved by the simple expedient of raising testing standards and deeming the land in question unsuitable for further use.

Only Satanists, who delight in poisoning the righteous, could devise such a plan.

**“The wicked watcheth the righteous, and seeketh to slay him.”
– Psalm 37:32**

3. GMOs

The Cabal like to give the impression that they possess great technological prowess. This promotes the lie that ‘Science’ will solve all human problems. It also allows them to coat with a veneer of scientific legitimacy bogus solutions to bogus problems. They get away with this because the average person has only a poor grasp of scientific principles and little or no appreciation of the rigor needed to prove that they apply in a given situation.

The strange world of bioengineering is awash with inflated claims. Major breakthroughs appear to be announced every week and yet we see no results. Cancer has been ‘conquered’ dozens of times, but the so-called cure is still not available. The ‘Elite’ like to boast about these spectacular advances, possibly because they might someday include a new ‘vaccine’ that combats a deadly new ‘disease’ – when both the disease and the vaccine are bogus.



Whether or not genetically modified organisms (GMOs) actually exist is an open question. While we will not pursue this line of enquiry, we can be sure that genetically damaged organisms *do* exist, whether the damage arises through radiation or mutation. If one of these organisms, such as a strain of wheat, can be marketed as a genuine GMO, then it can pass unchallenged into the food supply – having been approved by the FDA. Using this technique it would be possible to replace part, possibly a large part, of the traditional food supply with nutritionally deficient substitutes.



Regardless of how they are produced, GMOs are defective. They are corrupted versions of the food varieties created for us by God. The 'Elite' have been pushing them for years, trying to convince us that their version is better. Fortunately most consumers have been reticent to date, but as bottlenecks arise in the food supply, an increasing number will likely accept a GMO alternative.

Since GMO grain has been genetically damaged, it is generally sterile. This means next year's seed must be supplied by the company which developed the GMO (Where the company obtains its own supply is unclear). Farmers are therefore reliant on the company to provide the seed and to do so at an affordable price. As farmers in India discovered some years ago, this arrangement can rapidly turn sour, with the company extracting huge profits from the thousands of farmers who fell into their net.

In short, GMOs result in food of low nutritional value which may also be harmful to our health. They also concentrate control over food production in the hands of a tiny minority.

4. Concentration of ownership in the food industry

The following section is drawn from our earlier paper #316.

All food producers rely on an efficient distribution system to take their products to the consumer. The number of companies operating in this business has been steadily contracting, to the point where today just a few corporations control nearly 80 percent of the market for common grocery items consumed in the US.

The consumer is under the illusion that he has a wide variety of brands to choose from, when in reality most of the products are brought to market by just a few mega-corporations. Many ‘competing’ brands are made by the same company. These corporations dominate every link in the food supply chain, from the sale of seeds and fertilizers, to food processing plants and meat factories, to food storage and transport, to the nationwide supermarket chains which bring the food to the consumer.

Where food products are concerned the farmers and growers are tied to the price offered for commodities by the big corporations. Since the corporations control the pricing they are able, by working together, to drive a sizeable number of producers into bankruptcy by suddenly dropping the price. This is pushing more and more medium-sized farmers out of business and enabling predatory corporations to buy up large chunks of agricultural land at very attractive prices. This oppressive technique has been used extensively in recent decades to pass more and more control of American food production into the hands of just a few large corporations.

We often refer to Big Pharma and Big Tech, but we probably under-estimate the immense power exercised by Big Food. Just a handful of food giants own and control most of the market in the groceries we buy – Kraft Heinz, General Mills, Conagra, Unilever, Delmonte, Kellogg, Nestlé, Danone, P&G, Pepsico, Mars, and Post Holdings. The processing and marketing of grains is substantially controlled by just three companies – Cargill, ADM, and Continental Grain. Up to about 1990 or so, many Americans bought their groceries at a local store, but today two-thirds of the retail market is controlled by just four supermarket giants – Walmart, Costco, Kroger, and Ahold Delhaize.

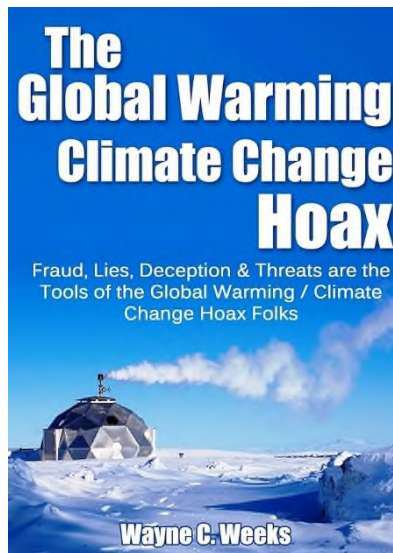


Mergers in the meatpacking industry in recent years mean that just a few corporations now control most of the meat production and pricing in America. These include Tyson, JBS, Cargill and Smithfield.

The control which these corporations exercise over pricing is so great that farmers are now paid less for their meat than thirty years ago. Most stay in business by relying on government subsidies. The biggest subsidies are paid for corn production, but most of the corn grown in the US is used as animal feed. This means the taxpayer is paying twice for the meat he consumes, with all profits going to the mega-corporations.

5. Environmental regulations and restrictions

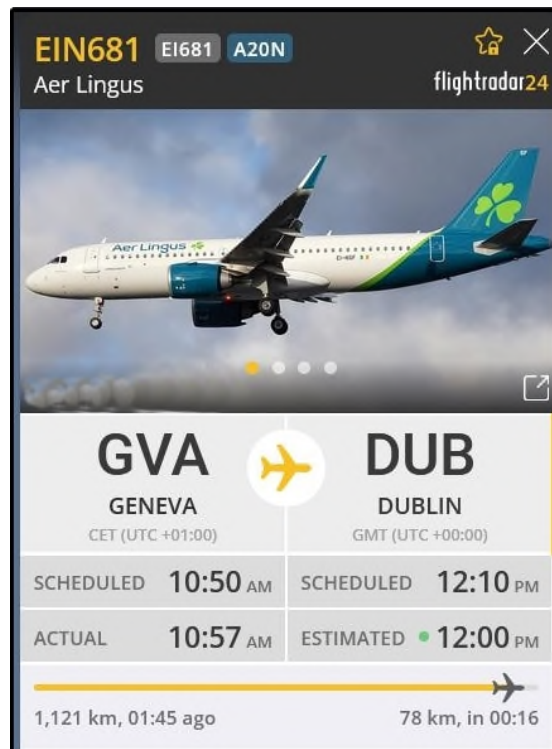
The more rules the government makes, the harder it is for farmers to maintain output and turn a profit. The biggest scams are centered around the hoax known as global warming and the nonsensical targets set by the government to reduce what they like to call 'greenhouse gases'. Farming just happens to be an activity that produces large quantities of these benign natural gases, notably carbon dioxide and methane. As more of these restrictive regulations are imposed, farming output is bound to fall. Stated simply, the global warming scam is designed to reduce the food supply!



Other environmental regulations, such as those intended to 'protect' allegedly rare or endangered varieties of flora and fauna, are being used to withdraw prime agricultural land from production. The 'wilding' program itself, where large tracts of commercially viable land are rezoned exclusively as nature reserves or wildlife sanctuaries, is designed to force more people to live in cities and to prohibit use of the land for food production.

6. Chemtrails

It is difficult to believe that, after more than forty years of chemtrail spraying, the majority of the population are still unable to see that our skies are being polluted with aerosols. All aircraft are meant to have transponders which broadcast their location continuously. These signals are then plotted in real time and made accessible to the airline industry 24/7. The public too can check the identity of a plane flying overhead by going to a website, such as flightradar24.com which carries this data. For example, as I type this paragraph a plane is approaching Dublin airport along the east coast flight corridor. It is about 20 miles east of my home. The website gives the following information – in real time – about this flight:



The planes that are spraying our skies are not tracked by this system. So if one or two of them are flying overhead – they often come in pairs – you should be able to check the website and see if they appear. If not, and if they are emitting a continuous stream of white ‘vapor’, then they are part of the clandestine chemtrail program.

What do these aerosols contain? We cannot answer this question with any certainty, but scientists who have analyzed samples which were obtained from rain that fell from a heavily chem-trailed sky found traces of strontium, barium and aluminum. The ongoing accumulation of these and other toxins is certain to have an adverse effect on the soil over time and to make its way into our food supply.

7. Livestock diseases and vaccines

As we have already noted, there is no need to ‘create’ a new disease through gene editing or by other means. The ‘Elite’ only need to create the illusion that a new disease has emerged. The great advantage with an illusory disease is that it cannot be eradicated (just like ‘Covid’). It can also have numerous variants and can be made as virulent or infectious as required. It can even cross the species barrier and threaten other animals or even humans. The presence of this imaginary pathogen is easy to prove using the right equipment, namely a device which registers positive whenever a positive response is required. The only loose end is the need for symptoms of some kind. The Elite got around this during ‘Covid’ by pretending that their new disease was contagious even in the absence of any symptoms in the allegedly infected carrier.

The latest new disease is bird flu which, it would seem, is destined to impact heavily on the food supply. If just one hen or turkey among ten thousand is poorly, the state authorities can claim the creature is suffering from 'bird flu' and the entire stock must be slaughtered. The same could apply to a large beef herd or pigmeat farm. The scope for tyrannical abuse of this kind is extraordinary. Stalin sent his henchmen to take livestock and stored food from the Ukraine in 1931. Their modern counterparts may resort instead to a callous 'bird flu' deception to achieve the same end in farms across America and Europe.

Farmers will naturally be alarmed if a large number of their birds, say 1,000 out of 200,000, die for no obvious reason. However, they have already been conditioned to blame a new disease called 'bird flu.' It may never cross their minds that the covert contamination of feed or the presence of a toxic aerosol could produce the same result.

How many people will realize what is happening before it goes too far? Who can say? The vast majority of rational, intelligent people have an abysmal record when it comes to detecting government deception and nefarious schemes by big corporations.

8. Weather weapons

A key to understanding weather weapons may be found in most homes today – the microwave oven. It is a simple, inexpensive device which converts household electricity into high-energy electromagnetic waves about 10cms long. These microwaves are extremely harmful, which is why the entire device must be shielded.

Imagine if these devices were scaled up by a factor of 100, say, and a few hundred were erected in a remote location. Provided a suitable electrical source was available (as with HAARP – see below), such an array could literally super-heat the sky. The upper canopy of the atmosphere would expand and then contract, sending air at high pressure into regions of low pressure. Since this is the fundamental dynamic behind changing weather patterns, the array can be used to alter the weather.

Such weather-altering technology has been used since the 1950s. Over the following years additional features were added, such as sonar waves and laser beams, to provide greater accuracy and flexibility. The effect can be amplified by adding nanoscale metallic particles to the atmosphere, a process known as “cloud seeding”. A network of such arrays, if distributed across a continent, could “push” polar fronts into temperate regions and create unprecedented snow storms, or concentrate atmospheric moisture over a large area into a smaller region, causing the latter to experience torrential flooding.

This technology is now being used covertly to produce extreme weather conditions in various parts of the world, including hurricanes of high intensity. They are then attributed to ‘global warming’ and used to bolster ‘greenhouse gas’ propaganda.

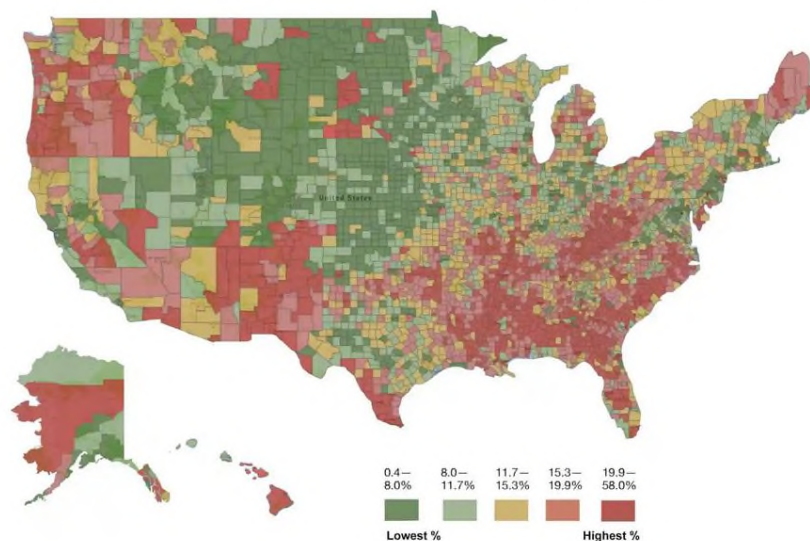
There is every reason to believe these weapons have also been used to spoil crop harvests and may be so used in the years ahead in a more systematic way. As a means of drastically reducing the global food supply, they are exceptionally effective.

9. Computerization will enable new forms of destruction

Advanced computer systems are exceptionally useful in many areas of food production and distribution. The Dutch have greatly increased their yield of certain vegetables by irrigating crops automatically under canopies, regulating the concentration of carbon dioxide, and precisely timing their exposure to light of different wavelengths. None of this would have been possible without computerization. The transport of perishable goods over long distances is also highly dependent on reliable stock management software. This greatly reduces the level of spoilage and avoids bottlenecks and delays.

The main food distribution centers across America and Europe are the giant supermarket chains. Without computers to manage the flow of inventory, order stock and schedule deliveries, the cost of food would increase, possibly significantly, while the supply and variety of products would fall.

The largest system in the world for the facilitation of food supply is the US SNAP system (SNAP stands for Supplementary Nutrition Assistance Program), formerly known as the Food Stamp Program. About 42 million Americans depend on SNAP. Originally they received paper coupons which could be exchanged for food at local stores. A few years ago this was phased out and replaced by an electronic benefit system, where recipients pay stores with a SNAP debit card.

Now consider the impact of a major cyber attack on the SNAP system. If 42 million people are left to survive on a meagre diet for 8-10 days, especially in urban areas where most of one's neighbors are in the same situation, riots and arson could be expected to flare up everywhere. Enraged citizens would break into stores in search of food, while others would take advantage of the situation to indulge in looting. Civil unrest could escalate rapidly and leave large urban areas in ruins.



Cyber attacks on supermarket chains and road haulage companies would probably be less disruptive but, on the other hand, they would affect the whole population.

Recent advances in AI will greatly increase the potency of cyber attacks, enabling trojans and other malware to continue to propagate after the initial assault has been repulsed.

In short, we are living in a world where food security has been sacrificed to expediency, thereby creating a new class of disruptive opportunities and giving the 'Elite' a surprisingly simple way of destabilizing society.

10. Other factors

There are so many aspects to the war on food that we simply cannot address all of them in a short paper. If we had time we could say a great deal more about such factors as the role of pesticides and EMR in the poisoning of pollinators, the inflated cost of fertilizers, arson attacks on food-processing facilities (which have grown considerably in recent years), the war on meat (see our paper #202), the impact of power interruptions on food storage, and the fantastic world of food substitution.

The latter – food substitution – is so bizarre that only the most obstinate observers could fail to see that it has a sinister purpose. For example, on 25 January 2025, the EU Commission passed a regulation stating that, in their “scientific opinion”, UV-treated powder of whole mealworm larvae (*Tenebrio molitor*) may be safely added to bread, cakes, pasta-based products, processed potato products, cheese and cheese products, and fruit/vegetable compotes intended for the general population. The regulation did not specify the maximum quantity allowed. This means it is left to manufacturers to determine the amount they will add to their products (such as bread etc), provided they comply with the safety conditions in the regulation. Furthermore, the regulation states that, for the next 5 years, only one company – Nutri-Earth – is authorised to make this powder.

The exoskeleton of mealworms is composed in part of chitin. This fiber is commonly found only in insects and crustaceans. Since chitin is neither readily absorbed nor metabolized by the human body, its inclusion in the food supply, especially in the West, ought to be a matter of real concern.

Biosludge

We now arrive at a subject which beggars belief. If the facts of the matter were not spelt out clearly in official documentation many of our readers could justifiably claim that we had exaggerated the extent of the problem. Alas, the practise we are about to describe is widespread in both N America and parts of Europe, and possibly in other countries as well.

It can be summarized as follows:

Following treatment, human sewage is rendered into a form known as biosludge. If the biosludge meets certain environmental standards, it can be reclassified as a “biosolid” and applied to agricultural land in place of fertilizer. About 60% of the sewage sludge produced by treatment facilities in the US in 2019 was spread on farmland and gardens. Farmers are being told by the EPA (Environmental Protection Agency) that biosolids may be safely applied to the soil, even though they are known to contain more than sixty contaminants which other government agencies have classified as “hazardous” or a “priority pollutant”. The EPA does not test for the presence of these substances but checks only for the presence of nine metals (arsenic, cadmium, copper, lead, mercury, molybdenum, nickel, selenium, and zinc). The procedures used to test for these metals are known to be inadequate and the EPA is unable to guarantee that heavy metals are not present in some of the biosolids approved for agricultural use. Biosolids have been applied to the soil by farmers across America for over twenty years. Should the government decide to test agricultural land to see whether the soil is safe for producing human food products, it could well find that many farms fail to meet the minimum standard. If so, they would have to cease operating. If the government decided to raise the testing standard – on the advice of ‘experts’ working for the New World Order – the number of farms disbarred from further production could be dangerously high. The impact on food supply would be catastrophic.

Many professionals in the field of biochemistry, food production, and agricultural science have been warning of the possible risks associated with the widespread use of biosolids, but their concerns have been repeatedly ignored. Some have called for the practise to be discontinued with immediate effect.

Under the heading, ‘Assessing Pollutants Found in Biosolids’, the EPA states:

Assessing the potential risk of pollutants found in biosolids is the top priority of EPA's Biosolids Program. EPA identifies pollutants found in biosolids through open literature reviews and sewage sludge surveys in order to assess their potential risk to public health and the environment. More than 700 pollutants have been found to occur in biosolids (in at least one instance) since EPA began tracking their occurrence in 1993... Not all of the approximately 700 pollutants that have been found in biosolids will be present in every wastewater treatment facility. Pollutants found in biosolids will vary depending upon inputs to individual wastewater treatment facilities over time. The presence of a pollutant in biosolids alone does not mean that the biosolids pose harm to human health and the environment.

Even by their own admission, the EPA has little information about the pollutants in biosolids or the adverse health effects that they may be producing. The stark absence of any reference to a rigorous testing procedure – or indeed to ANY testing procedure – is very troubling.

It is with good reason that a spokesperson for the Sierra Club [an environmental awareness organization] has called biosolids “the most pollutant-rich manmade substance on earth.” Before it was approved for use on agricultural land in the 1990s, sewage sludge had to be disposed of securely, either by incineration or by dumping it at sea. Since these two options gave rise to safety and environmental concerns, it was decided to spread it on farmland instead!

Dangerous “forever chemicals” known as PFAS

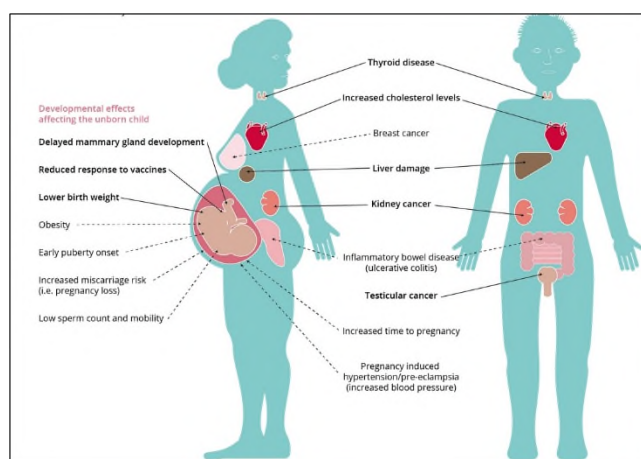
Among the most dangerous chemicals found in biosolids are PFAS or polyfluoroalkylated substances. These are manmade chemicals consisting of multiple fluorine atoms attached to a chain of carbon atoms. PFAS are widely used in industrial processes and over 4,700 different types are known to exist. The properties which make them suitable for industrial use – water resistance, oil resistance, and chemical stability – are the same properties which allow them to persist for years in the soil. For this reason they are sometimes called “forever chemicals.” Some PFAS have been linked to cancer, hormonal disruption, and diminished immune response.

The Irish EPA [which has no connection to the US EPA] states:

“Human and environmental exposure to PFAS can arise from contaminated water and food, PFAS-containing consumer products, household dust and air as well as the reuse of PFAS contaminated sewage sludge as fertiliser resulting in PFAS pollution in soil and crops.”

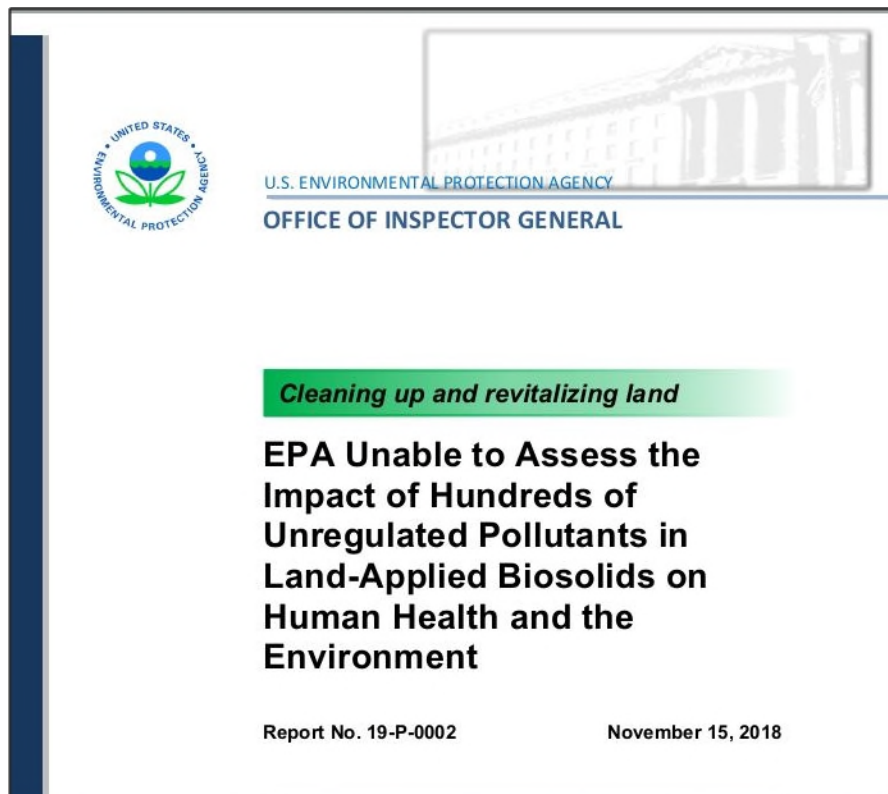


Organs affected by PFAS.

Scathing report by the Office of the Inspector General

The activities of all federal agencies in the US are audited by the Office of the Inspector General (OIG). The purpose of the audit is to identify inefficient or unlawful activities. The officials who carry out the audit have no connection to the agency and are essentially independent, both as regards the methods they use to conduct the audit and the findings they release for public consideration.

The OIG carried out an in-depth inspection of the EPA in 2018 and published their findings and conclusions in a scathing report. These are very plainly expressed but suffer, as expected, from bureaucratic understatement. Every patriotic American should read these extraordinary findings and ask themselves how an organization like this – a federal agency mandated to protect their nation from environmental pollutants and poisons – has been allowed to mislead and deceive the public in the most brazen fashion for the past twenty years. We will summarize the OIG findings later but we strongly recommend that readers go through the actual text since it clearly shows the commission of ‘high crimes and misdemeanors’ by hundreds of top officials in every Administration from the Clinton presidency to the present day:

OIG Report: selected extracts

“The controls over the land application of sewage sludge (biosolids), including laws, regulations, guidance, policies or activities, were incomplete or had weaknesses and may not fully protect human health and the environment. The EPA consistently monitored biosolids for nine regulated pollutants. However, the agency lacked the data or risk assessment tools needed to make a determination on the safety of 352 pollutants found in biosolids. The EPA identified these pollutants in a variety of studies from 1989 through 2015. Our analysis determined that the 352 pollutants include 61 designated as acutely hazardous, hazardous or priority pollutants in other programs.”

“However, the EPA has chosen to reduce staff and resources in the biosolids program over time, creating barriers to addressing control weaknesses identified in the program. Past reviews showed that the EPA needed more information to fully examine the health effects and ecological impacts of land-applied biosolids. In these cases where more information is needed but does not exist, the related law and regulations are silent on whether the EPA is required to obtain additional data to complete biosolids risk assessments. Without such data, the agency cannot determine whether biosolids pollutants with incomplete risk assessments are safe. The EPA’s website, public documents and biosolids labels do not explain the full spectrum of pollutants in biosolids and the uncertainty regarding their safety.”

“Control weaknesses in the EPA’s implementation of laws, regulations, guidance, policies or activities related to the EPA’s biosolids program pose a risk to the agency’s mission to protect human health and the environment from risks related to the land application of biosolids. The EPA has chosen to deprioritize the biosolids program and staff over time, creating barriers to its ability to address control weaknesses.”

“Existing biosolids data and studies do not fully examine the pollutants found in biosolids, especially unregulated pollutants. Until such research and data exist, the EPA cannot determine if any regulations should be issued. In over 20 years, no new pollutants have been regulated... The EPA does not have complete risk assessment information on these pollutants; therefore the agency cannot say, whether the pollutants are safe or unsafe when found in biosolids... The EPA’s most recent list of pollutants found in biosolids with incomplete risk assessments included 352 pollutants. When present in biosolids material, it is not well established if or how these pollutants are harmful to humans or the environment, or at what level they are harmful.”

“The EPA lacks data on human health and ecological toxicity values (e.g., studies that are adequate for evaluating hazards following acute or chronic exposure to pollutants) as well as other parameters to complete these risk assessments. In the EPA’s 2015 biennial review of biosolids (the most currently published review), it stated in the summary that the available data for many of the pollutants identified were not sufficient at that time to evaluate risk using then-current biosolids modeling tools... The need for additional biosolids research has been raised by many groups and individuals, including a review by the National Academy of Sciences...”

“On its website, the EPA does not disclose that because it cannot assess the safety of the 352 pollutants found in biosolids, it cannot inform the public as to whether the biosolids are safe... In the face of data gaps, a lack of risk assessment tools, and uncertainty regarding the safety of biosolids, the EPA is not providing clear and complete information to the public. Concerned citizens are questioning the safety of biosolids, particularly for agricultural land, and some municipalities voted on local ordinances restricting biosolids altogether. The EPA’s webpage on biosolids has a section on frequently asked questions about biosolids that includes the question “Are biosolids safe?” EPA scientists currently working on biosolids cannot definitively say whether the pollutants in biosolids are safe without completing the full risk-assessment process on all identified pollutants. However, this constraint is not disclosed on the EPA’s public website.”

“More recently, USGS scientists and other researchers identified organic chemicals in biosolids. They also found that biosolids contained relatively high concentrations of the active ingredients commonly found in pharmaceuticals as well as other emerging chemicals. A prior OIG report... found that sewage treatment plants may not be adequately testing for or treating wastewater entering their facilities and are at risk of discharging hazardous chemicals. The EPA is aware of this information and that harmful unregulated pollutants could end up in biosolids...”

“Despite the data and control weaknesses, the EPA implies that, when used correctly, biosolids are safe. The EPA does not disclose the shortcomings of information used to assess safety, nor does it reveal that potentially harmful and unregulated pollutants are present in biosolids such as pharmaceuticals, steroids and flame retardants.”

If we summarize these findings and state them in plain language, the OIG report is telling us that:

- The EPA is not fit for purpose;
- The public is being deliberately deceived;
- Agricultural soil across America is being systematically polluted;
- The pollutants accumulate in the soil and enter the food chain;
- The EPA’s testing methodology is grossly inadequate;
- Numerous requests to redress these deficiencies were ignored;
- Biosolids are allegedly tested for nine metal contaminants but the EPA conducts no systematic examination of the adequacy of these tests;
- The EPA does not know how long these pollutants remain in the soil, how quickly they enter the food chain, or what health problems they cause;
- The EPA has not given any commitment to improve its testing procedures or to fill in its extensive data gap. Instead it has reduced the number of staff who are assigned to this work.

How did the EPA respond to the OIG Report? Were their top executives shaken to the core? Not at all! As the following excerpt from their response shows, they simply treated it as no more than a slap on the wrist:

“It can be challenging to communicate information about risks to human health and the environment. Risk assessment is a scientific process that, according to longstanding EPA policies, considers three primary factors: (1) how much of a chemical is present in an environmental medium (e.g., biosolids); (2) how much contact a person or ecological receptor has with the contaminated environmental medium; and (3) the inherent toxicity of the chemical. The presence of a pollutant in biosolids alone does not equate to scientific risk, but the EPA's Biosolids Program is working hard to prioritize its risk assessment work for known but not yet regulated pollutants.”

They are “working hard” to do their job properly. How comforting. Their arrogance is unbelievable.
