

Germany is Being Dismantled

Is this NATO's biggest target?

For the past five hundred years or so, the dark, malevolent spirit behind the New World Order has nursed a special hatred for Germany.

From the foundation of Christianity in 30 AD or thereabouts to the Papal proclamation of May 4, 1493, the Enemy had been steadily extending his control over the entire earth. Setbacks were few and generally short-lived. Pope Alexander VI was sufficiently confident in the political and military power of Rome, supported by the immense economic resources available to him via the Catholic kingdoms and principalities of Europe, to issue a Bull, *Inter Caetera*, dividing the conquest and exploitation of the world outside of Europe between Spain and Portugal.

The outlook in 1500 was very promising indeed. Through a complex series of wars, ceaseless political intrigue, and the progressive concentration of power and wealth in an ecclesiastic network spanning the whole of Europe, Rome had become a nascent world capital. Its leaders could justifiably expect, through the continued use of their proven strategy – direct conquest, alliances, bribery, subversion, military intimidation, assassination, sabotage, and superior technology – to secure complete control over the rest of the world by 1800 or thereabouts.

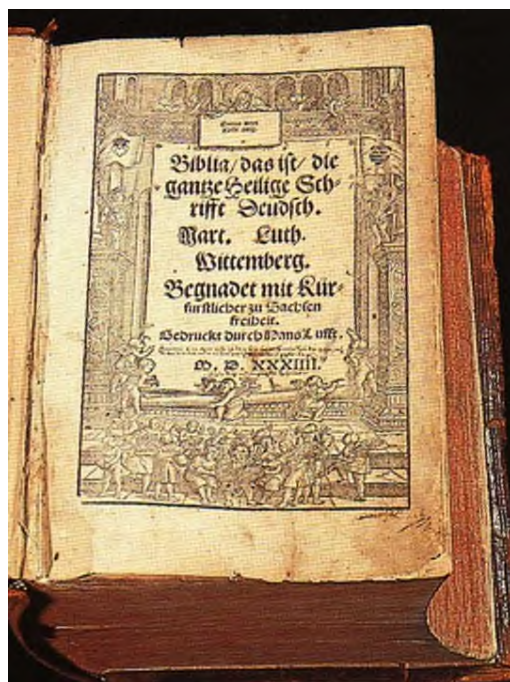
China and India were not nearly as politically cohesive as Europe, consisting mainly of rival fiefdoms and competing warlords. The Ottoman Empire, on the other hand, would offer greater resistance. Nevertheless, through a steady application of their effective *divide and conquer* technique, the Black Nobility – the consortium of powerful families that ruled Italy – expected to break down all barriers to their expansionary plans.

The impetus behind this ambitious enterprise was the spirit of Lucifer. His lust for absolute political domination of the entire earth would ensure that his human infantry would strive continually until this goal was achieved.

The Grand Plan was thwarted

Then disaster struck. Luther nailed his 95 theses to the door of a church in Wittenberg. His rebellion against the authority of Rome had a catastrophic effect, garnering support from all levels of German society and securing the protection of the Elector of Saxony. The standard Papal method of dealing with dissidents – which culminated in a mock public trial, imprisonment, torture, and, should the heretic fail to recant, execution – was thwarted by the German princes. They demanded that Luther receive a fair hearing.

As his theological arguments gained wider currency, his stance against Rome and her tyrannical brand of ‘Christianity’ attracted enormous popular attention. He was addressing, in a clear and understandable way, a range of issues which many Catholics in Germany had long wanted to discuss but were forbidden to do so. Luther pointed again and again to God’s Word as the final authority, and encouraged others to follow his example. As a result printed copies of the New Testament and other portions of Scripture began to circulate, at first in Latin or Greek and then in German.



Luther’s German translation of the Bible, 1534

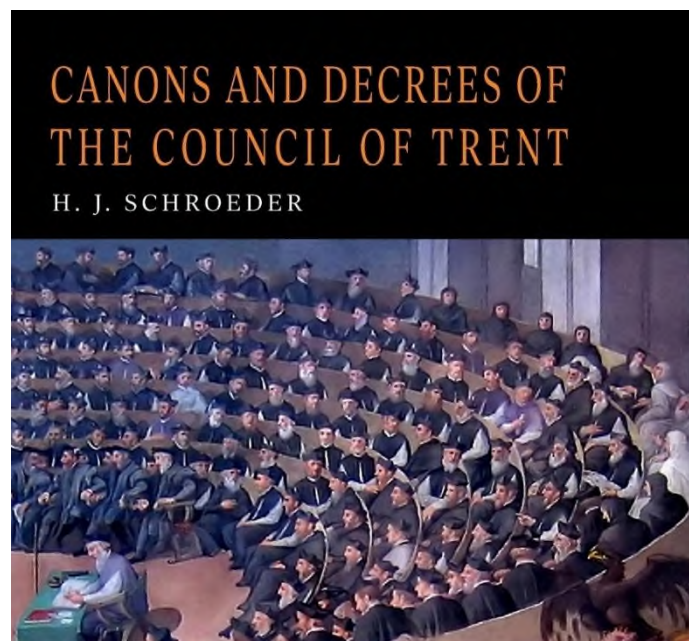
The idea that the common people could study the Bible for themselves was outrageous. Pope Innocent III (d.1216) had forbidden unauthorized translations of the Bible and confined its study to the priestly caste only. The Council of Toulouse, 1229, formally prohibited lay people from owning a Bible. Anyone who dared to obtain a copy of Scripture, which was available only in Latin, ran the risk of being called before the 'inquisition', a church-run system of prosecution where the accused was jailed and deemed guilty until he could prove his innocence. Torture was commonly used to extract a confession. Penalties included confiscation of property and execution. More often than not, no hard evidence was produced by the prosecution and a guilty verdict rested entirely on the 'reputation' of the accused.

Papal prohibition on Bible ownership

The prohibition on Bible ownership was sternly enforced across Europe for many centuries. As recently as 1950 it was rare to find a Catholic household in Ireland that possessed a copy of the Bible. Its members had to be satisfied instead with a compilation of approved Mass-related texts known as a 'Missal'.

Between 1545 and 1563, in a series of high-level ecclesiastic reviews known as the Council of Trent, Rome prepared a detailed refutation of every single reform suggested by Luther. To believe any part of Luther's 'protestant' theology was deemed a crime by Rome and the guilty party could be punished in whatever manner the Catholic hierarchy considered appropriate. The penalties imposed by these formal denunciations were known as *anathemas*.

The rulings issued by the Council were later compiled and published in a comprehensive document known as *The Canons and Decrees of the Council of Trent*. It included over one hundred anathemas and served as an official Papal rejection of everything sought by Luther and the reformers.



If our school system taught history in accordance with the facts, everyone today would know that the political elite who ruled Europe in 1563 were imposing a totalitarian system of government via their power base in Rome. The draconian system of social control enshrined in *The Canons and Decrees of the Council of Trent* was a precursor to the system now being imposed by the global elite via the UN, the WHO, and the World Economic Forum. In the same way that dissent, or the suspicion of dissent, was considered a treasonable offense in 1563, so today we have an emerging *social credit* system which monitors expressions of dissent online and assigns a graduated scale of penalties to encourage conformity and isolate non-conformists.

A blueprint for tyranny

We rightly denounce the awful plan of subversion and tyranny outlined in the document known as *The Protocols*, whose authors are commonly believed to be a confederacy of apostate Jews, but one seldom hears a reference to *The Canons and Decrees of the Council of Trent*, a document which is just as tyrannical in scope. Its dark purpose is rendered even more sinister, if that were possible, by its continued ratification by the Vatican. Very few people today seem to understand that the Tridentine anathemas continue to form part of Roman Catholic canon law! This proves without doubt that the guiding spirit of the Counter-Reformation, which caused death and mayhem on a grand scale across Europe in the 17th century, is still controlling the Vatican today.

As the Word of God says, we are battling against demonic princes and principalities. The human agents over whom they exercise control are probably not fully aware of the malevolence that energizes their invisible spiritual guides. The wicked are being led by forces that are far more evil than anything they could imagine.

These powerful spiritual entities remember with bitterness the vital role played by the German people in both starting and defending the Reformation. The plan they had been following for one and a half thousand years, a plan that had been steadily maturing to their satisfaction, had suddenly cracked down the middle. The imperial might of Rome now faced serious political opposition. Not only had a significant segment of the German people rejected Papal hegemony, but they had gained access to God's Word! The enemy of Rome was *armed!*

Satan faced the possibility of losing all the gains he had made over the previous millennium or more. Germany had to be destroyed. He began by creating a dedicated military wing within the Catholic Church to supplement the power exercised by the Dominican Order. The Society of Jesus was the driving force behind the Council of Trent and its terrible anathemas.

The Thirty Years War, 1618-1648

Once the necessary groundwork had been prepared and the Protestant movement in France had been destroyed, the Jesuits launched their scorching attack on the German people. The resulting carnage and destruction, known to history as the Thirty Years War (1618-1648), was comparable to that of World Wars I and II. The death toll is estimated to have been somewhere between four and eight million. These fatalities arose, not only from battlefield encounters and violent raids on towns and villages, but from famine, disease and widespread social collapse. At a time when the population of Europe as a whole was around 100 million people, this toll was horrific. In relative terms, it actually exceeded that of World War I and came close to that of World War II.

The Thirty Years War ended in stalemate. Unable to crush Germany, Rome agreed to a settlement known as the Peace of Westphalia. In effect it allowed sovereign kingdoms or nation states to exist and to exercise their autonomy without interference from Rome. This meant the Jesuits and the Black Nobility had to find ways to infiltrate and subvert these independent entities and draw them back under the scheming jurisdiction of Rome. As a result the distribution of political power across Europe in the period between 1648 and 1815 became very opaque and difficult to map until the famous Congress of Vienna in 1815.

The Congress of Vienna, 1815

The great powers that convened this congress, notably Britain, France, Prussia, Russia and Austria, were trying to frame a continental system of governance that would lead eventually to a united European federation. However, the Tsar of Russia was very uncomfortable with what the Freemasons of Britain, France and Prussia were trying to do and refused to give it his full support. He envisaged instead a European framework for peace based on Christian principles. By standing apart in this way, Russia became a target of the Rothschild oligarchs. They sought revenge and financed a league of anarchists who spent the rest of the 19th century undermining the stability of Russia. Five attempts were made on the life of Tsar Alexander II before he was finally murdered in 1881. Several attempts were also made on the life of his successor, Tsar Alexander III, but none succeeded. Finally the Rothschilds scored a major 'hit' in 1918 when they ordered the bloody slaughter of Tsar Nicholas II and his entire family.

The Russian 'revolution' was nothing more than a campaign of butchery organized and financed by the Rothschilds and their Kabbalist cronies. Communism is an apostate Jewish/Jesuit creation designed to destroy true Christianity and prepare the way for a totalitarian world government run by the super rich. It is steeped in Luciferian wickedness and takes considerable pleasure in punishing those who oppose it.

The destruction of Russia and its Orthodox culture was horrific in the extreme. The 'Red Terror', in which millions of civilians were murdered, was largely ignored by the Western press and the Vatican. So too was the Gulag system in which millions were incarcerated and worked to death over the following decades. Russian statistician, Professor Ivan Kurganov, estimated that, between 1917 and 1959, 'Socialism' – a ruthless nihilistic system of mass control – cost the lives of 110 million Soviet citizens, most of whom were members of the Russian Orthodox Church. This Satanic slaughter had a purpose, namely to transfer complete control of Russia into the hands of the Rothschilds.

The so-called collapse of Communism in 1989-1992 was a charade. The same people continued to run the country and the soviet satellites. The Rothschild puppet, Boris Yeltsin, authorized the privatization of Russian assets in the early 1990s, enabling a small number of 'oligarchs' to buy up most of the shares using money loaned to them by the Rothschild banks. The real owners of Russian oil and gas reserves, including massive mineral resources, are the Rothschilds. One journalist called this "the most cataclysmic peacetime economic collapse of an industrial country in history."

The betrayal of Germany by its leaders in two World Wars

Germany was sold into the hands of the global elite in a similar manner. The Prussian aristocracy who had represented northern Germany at the Congress of Vienna, managed to create a 'unified' Germany in 1860. This brought the rest of Germany under their control. The Hohenzollern monarchy immediately set about indoctrinating the German youth with their militarist values. The Habsburg monarchy which controlled the Austro-Hungarian empire did the same. The stage was being set for World War I, which would see the collapse of Russia and the infliction of severe economic distress on the German people.

The punitive terms of the Treaty of Versailles (1919) were designed to add to this distress and cause political turmoil across Germany. The resulting chaos facilitated the rise of the Nazi Party which had only one goal – to draw Germany into another major international conflict. The Second World War exhausted Germany to the point where the Allies were seriously contemplating, in the period 1945-1948, the reduction of Germany in its entirety to a purely agricultural economy. It would be totally de-industrialized and serve as little more than a supplier of food and raw material to the rest of Europe.

This plan was changed at the last moment when the Allies saw how much of eastern Europe had successfully fallen into the hands of Stalin. A great betrayal had taken place. With so many countries now under Communist control, the Allies would need an industrialized Germany to maintain the ‘balance’ between East and West. The resulting ‘Cold War’ would enable the massive build-up of military equipment on both sides and plant the conviction in the public mind that some form of world government was needed to avoid another, even more devastating war.



Nevertheless the plan to weaken Germany and break the will of its people was pursued in a modified form when a large chunk of the country was handed over to Soviet control. For 40 years the people of East Germany were subjected to intense Marxist indoctrination and taught to believe that communism alone could guarantee a dignified future for mankind. The ‘reunification’ of Germany in 1990 was primarily a way to reduce, in per capita terms, the wealth and industrial productivity of the country as a whole. It also diluted significantly the proportion of the German population that would actively resist the absorption of their country into a federal Europe.

The Energy Betrayal

Another major initiative to deindustrialize Germany began in 2011 when the globalists used a submarine explosion off the coast of Japan to destroy the Fukushima nuclear plant. Within a couple of months, the German chancellor, Angela Merkel – a deep state communist trained in East Germany – decided to close down all 17 of Germany’s nuclear-power plants, which supplied about a quarter of Germany’s electricity. She argued that they posed too great a risk to the security and well-being of the German people. No other country followed suit, even though the ‘Fukushima’ risk, so-called, was common to all such plants. Eight were shut down immediately and the remainder were closed by April 2023. Significantly, the closures were intended to be permanent, with many plants being decommissioned.

Merkel and her globalist cronies had betrayed the German people. The media failed to alert them to the high risk posed by these closures. There was no public debate and the major political decisions were taken at short notice with almost no analysis or consultation. The German media even took to casting Merkel as a caring and protective figure by calling her ‘Mutti’ – ‘Mother’.

When he left office in 2005, another German chancellor, Gerd Schröder, took up positions with the Russian energy companies Nord Stream, Rosneft and Gazprom. They were building a huge natural gas pipeline that would connect Russia with Germany. According to Wikipedia he also had a role as a “global manager” for investment bank Rothschild. The Nord Stream pipeline would make Germany heavily dependent on Russian energy and would cause serious problems for the economy if its operation was interrupted. International observers were very surprised that Germany would allow itself to be tied to one supplier in this way.

The closure of the nuclear power plants and the irrational decision to shackle the economy to a single supplier of natural gas were part of a deadly strategy to deindustrialize Germany. Those who had loudly condemned the Nord Stream arrangement were vindicated on 26 September 2022 when a series of undersea explosions destroyed the Nord Stream pipeline.

No group or nation accepted responsibility. However, very few countries had the technical expertise needed to carry out such a major act of sabotage and avoid detection. Since it was in the interests of neither Russia nor any European country to carry out an attack of this kind, most political observers assumed that America had done it. This opinion was supported by remarks that President Biden had made during a press conference on 7 February 2022, where he said “If Russia invades – that means tanks and troops crossing... the border of Ukraine again, there will no longer be a Nord Stream 2. We will bring an end to it.” When a reporter asked the President how the US could do this, given that the pipeline was under German ownership, he replied: “We will, I promise you, we'll be able to do it.”



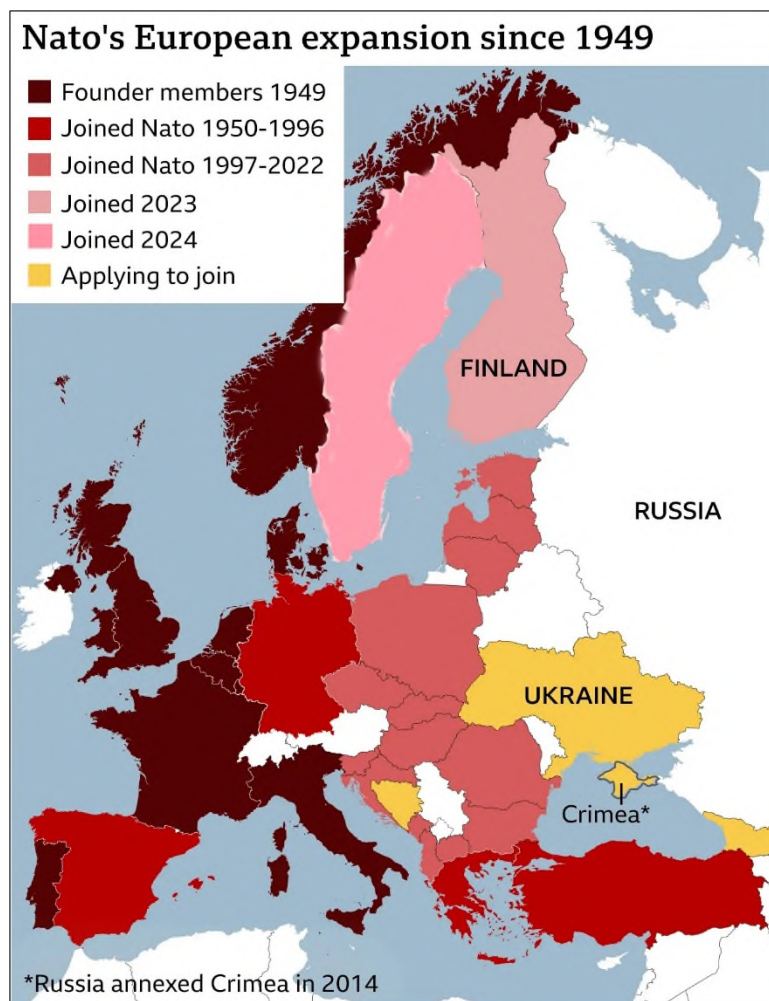

The veteran investigative journalist, Seymour Hersh, published a devastating analysis of the Nord Stream explosions in his Substack newsletter of 8 February 2023. Under the title, *How America Took Out The Nord Stream Pipeline*, Hersh revealed that unnamed sources had described to him how a team of experienced deep-sea saboteurs, trained by the US military, had been recruited by the CIA to carry out the operation.

Hersh added that the CIA works, not for the Constitution, but “for the Crown.” Not many journalists are as candid as this. As we have noted in several of our papers, the ‘world conspiracy’ is co-ordinated from London. If Satan has a capital city, this is it. Rome and Washington DC are major players of course, but day-to-day oversight of the multi-faceted program to bring in the Antichrist is maintained by a huge underground complex in the city of London known as “the Crown”. A connection with the bloodline of the British royal family is also implied by this term. The late Queen Elizabeth called it “the Firm” – since she was the *Crown*.

All governments are working for the Rothschild Cabal

The scenario we are describing only makes sense when we see that the governments of all nations, with perhaps a few exceptions on the continent of Africa, are working for the Crown, the consortium of top international bankers led by the Rothschilds. They are all prepared to betray the countries they “rule” in whatever ways the Crown decrees. Schröder and Merkel betrayed the German people. Putin and his team serve the Crown, not the Russian people. Biden, Trump and the rat’s nest of liars and deceivers who “rule” the US from Washington DC also work for the Crown. The list is endless. The Cabal is not yet sufficiently entrenched to openly boast of the power it exercises, but its leaders expect to be able to do so when their long-planned ‘New World Order’ is established.



The harm inflicted on Germany by its loss of the Nord Stream pipeline has been severe. Households and industry incurred substantial increases in the cost of natural gas and electricity. Some companies had to reduce or cease production temporarily. The government was forced to introduce subsidies and financial relief packages, the cost of which was borne by the taxpayer. Higher energy costs pushed up the rate of inflation and obliged many companies in the industrial sector to transfer some or all of their operations to locations outside Germany. It has been estimated that as many as 2 out of 3 have done so to date! As a result German economic growth is close to zero and shows no signs of improving.

The Anglo-American Axis wants war, not peace

Attempts to find a diplomatic solution to the Ukraine crisis have been consistently resisted by the US. As we explained in our previous paper (#390), the Biden regime wants war, not peace. Subject to limited territorial concessions from the Ukraine, the Russians have indicated on several occasions that the conflict could cease immediately if the Ukraine agreed to remain neutral and not pursue membership of NATO. Under the circumstances, where the weaker country is being torn apart and hundreds of thousands are said to have died, the Russian offer merits serious consideration. When this approach was first tried, just weeks after the conflict began, the US sent former UK prime minister, Boris Johnson, to the Ukraine to sabotage negotiations. The groundwork for this trip had been prepared some two weeks earlier by Polish president, Andrzej Duda, at a NATO conference in Brussels on 24 March 2022.

Given the belligerence of the US and the prospect of the war escalating into an international conflict, Germany has been obliged to increase its military spending by a massive 40 percent. This too is a major burden on the taxpayer.

The US has also imposed a significant and unexpected strain on the German economy by pressing two of its largest companies, BASF and Volkswagen, to close down their huge manufacturing base in the Xinjiang region of China. The US is accusing Beijing of human rights violations in the region, which has a very large Muslim Uighur population, and by doing so implying that all large manufacturers in the region, such as BASF and Volkswagen, are implicated. No credible evidence has been offered by the Biden regime to support this allegation. Under normal circumstances the German government would have angrily dismissed it as propaganda. However, the German authorities are doing everything they are being told to do by the US. It is all part of the game plan, where top politicians and seasoned industrialists in Germany make seriously irrational decisions which can only hurt the German economy and the German people.

Germany's radically revised 'defense' strategy

One of the clearest signs that Germany is now doing whatever the Crown demands is the recent introduction by the German military of a radically revised defense strategy for the country (known as the RRGV plan). It is cast, not as a peacetime document, but as a set of emergency measures to address the prospect of imminent war. It even identifies Russia as the enemy and implies a time scale of 3-5 years. For example, in its introduction it states:

Russia's war of aggression against Ukraine is a breach of international law and the European security order. Germany and NATO responded to this by expanding their deterrence and defense capabilities. For the first time in decades, Germany is again under military threat.

It also sets out the legal justification for what it is now doing:

Germany has committed itself to mutual assistance in the North Atlantic Treaty. In the event of an armed attack against one or more NATO states, the other contracting states are obliged, according to Article 5 of the North Atlantic Treaty, to exercise the right of individual or collective self-defense recognized in Article 51 of the UN Charter of the party or parties that are attacked: To provide assistance by taking, without delay and in cooperation with the other parties, measures, including the use of armed force, deemed necessary to restore and maintain the security of the North Atlantic area.

The document is designed to involve the civilian population in the conflict to the greatest extent possible. The rationale for this is set out in paragraph 2.3.2.2 -

Security precautions are not only a task for the entire state, but also a task for society as a whole, which, in the spirit of integrated security, requires the participation of the population, science and business in order to strengthen the resilience of the state and society as a whole.

So, “in the spirit of integrated security”, the entire country will be put on a war footing, recruited to work long hours in assignments deemed essential for the war effort, and exposed in full to the dangers associated with such assignments.

Steps to militarize the German civilian population

Of its many detailed provisions, these are probably the most shocking:

- o the introduction of compulsory military conscription under the Conscription Act. This applied in the past (up to 2011) to all males aged between 18 and 45. It is unclear whether women will also be conscripted.
- o the compulsory reallocation of labor under the Employment Security Act whenever the open labor market is unable to meet specific requirements. The document states that male civilians aged between 18 and 60 may be employed by the Bundeswehr (military administration). Female civilians between the ages of 18 and 55 could be enlisted into the civilian health care system and the ‘stationary’ military hospital service. The document also provides (23.7.3) for the compulsory assignment of members of “non-medical professions” to health care work.
- o In an emergency, the highest state authorities can issue “exit and entry bans”, as well as evacuation orders, to protect against threats to the population.

- o The accommodation and care of “all uninjured people in Germany who have become homeless due to the effects of war” will be ensured through appropriate measures. [The widespread destruction of civilian property would appear to be expected.]
- o The possibility of biological threats to humans is mentioned three times. Also the following provision (20.4.2.3) tells us that, if animal diseases are expected, bio-weapons are likely to be used: “The veterinary offices should be obliged to draw up and update plans for combating animal diseases.”
- o If the supply of food to the military is under threat, any shortfall will be met by the mandatory requisition of civilian supplies. The document even warns the public to expect a food crisis: “In a crisis and in the event of a defense, a decline in imports, especially overseas imports, but also disruptions in the production and distribution of food must be expected.” In a “supply crisis” the authorities may introduce controls, including the rationing of food and electricity.
- o The state will maintain a “Federal Grain Reserve” and a “Federal Civil Emergency Reserve”. These are intended “to provide the population with one hot meal a day for a certain period of time, especially in metropolitan areas”. The masses will likely be huddled together in bunkers - “Underground car parks or subway stations that are located below the surface of the earth also offer protection against explosions.”
- o The military will be empowered to requisition certain goods from the public when required, such as motor vehicles, construction equipment, and IT infrastructure. Paragraph 22.4.1.3 also states that “the supply of goods and services to the Bundeswehr when necessary through the use of civilian means of transport, services and facilities must be guaranteed.”
- o “Precautions must be taken to prevent the risk of dams breaking”
- o “the Federal Government is authorized to introduce a reporting requirement for non-working health professionals by means of a statutory ordinance” – This means a high casualty rate is expected.
- o Employees will not be allowed to leave their jobs and move to a safer location except where enabled by “legal ordinance” (23.2.4.1).
- o Employees may be required to work longer hours or seven days a week and may be assigned to different jobs or moved to a different location (23.3.2).

- o Public servants may be assigned without their consent to work with other employers, performing tasks that do not match their qualifications. Also, “civil servants are obliged to serve beyond regular working hours for defense purposes without any special remuneration.”
- o Men and women between the ages of 18 and 60 can be obliged to provide assistance in countering certain threats in defensive situations if the available forces are not sufficient. This would appear to be what the original German text is saying (23.5.2):

“Männer und Frauen vom vollendeten 18. bis zum vollendeten 60. Lebensjahr können verpflichtet werden, bei der Bekämpfung der besonderen Gefahren und Schäden, die im Verteidigungsfall drohen, Hilfe zu leisten, sofern die vorhandenen Kräfte nicht ausreichen.”
- o In their work employees must “accept risks and hardships that are reasonable given the circumstances”.
- o “The allied armed forces and NATO military facilities on the territory of the Federal Republic of Germany [will] receive support based on Germany’s commitments to NATO...”
- o IT services will be maintained to ensure that “warning information about chemical, biological, radiological and nuclear hazardous events is transmitted to the military authorities”
- o Civil defense will comply with measures by the Bundeswehr as part of the state-wide support for foreign armed forces when staying in or transiting through Germany. Substantial troop movements within and through Germany would appear to be expected.

The Core Message

These 18 provisions, along with a great many others in the 67-page document, set out a comprehensive statutory plan to control the entire German population during the coming conflict. One only gets a true sense of its implications when the most draconian elements are brought together.

It envisages a situation which will impose as much disruption, trauma, suffering, mutilation and death on the German civilian population as World Wars I and II. The plan enables the government to break up families, assign workers to any location, involve women as well as men, require them to work long hours without pay, and to survive on rations or low-calorie nutrition. In a real sense, the plan turns the civilian population into a branch of the military, exposing them to dangers arising solely from their assignments and making compliance mandatory. The military itself will be greatly expanded through compulsory conscription. The document is vague as to what extent women and older males will be conscripted but its many provisions suggest that the state will draw as much as possible on all able-bodied men and women under age 60, either as direct military recruits or as slave labor.

The core message in this treasonous document is that Germany will be destroyed and the German people will be made to co-operate in their own destruction.



The Hohenzollerns followed the Illuminati plan to crush Germany in World War I. They betrayed the German people and fed them endless lies through the media and educational system. Prussian militarism was designed to lure Germany as a whole into an insane conflict which could have only one outcome. All attempts to broker a peace deal were rejected by the Allies (US and Britain). The Crown wanted to inflict the maximum possible damage on the German people.
