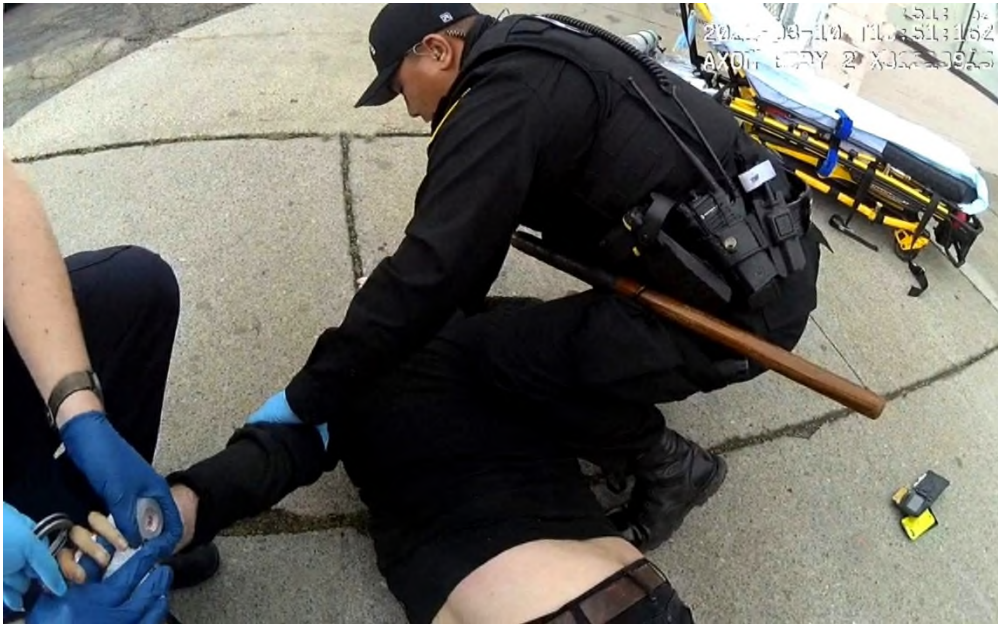


New Zealand to Allow Forced Vaccinations with Police Assistance

If more people understood the nature of evil, it would wreak less damage on the earth. Many today, including professing Christians, have little or no understanding of evil, therefore the scope that the Wicked now enjoy to carry out their plans is probably without equal in history. We saw this happen on a grand scale in 2020-22 and, given what the authorities in New Zealand are planning to do, we are about to see it all again.

It was for good reason that we gave such a stark title to our earlier paper, #291, ***The World is Under Demonic Attack***:

In that paper we drew attention to an ancient and well attested spiritual truth, namely that the Wicked worship and revere the god of this world. As such many of them strive to form a bond with one or more supernatural entities ('demons') and thereby enhance their power. We gave Alan Dershowitz, the famous American lawyer, as an example. In 2020 he publicly advocated the forced vaccination of people who refused to take a vaccine during a pandemic.

Here is what we said:

Dark spirits control these wicked people

We don't often get to see the resident demon manifest in a public figure, but it does happen. The American lawyer Alan Dershowitz – an arrogant Kabbalist and known associate of predatory pedophile Jeffrey Epstein – had the audacity to make the following claim in an interview on 19 May, 2020, and again, in a more nuanced manner, in a debate with Robert Kennedy Jr on 23 July:

“Let me put it very clearly. You have no constitutional right to endanger the public and spread the disease. Even if you disagree you have no right not to be vaccinated. You have no right not to wear a mask. You have no right to open up your business...if you refuse to be vaccinated the state has the power to literally take you to a doctor's office and plunge a needle into your arm.”

On two occasions during the interview, the demon controlling Dershowitz showed itself for a fraction of a second – first at 3.29 and then, more aggressively, at 3.31 (*see above*). Many who watched this video probably missed these two remarkable flashes of demonic rage. A normal person cannot do what Dershowitz did – form and erase an expression of rage in a fraction of a second – but a demon can.

Dershowitz is a high-ranking member of the Cabal that rules America and the world as a whole. They are all in rebellion against God and they all swear allegiance to Lucifer. This means that their goals – ultimately – are those of their demonic master. Since Satan craves the complete destruction of humanity – as the Book of Revelation clearly shows – then we ought to assume that his chief followers, either knowingly or unknowingly, are complicit in achieving the same goal.

For this reason it behoves us, as Bible-believing Christians, to accept that those who rule the world from behind the scenes are intent on genocide. This is certainly a hard fact for many to accept, and yet it is true – Biblically true.

The need for a thoroughly Scriptural approach

It is in this light that we ought to examine what the Enemy has been doing over the past five years. We have to assume that, given an opportunity to achieve his ultimate goal, he will take it. So, if he has engineered a situation where billions of unsuspecting people allow themselves to be inoculated with an untested, experimental substance, we must take into consideration the possibility that this substance may be tainted in some way.

There is a Biblical obligation on us to follow this line of inquiry, to at least bear it in mind and watch for evidence that may corroborate it. If there is no corroborating evidence, then we may safely assume that no malice was intended. However, as anyone who has taken the time to examine recent medical statistics on morbidity and mortality will already know, there is compelling evidence to show that the so-called Covid ‘vaccines’ have caused serious harm to a great many people.

One of the sinister aspects of the entire Covid campaign that our respective governments conducted was the extent to which so many ‘prophylactic’ and ‘therapeutic’ measures were mandatory. Those who breached the regulations were guilty of an offense and a large proportion of the population was coerced into taking the ‘vaccine’. The public was told over and over again that perfectly healthy people, who refused the vaccine, were putting the lives of others at risk. Many lost their jobs for failing to comply and opt-out provisions, where they existed, were very grudgingly applied.



A seasonal flu epidemic was transformed, through the use of a scientifically bogus PCR test, into a deadly pandemic threat which could result in a huge number of fatalities if draconian measures were not imposed. In short, as many can now see, the so-called ‘pandemic’ was a carefully planned hoax. The Cabal succeeded in getting over 90 percent of the population of many countries to receive one or more doses of the fake vaccine.

Along the way they imposed severe social controls across nearly all nations, controls which they can reimpose at any time by launching yet another “we are all going to die” fear-laden campaign where, it is claimed, an allegedly deadly virus threatens to sweep the world unless we take decisive action.

They have told us what they are planning to do

We know they are planning to do this because they have repeatedly advertised their intentions. The WHO has issued many warnings of an inevitable respiratory pandemic which, in their view, will demand a centrally co-ordinated worldwide response. They have lobbied strongly for powers that will enable them to bypass the autonomy and independence of sovereign states and impose draconian lockdowns solely on the basis of a ‘pandemic declaration’ by the Director.

The powers they are seeking are insanely dangerous and many influential bodies have opposed their introduction. So, in order to press ahead with the next hoax pandemic and use it to subjugate nations, the Cabal would appear to have ordered individual countries to introduce draconian domestic legislation to facilitate the imposition of a worldwide lockdown and mandatory ‘vaccination’ campaign.

New Zealand is the first to do this.

Criminally insane laws introduced by two countries in 2020

Before we examine what that country has just announced, we ought to look at revolutionary health legislation introduced by two other countries in the English-speaking world in 2020.

The first is the UK Coronavirus Act 2020 which received Royal Assent on 25 March. We set out in **Appendix A** a layman’s summary of the powers granted to the state under that piece of legislation.

According to the UK Parliament website, many of these provisions lapsed on 22 March 2022, but some are permanent. As far as we can determine, virtually any provision in the Act can be “revived” at a future date if the government so decides. We can see, therefore, that the 2020 Act can be used to instantly confer draconian powers on the UK government if another ‘pandemic’ is declared. The extent of these powers may be gleaned from **Appendix A**. As we noted, forcible vaccination is only indirectly enabled under the Act by declaring the subject to be mentally incapable – a slow procedure compared to what the New Zealand authorities are now planning.



Coronavirus Act 2020

The second country is Ireland. In an earlier paper (#249) we identified the many basic human rights which were violated by the legislation passed by Dáil Eireann in March, 2020: ***The Health (Preservation and Protection and other Emergency Measures in the Public Interest) Act 2020*** and the ***Emergency Measures in the Public Interest (Covid-19) Act 2020***. Of the sixteen inalienable rights that we identified – our God-given rights guaranteed under common law and enshrined in our Constitution – all but one were set aside by the state.

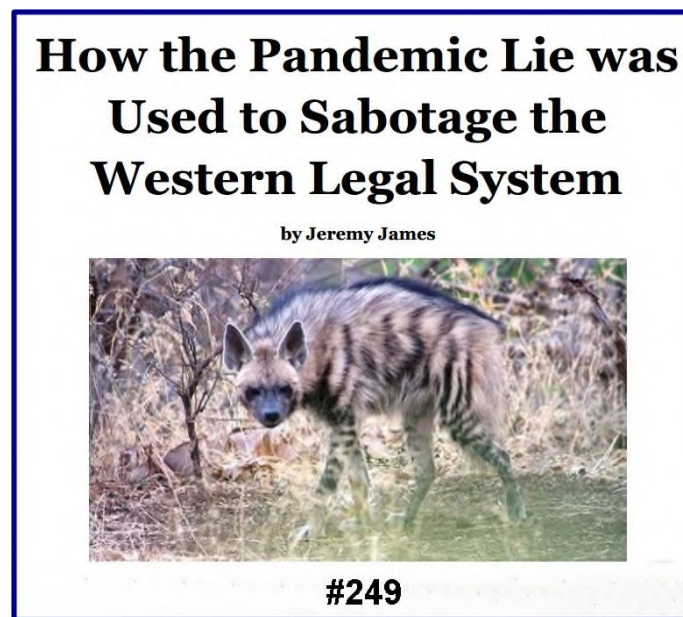
The Irish media gave their full support to this tyrannical development. Not one major outlet carried an opinion piece contesting what the government had done, or reviewed the degree to which our basic rights were violated, or highlighted the gross disparity between the extreme nature of the measures being introduced and the alleged health threat they were meant to address.

We showed in detail in paper #249 the many ways the government of Ireland abused the legal and Constitutional rights of its citizens – see **Appendix B**, for example. Similar abuses were being committed in over a hundred other countries, all in concert with the Communist program of enslavement devised by the Cabal. Here is a revealing extract from that paper:

“Covid legislation is deliberately designed to override the Constitution and deem all citizens “guilty,” without a “trial” or due process, of being a permanent potential biohazard. This “guilty verdict” is given by the “court” of government without even the dignity of a scientific or other “test” to determine whether, and to what extent, the individual is likely at any time to contract and succumb to the pathogen in question. This means the vast majority of the population, who enjoy good health, who have no co-morbidities, and who have a robust and fully functioning immune system, are treated under the law – automatically and without recourse of any kind – as health hazards on a par with very elderly persons with poorly functioning immune systems, one or more co-morbidities, and a need for constant medical care and attention.

“By any reckoning, this is intolerable. The individual is deprived on his or her liberty on the most spurious and unscientific grounds. Perhaps the most fundamental God-given right of all – the right of *habeas corpus* – is trodden underfoot. The whole of Common Law is built on the pillars of *habeas corpus* and due process. Covid legislation topples both and restores to the Elite the ancient royal prerogative of discretionary enslavement.”

The sinister, totalitarian attitude that enabled this to happen is alive and well. It hasn't disappeared. The Cabal succeeded in imposing phase one of their plan in 2020 and phase two is about to commence.



Forced vaccination

This second phase will build on the framework set in place in 2020 and will include a feature that existed only in a mental health context in phase one – forced vaccination.

We have been shown this, in flashing red lights as it were, in a recent document published by the New Zealand Ministry of Health. Mr Dershowitz's nightmare scenario is being given statutory effect.

This horrific new regulation may have arrived first in New Zealand, but there is no doubt that other countries will shortly follow suit.

Be warned. The Cabal seem determined to use cold physical force to subdue the civilian population and administer kill shots to those who refuse to submit to their 'new' system of governance.

A closer look at the New Zealand document will show that this coercive, heavy-handed approach informs virtually all of the measures endorsed by their government. The authorities expect the public to be cowed and cajoled by the dreadful 'disease' scenarios that the Ministry of Health claims are certain to arise in the near future.

The document shows that they are building on the nasty Marxist rhetoric and thuggish conduct of their former prime minister, Jacinda Ardern (It is significant that Archbishop Vigano, who has for several years warned of the New World Order, recently declared that the 'spouses' of French President Macron and former US President Obama are both transgenders – that is men who profess to be female and dress accordingly. We agree with his assessment and would add J Ardern to his list.)

Endless ‘pandemic fear’

The NZ Pandemic Plan 2024 is designed to run forever. This is clear from p.6 which states that: “Viruses that have pandemic potential are those that can undergo antigenic changes – for example, influenza viruses and coronaviruses.” The plan assumes that new vaccines will continually be required to tackle emerging “variants” against which the general population has no immunity, allegedly. This trick was used in the 2020 hoax but is now being given top billing since it enables the government to keep their program running indefinitely. They confirm this when they say: “Sometimes a virus may undergo a major change in its genetic profile. This results in a new virus sub-type to which humans have no immunity. This new sub-type may be a virus with pandemic potential.”

It is a very difficult document to read because the spirit behind it is so dark. There is a malign purpose behind almost every paragraph.



Zoonotic diseases

Another important new feature in this expanded pandemic plan is the emphasis placed on “zoonotic” diseases. These are diseases which can allegedly cross from animals to humans and pose a serious threat to human health. The document does not bother to offer evidence that future ‘pandemics’ may be due such diseases. Instead they simply assert it as a fact: “Coronaviruses are zoonotic, meaning they are transmitted between animals and people.” Since the whole pandemic thesis is predicated on the emergence of rogue coronaviruses, the automatic inclusion of animals – of any species – as a possible source is a very worrying development.

Until now the public has been conditioned to think only of bats and pangolins as dangerous zoonotic sources, but the emphasis has recently shifted to domestic fowl and pigs. This document goes a step further and effectively makes any animal species a potential source of a pandemic-causing coronavirus. This means farms animals may be culled under the plan, with entire herds of cattle or flocks of sheep being slaughtered because some nameless authority decides that they pose a “risk” or failed a “test” (*their* bogus test, of course, akin to the meaningless PCR test used during the ‘Covid’ scam).

Engineered food shortages

This ‘zoonotic’ dimension marks a clear overlap with another well-known source of severe social oppression, namely a radical reduction in the food supply. Stalin did it in the Ukraine in the 1930s, sending his henchmen to remove all stores of food and supplies and requisition existing crops. Millions died a terrible death. It should be noted that the Cabal exercised such power over the media even then that news of the atrocity did not circulate outside of the Soviet Union. As one website puts it:

“Not a single Western newspaper or press agency protested publicly against the confinement of its correspondents in Moscow or investigated the reason for this extraordinary measure. The majority of reporters complied, fearing possible expulsion and losing their journalistic privileges. This limited the possibility of press coverage of this tragic event.”

A senior journalist with *The New York Times*, Walter Duranty, was allowed to enter the Ukraine and check whether the rumors were true. He reported back categorically that, while there may have been isolated food shortages in the Ukraine, there was no famine. However, according to a British Diplomatic Report, Duranty conceded off the record, that “as many as 10 million” may have perished in the Soviet Union and that the “Ukraine had been bled white.” (In recognition of his service, the Cabal awarded Duranty the Pulitzer Prize in 1932.)

Today the same Cabal control the same media and pursue the same agenda with the same goals, using the same methods and the same lies. There is nothing new under the sun. These guys are very dangerous and have every intention of doing whatever it takes over the next few years – including mass killing on a horrifying scale – to impose their long-planned ‘new world order’.

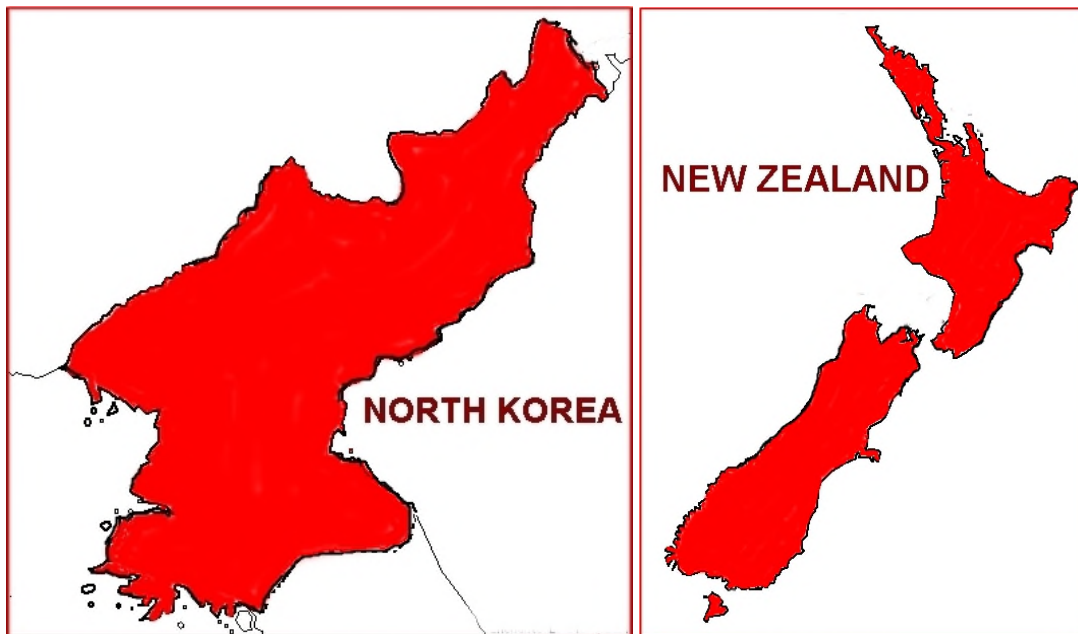

Another feature of the NZ pandemic plan is a neurotic emphasis on surveillance and contact-tracing, with extensive monitoring of vaccine roll-out, testing, vaccination status, self-isolation, and mandatory quarantine. The plan would appear to allow the state to investigate any circumstance, any building, any home or premises, and any person or group where it believes a health risk had arisen or might be likely to arise.

There are many indications throughout the document which suggest that the NZ police will be able to go anywhere and interview anyone at their discretion, without probable cause or a court order. (This will likely give them powers similar to those enjoyed by the military police in North Korea, including immunity from prosecution if they abuse those powers.)



They seem to get closer every day.

Censorship

The pandemic plan also provides for the introduction of whatever legislative measures may be needed to combat “misinformation and disinformation”. The document takes care not to disclose the form this will take, presumably to avoid provoking a public reaction at the present time. The attitude of the authorities to any dissemination of views contrary to the official narrative may be gleaned from the following statement on p.53:

“Along with the pandemic, there will also be misinformation and disinformation, which may be voluminous and significant in its consequences.”

Given the many published studies which show that mask wearing confers no health benefit whatever and probably causes psychological if not physical harm, the NZ plan even prescribes the widespread use of masks. Social distancing, travel restrictions and “enhanced quarantine” are also included.

Relentless coercion

It is also clear from the plan, both from the provisions themselves and from the tone employed when discussing them, that the state intends to condition the public to perceive any form of non-cooperation as a failure of social responsibility. In all likelihood those who try to “opt out”, whether by refusing to wear a mask or engage in social distancing, will be portrayed as a health threat to their neighbors. The stigma created by non-conformity will be even greater than it was during phase one (2020-2022).

What if a significant number of citizens decide to leave New Zealand to escape the tyranny? Would that be possible? Certainly not! No-one is going anywhere:

“[The state will] Consider and implement measures or restrictions on people leaving New Zealand to prevent spread of the disease internationally.”

At least one’s personal property will be safe? Think again:

“Mandated measures may include... commandeering of resources (eg, land, buildings or vehicles).”

Special Powers

The sections in the plan under the headings *Routine Powers* and *Special Powers* are of such importance that we give them in their totality in **Appendix C**.

As you read them bear in mind that similar provisions are likely to pass into law in your own country before long.

As Samuel Johnson said, “Depend upon it, sir, when a man knows he is to be hanged in a fortnight, it concentrates his mind wonderfully.”

Rather than provide a commentary on these sections, we have simply highlighted the passages which point directly to the totalitarian thuggery which the Cabal intend to foist upon a sleeping world.

Please dwell on these passages and ask yourself how anything like this could be allowed to happen. The Cabal can only get away with it because the sleeping world has only an infantile understanding of the evil in its midst.

CONCLUSION

The use of force to inoculate an unwilling subject is a truly horrifying development. Oddly enough, the document does not expressly state that vaccines will be mandatory, and yet the “use of force” clearly implies that they will. So too do the many other instances where unquestioning compliance is expected with respect to the whole panoply of repressive measures. The word “mandatory” appears 17 times in the document, usually in a manner which implies that exemptions will be rare and infringements will be punished, e.g “Put in place regulations for any mandatory requirements, including enforcement, infringement and exemptions.” (p.77)

Some commentators have suggested that another series of worldwide lockdowns will not be possible, that after their experience of the last series the public will simply not tolerate the imposition of such draconian measures a second time. In forming this view they overlook the overwhelming role that fear played in phase one and underestimate the ability of the Cabal to generate an even greater wave of fear in phase two.

“...the heart of the sons of men is fully set in them to do evil.”

- Ecclesiastes 8:11

This will likely be achieved by turning on the 5G transmitters that have been installed all over the world (during the phase one lockdowns) and sending bursts of high frequency radiation across selected communities, possibly during the night – see **Appendix D**. Depending on the amount of nanoscale magnetic particles the individual has absorbed from vaccines and other sources, the adverse health implications of this radiation could be severe. A lot of people will become extremely ill and many will die. The public will be told that a deadly new “coronavirus” is on the rampage and that they must get the protective “vaccination” as soon as it becomes available.



Are we exaggerating?

Are we exaggerating? This is a question that everyone should ask. In weighing the evidence they should take into account events of the recent past, the severe nature of the regulations being imposed (including forced vaccinations), the remarkable determination by the Cabal to run again with another pandemic hoax, and the warning in God’s Word regarding the savagely destructive spirit that will govern the world in the latter days. Remember, the supernatural force that will control the Antichrist is also guiding the Cabal.

For those who doubt the warning in God’s Word – and who in the process are willing to disregard the appalling wickedness that will come close to destroying life on earth in the End Time – there is nothing we can say. The evil of the fourth kingdom exceeds anything we have seen before in history, while the technology at their disposal is orders of magnitude greater than that which existed even 70 years ago.

APPENDIX A

A layman's Summary of the Main Provisions of the Coronavirus Act 2020 [UK]

Any person, including children, can be forcibly detained and isolated by the state for any length of time. This can be done without a court order, without legal representation, and without documented medical evidence. [Some may cavil over our interpretation of the length of time involved, but the Emergency Powers are such that the state can detain anyone as often as it deems necessary.]

The state can forcibly test any person, including children, and remove samples of bodily fluid for that purpose.

It is unclear where the state plans to hold detainees, but it could be hundreds of miles from their home and family. There will likely be no visitation rights, no independent supervision of the care provided, no legal inspection of housing conditions or medical treatment, and little or no documented proof that one's continued detention is medically justified.

The state can impose lockdown conditions on the entire population or on such segments of the population as it decides. Public gatherings, no matter how small, can be made illegal and those who violate this rule can be arrested. It will therefore be impossible for any group – such as a civil rights organization – to protest in the street against this draconian piece of legislation or even to organize indoor meetings to discuss its implications.

The surveillance powers of the state are greatly increased. Whether or not the Act allows the police to enter one's home without a court warrant is unclear. Some of the powers granted to the authorities under the Act are so vaguely worded and so general in nature that householders may not be able to refuse entry without violating some provision or other of the Act.

The Act does not appear to provide for forcible vaccination, but it does greatly increase the power of the state to deem a person mentally incapable and to forcibly medicate them. Relatives of detainees may not be aware that this is happening and would appear to have no right legally to intervene or to request an independent medical assessment.

The state has the power to cremate any person who dies while in detention. It will not be possible to request an autopsy where foul play or maltreatment are suspected. The doctor who signs the death certificate does not need to have seen the victim at any time, alive or dead.

Current provisions in law regarding culpable responsibility and duty of care, as they apply to health service workers, are greatly relaxed. In effect, anyone treating, supervising or monitoring a person in detention is indemnified under the Act.

Extract from our paper #249 regarding police powers granted under Irish 'Covid' legislation in 2020

Of the many astonishing powers which the state has vested in itself, none are as draconian or inimical to Common Law and natural justice as those given to the police, known in Ireland as the Garda Síochána, under Covid legislation. For example, it provides for the following:

- **a police officer may arrest a person without warrant if, having requested them to comply with a regulation made under the Act, they fail to do so.** All he needs is “reasonable cause to believe” that the individual did not comply. Why bother with old-fashioned notions like probable cause, evidence, witnesses, a fair hearing, a court order, or proof that any harm was done?
- **any person authorised by regulation to enforce any of these provisions may call upon the support of the police where force or coercion are likely to be required,** including “detaining any person, bringing a person to any place, breaking open of any premises, or any other action in which the use of force may be necessary”.
- **any medical officer who believes in good faith that a person may be a potential source of infection may order in writing the detention and isolation of that person against his will in the place specified in the order, until such time as he believes the person in question is no longer a potential risk to public health.** The person detained in this way can ask for an independent medical review of his case and the medical officer is required to comply with this request, but only “as soon as practicable.”

Powers like this are usually exercisable only in a totalitarian regime or police state, where cold-blooded thuggery is a regular feature of law enforcement.

APPENDIX C

The sections on ‘Routine Powers’ and ‘Special Powers’ in the New Zealand Pandemic Plan

- start of extract -

Routine powers

Several routine powers are relevant in the pandemic context.

A medical officer of health or health protection officer has the power to enter any premises, including by boarding an aircraft or ship, at any reasonable time if he or she ‘has reason to believe that there is or recently has been any person suffering from a notifiable infectious disease or recently exposed to the infection of any such disease’ (section 77 of the Health Act).

The power to examine allows a medical officer of health or health protection officer **to medically examine any person in any premises**, including on an aircraft or a ship, to ascertain whether a person believed to be suffering from a notifiable infectious disease or recently exposed is suffering or has recently suffered from the disease (section 77).

The power to detain at a specified place of residence for isolation purposes allows a medical officer of health to issue a written direction to a person or contact whom the officer believes on reasonable grounds poses a public health risk arising from an infectious disease under sections 92I to section 92K. These sections outline a variety of conditions the officer may specify in the direction, including to stay at all or specified times at a specified place of residence, subject to specified conditions. The direction must specify its duration. Directions cannot be used to compel a person to seek treatment under Part 3A. For that to happen, the officer must apply for and be granted a public health order, order for contacts or medical examination order with a treatment order component under that Part. **A medical officer of health may issue a direction under section 92K to a person to undergo a medical examination**, although several pre-conditions must first be met (eg, the person has not complied with a previous request to seek examination).

A medical officer of health can also issue directions to the head of an educational institution where staff or students pose a public health risk because of infectious disease and the risk is unlikely to be managed effectively by solely giving directions to individuals (section 92L). A medical officer of health may, after consultation with the head of the institution, direct them to direct a student or staff member to stay away from the institution for a specified period, until the infection risk has passed (section 92L). The *Communicable Diseases Control Manual* (Health New Zealand) (currently under review) sets out disease incubation periods for various infectious diseases, which will assist in **determining how long unimmunised contacts and infectious cases must stay away** from the institution. Alternatively, the head may decide to take action themselves, under the Education and Training Act 2020. Where it is necessary to close part or all of the institution, the medical officer of health can issue a direction for closure to the institution's head.

Subpart 5 of Part 3A of the Health Act provides for **formal contact tracing**. **This is most useful in a situation in which voluntary contact tracing is not working, or the case is not cooperating**. A medical officer of health, health protection officer or other person authorised to contact trace under subpart 5 can require the case to provide specified information about contacts, including each of their identifying and contact details, in order for the contact tracer to identify the disease's source, make contacts aware that they too may be infected and may require testing and treatment, and limit the transmission of the disease.

Special powers

Special powers are authorised by the Minister of Health or by an epidemic notice or apply where an emergency has been declared under the Civil Defence Emergency Management Act 2002.

The power to detain, isolate or quarantine allows a medical officer of health to 'require persons, places, buildings, ships, vehicles, aircraft, animals, or things to be isolated, quarantined, or disinfected' (section 70(1)(f)).

The power to prescribe preventive treatment allows a medical officer of health, in respect of any person who has been isolated or quarantined, to require people to remain where they are isolated or quarantined until they have been medically examined and found to be free from infectious disease, and until they have undergone such preventive treatment as the medical officer of health prescribes (section 70(1)(h)).

The power to requisition premises allows a medical officer of health to requisition premises and vehicles for the accommodation, treatment and transport of patients (section 71(1)).

The closure of premises such as schools can be required under sections 70(1)(1a) and 70(1)(m). This can be made by way of written order to the person in charge of the premises or order published in a newspaper or broadcast by television or radio and able to be received by most households in the district. If specified in the order, premises operating certain infection control measures may be exempted from closure.

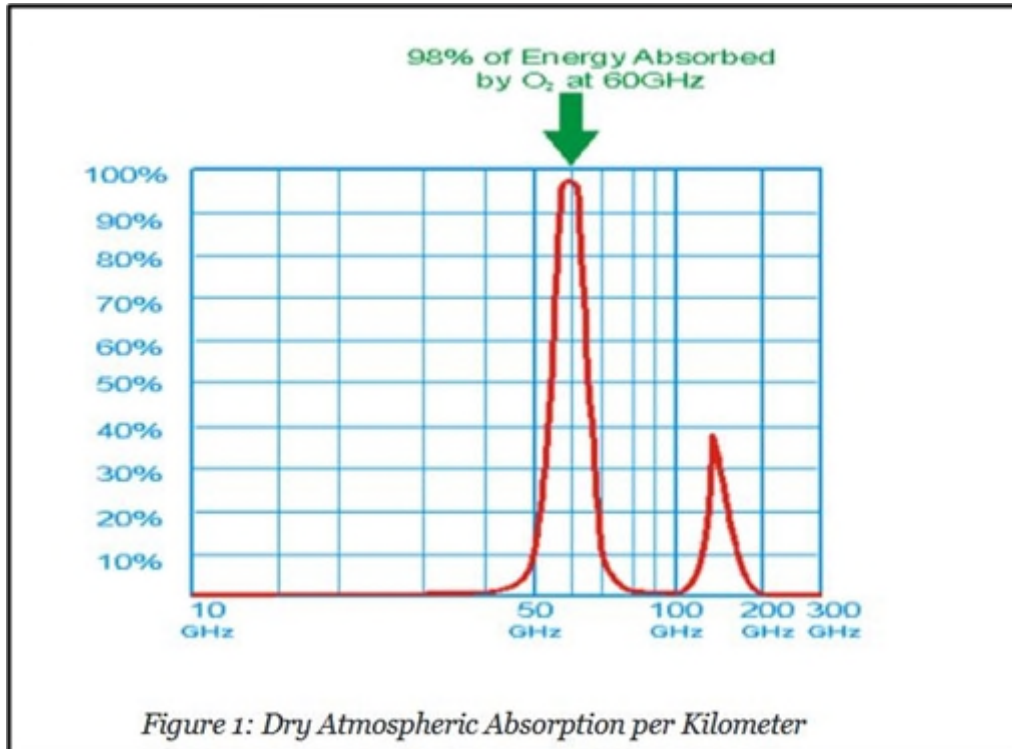
Section 71A states that a member of the police may do anything reasonably necessary (including the use of force) to help a medical officer of health or any person authorised by the medical officer of health in the exercise or performance of powers or functions under sections 70 or 71.

These special powers were used for the first time during the response to COVID-19. In general terms, they performed well. However, there were some mis-steps in their application, they lack procedural and human rights safeguards and court judgments have found that while they can be used as a stop-gap measure in emergency situations, they are not suitable for sustained, complex responses.

Impact of 60 GHz electromagnetic radiation on Oxygen

The chart above is taken from a website that promotes the use of 5G. It is intended to show the way oxygen in the atmosphere absorbs EMR in the 60 GHz waveband. The absorption rate is very high – 98 percent over a kilometer. This is why 5G networks require a high concentration of transmitters in a local area, allowing a signal to travel shorter distances and thus retain most of its original energy.

The chart also reveals – unintentionally – the impact on human health of 5G operating at 60 GHz. We all need oxygen to survive. We get this from the air around us. Our lungs use an electro-chemical process to extract the oxygen from the air and feed it into our bloodstream. This process only works correctly if the oxygen in the air is maintained within a certain temperature range. If the oxygen is greatly agitated by EMR at 60 GHz our lungs will have difficulty extracting it. Thus a burst of 5G operating at 60 GHz for 15 minutes or so could cause the rapid onset of hypoxia or oxygen deprivation. Victims asleep in its path could wake in a panic, unable to breathe. Useless immediate remedial action is taken, he or she could die.

The similarity between the symptoms of ‘Covid’ and the effect of 5G operating at 60 GHz ought to be obvious. The effect will be amplified if the victim has already absorbed, over a period of years, a large number of nanoscale particles that are sensitive to EMR.
