# Proof that the Covid-19 Pandemic is a Hoax Based on a Fake Test and Twisted Statistics

[You know how this will end. Why not speak up now?]

No matter how much information some people receive about the manipulation of public opinion by the media, they simply cannot come to terms with the possibility that those nice reporters on the television or those smart journalists in the press might be lying to them.

We are at the beginning of a severe financial crisis that will dwarf 1929. It will affect every nation on earth, but will do most damage, comparatively speaking, in the US and western Europe.

#### **Useless eaters**

In their system of accounting, a huge proportion of the population of the earth are nett consumers or "useless eaters". They are not worth keeping and need to be eliminated. They do not see this as "cruelty" – just business. As they might say in the Square Mile, 'We really need to be realistic, dear boy. We can't let the cattle reproduce ad nauseum and spoil it for the rest of us."

Their ruthlessness is abundantly evident in the following quotation from H G Wells, one of their leading theoreticians:

"And for the rest, those swarms of black, and brown, and dirty-white, and yellow people, who do not come into the new needs of efficiency? Well, the world is a world, not a charitable institution, and I take it they will have to go. The whole tenor and meaning of the world, as I see it, is that they have to go. So far as they fail to develop sane, vigorous, and distinctive personalities for the great world of the future, it is their portion to die out and disappear." - Anticipations of the Reaction of Mechanical and Scientific Progress Upon Human Life and Thought, 1902 (p.317)


The plan is simple. Reduce the population of the earth to a manageable 500 million or so. Control all reproduction. Confine the cattle to fixed zones of habitation. They will own nothing but will receive accommodation and an allowance from the state. In return they will work for and serve the Elite. Every head of cattle will be chipped at birth and monitored continuously. Disobedience will be severely punished. The state must be obeyed in all things. Men and women will be sexually modified at birth so that the natural distinction between male and female will be erased. Some cattle will undergo 'transhuman' [electro-mechanical] enhancements to enable them to perform certain functions more efficiently. At the end of its productive life, probably no more than three or four decades, each head of cattle will be terminated.

Our apologies for using the word "cattle" so many times, but it perfectly exemplifies their utter contempt for humanity. They do not see themselves as 'human' but as beings who have transcended the flesh and acquired a god-like nature. They have convinced themselves of this through their participation in vile occult rituals which open their minds to the fallen angels. [See our paper #39 on *The Externalization of the Hierarchy*.]

#### Lockdown

Up to the end of 2019, more than 99% of people living in Europe and America would have found this thesis absurd. But they have since learned that the Elite are <u>already</u> able to confine everyone to a fixed zone of habitation – and have done so in a great many countries. After the coming collapse of the world financial system, when a huge proportion of the population will have lost their livelihood and means of support (which is already the case for many in the current 'lockdown'), the state will offer a *universal basic allowance* to every adult. It will then deploy "essential workers" (recognize the term?) to provide food and services to those who are housebound. Can you see how close this emerging scenario is to the one we have already described?

We are in the throes of a World Revolution, where the Elite, by coercive means and immense propaganda, are turning normality upside down. They have "pressed the button" as it were. Decades of careful preparation have led to this moment. The house of cards which they have so patiently built up – a world economy perched precariously on a mountain of debt – is about to collapse. And when it does, very probably in the next 6-9 months, the public will place the blame squarely on the phony pandemic.

These people love the expression, "the smartest guy in the room." They get great pleasure from cheating and deceiving their victims. And there is no doubt that the best of them are very bright indeed. When it comes to exploiting the weak and vulnerable – which in practice can mean any one of us – they have no equals. Jesus was likely referring to this when he said: "And the lord commended the unjust steward, because he had done wisely: for the children of this world are in their generation wiser than the children of light." (Luke 16:8)

The unjust steward was a child of this world, one of the covetous deceivers who despise "the children of light."

#### **Organized sociopaths**

We need to recognize that these people are basically sociopathic and that a large number of them have risen to positions of great influence in society, not just in Europe and America, but all over the world. They are working together to mould a new world order where their dominance is openly visible and uncontested, where their control is absolute, and where their utter contempt for man – who was made in the image and likeness of God – can find unlimited expression.

Today (March 31, 2020) they are herding people into their homes, shutting down their places of work, severely limiting their activities, keeping their children out of school, conducting police check-points, and fining anyone who walks down the street next to another person. In some countries, such as the UK, they have introduced legislation that in practice will enable them to detain whomever they want at an undisclosed location for at least 28 days, without due process or legal representation, forcibly medicate them, and (should they decide to do so) leave them to die of dehydration. #### We're in a 'Live Exercise'

See, for example, *Targeted* (2019) by Brittany Kaiser, in which she describes the elaborate range of techniques currently being used by 'opinion formers' to influence and direct the choices made by unsuspecting Internet users, or Robert Epstein's presentation to Congress on June 16, 2019, in which he revealed just how easy it is, with the right tools and techniques, to lead Internet users by the nose – even when they <u>know</u> they are being presented with a continuous stream of biased information.

In our paper #210, *Weaving Spiders: The Illuminati are Testing the Veil* (November 17, 2019) we showed how the Elite conducted one or more exercises in 2019 to see just how "deep" a sleep the public was experiencing. Just how far "under" had they gone? Given recent events we can safely conclude that the test results were more than satisfactory.

#### Implanting a deep subconscious fear of viruses

It's nearly always a virus, not a bacterium, a fungal spore or a microscopic parasite. Ever wonder why? And it always needs a vaccine to defeat it. Ever wonder why? In most cases its causes ghastly facial sores and gruesome deformities, and sometimes turns its victims into crazy, zombie-like creatures. Anyone who has seen these movies – and nearly everyone under age 40 has seen several, some on multiple occasions – the graphic images implanted in their minds convey a stark and disturbing message: certain viruses are deadly and could kill us all; viruses mutate; their impact on our mind and body can be horrifying; there is no way to escape them; unless science finds a cure – a vaccine – we will all die.

That's a pretty strong message, is it not? It has been impressed repeatedly on the minds of young people, invariably in a setting tinged with fear and anxiety, which is why many of these movies are classified in the "horror" genre. Messages imparted in this way generally seep into our subconscious and remain intact for the rest of our lives.

On top of all these movies, there have been countless television shows and series, as well as video games and cell phone apps, featuring virus infected zombies and equally horrifying virus-driven scenarios. The message and the associated emotions are always the same – deadly virus, shriek with fear, run and find a scientist who can inject the life-saving vaccine. All of the younger generation today have been programmed with this engram, along with many in their 40s and 50s.



#### Media conditioning using 'real' events

The media conditioning over the past 40 years, supposedly based on real life events, has also been heavily infused with the spectre of viral annihilation. HIV was meant to wipe out millions of innocent people (See our paper #220). As were Ebola, SARS and MERS (Did I miss one?). Oh yes, Avian Flu, Swine Flu, and...well, you can fill in your favorite, not to mention the endless, near-hysterical promotion of annual vaccine shots to "fight" seasonal flu.

Now the big boys shout "Covid-19!" and the only deadly virus on earth – FEAR – ratchets the entire world into pandemic mode. Shriek, panic, find a vaccine! Do what mama-government tells you to do – stop working, stay home, hide under the bed.

That would never work, surely? Well, it has. What is more it will continue to run and run. This virus will never die. Just like HIV it will continue to morph into new shapes which defy the best attempts by science to wipe it out entirely. As Dr Fauci, scaremonger-in-chief to President Trump, said on 25 March: ""Would this possibly become a seasonal cyclic thing? I've always indicated to you that I think it very well might." Wow, we might run out of beds to hide under.

What is Fauci talking about? State-generated fear to control and terrify the cattle, to cause such a panic that they destroy their own economy.

But surely people are dying of Covid-19? It is perfectly true to say that people are dying in large numbers – because they always have. What these gangsters are doing is assigning the cause of death to a common Coronavirus which they are calling Covid-19. If an elderly person dies of pneumonia – which is frequently the immediate cause of death among the elderly – they are now blaming Covid-19. The victim might even test positive for the virus, since many people carry it. Or if a person succumbs to the seasonal flu, he too will be labelled a victim of the "deadly" Coronavirus, Covid-19. Just about anybody with a serious underlying health condition who tests positive for the virus (including many who don't) will be classified as "victims" of Covid-19. All one needs is a few doctors to play along, the kind that take bribes from the pharmaceutical industry. They number in their thousands and will have no problem taking even bigger bribes to sign misleading death certificates.



#### The Test is Fake

The test tells us nothing. Why? Because a large proportion of the population carry a range of Corona-type viruses. They cause the common cold, remember! What the test should measure – but never does! – is the **viral load**. This is a count of the <u>amount</u> of the virus in one's system. Only those with a high viral load are likely to develop symptoms. Even when they do, their immune system – the wonderful internal healer that God gave to each one of us – cranks up its production of white blood cells and tackles the virus. After a few days in bed, we are back on our feet and breathing the beautiful fresh air that God made.

But what about the ventilators? We need tens of thousands of additional ventilators – don't we? Well, if New York City needs them, then so too should cities all over Europe, but we don't hear of EU leaders signing industrial production orders to increase the number being manufactured. Why is that?

If 5G is being used to boost the Covid-19 numbers, which we believe to be the case, at least in Wuhan, Milan and Seattle, then the demand for ventilators will increase over time. (See our paper #222 for a discussion of this question.) But until 5G goes live in grand style across America and Europe this demand is likely to be fairly low.

We would ask readers to note that, while the whole of America was watching Covid-19 updates, President Trump signed into law a bill which will allow the implementation of 5G across the US. Its stated purpose is "maximizing the security of next generation mobile telecommunications systems and infrastructure." What most Americans do not realize is that much of this "next generation" [5G] infrastructure is <u>already</u> in place and the Act is merely giving retrospective approval to what they have already done.

The word "maximizing" says it all. This is legalese for the unlimited roll-out and implementation of 5G – in schools, colleges, hospitals, malls, libraries, public buildings, etc etc. Every street will have its own set of 5G antennas.

He signed this ominous Act into law on 23 March, known as the **Secure 5G and Beyond Act of 2020**.

#### Mothers are trying to defend their children

Many believe the lockdown is being used to install 5G antennas all across America in places which might otherwise encounter public opposition, notably schools and colleges. We <u>attach</u> for information an urgent appeal being made jointly by *Children's Health Defense*, *Moms Across America*, and *5G Free California* (**Appendix B**). It illustrates vividly just how dangerous state governors and other senior politicians have become when it is necessary to beg them <u>not</u> to irradiate our children and cause them harm. A lot of people know what is really happening but their voices are not being heard.

Every year about 2.7 million Americans DIE. If only 1% of these are ascribed to Covid-19 in 2020, which is quite easy to do using a meaningless test, then we will have 27,000 deaths due to the virus. That's a huge number of deaths, <u>real</u> deaths, but not one of them has been caused by the alleged Wuhan virus. And if one labelled all deaths from flu as Covid-19 cases, the total number of real deaths from the virus would jump to over 80,000! – and **not one** of them would be genuine as far as Coronavirus statistics are concerned. Not one.

#### The planned activation of 5G on a worldwide basis

The story will change dramatically, however, if the authorities activate 5G. When that happens, millions of people will be bathed daily in high-frequency EMR which will weaken their immune systems. This will leave them far more exposed to infection (from any source). The number of people who are officially infected with Covid-19 will shoot up. Furthermore, for the segment of the population that is subjected to 5G in the 60 GHz waveband, the health impact will be much worse. They will quickly develop serious respiratory problems and many of them will die, very likely after 2-3 weeks of agony.

There is reason to believe that the chemtrail spraying that has polluted our skies for decades may have been designed to introduce nano-size metallic particles into our bodies. These would not necessarily affect our health, assuming they remained inert, but as soon as 5G is activated at certain frequencies they will heat up or resonate because they are absorbing EMR energy. "It's not a good idea to treat a virus infection."


[The proposed vaccine for Covid-19 is not necessary and may prove harmful.]

"A positive test doesn't mean a healthy person is going to be sick."




[No proof has yet been given by the WHO or anyone else that Covid-19 causes illness in anyone. Dr Belsky makes the same point – see below.]




[Large numbers of people die every day in Italy from seasonal flu and other causes. The mortality rate was 10.5 per 1000 in 2019, or 1726 per day.]


[He says that in virtually all of the cases of 'death from Covid-19' in Italy, the true cause of death was a secondary or underlying illness.]







#### A former Vodafone employee speaks out

His message can be summarized as follows:

The Elite are rolling out 5G networks all over the world. Using the massive online inter-connectivity that this will bring, they will be able control entire populations. But they need 5G to do this. However 5G frequencies are so high (ten times more powerful than 4G) that they have a strong adverse impact on our health. Our cells accumulate poisons from the impact of electromagnetic radiation (EMR) and have to work hard to expel them from the body. This can create pronounced flu-like symptoms and produce a large number of viruses (protein fragments of RNA). The Coronavirus does not kill or harm anyone. It was invented as a deception by the Elite to mask the introduction of 5G. Wuhan was one of the first cities to activate 5G on a large scale. Then came cities in Spain and Italy. These are the places where 'Coronavirus' symptoms have been most severe. In other countries, notably Russia, where 5G is used only by the military, the incidence of 'Coronavirus' symptoms is extremely low [17 deaths, only three more than the Cayman Islands!] As more cities in Europe and America increase their use of 5G, with its extreme concentration of high-energy EMR, large segments of the population will fall ill. Many will die. In fact, millions will die. The Elite believe this is a small price to pay for the control that this greatly enhanced 'Matrix' will give them.

He warns against taking the Coronavirus test since, he believes, it is being used to introduce pathogens into the body and cause the symptoms of Covid-19. This is a way of infecting populations where 5G is not yet fully operational. The vaccines, too, which countless millions of people will happily accept, will weaken their immune systems and cause the adverse effect from 5G EMR to work even faster. They are building large makeshift mortuaries around the world to accommodate the huge influx of dead bodies.

This man is highly intelligent and a Christian. "I have never seen anything like this, anything anywhere near like this. I'm not talking about the pandemic, because I've seen 30 of them, one every year. It is called influenza. And other respiratory illness viruses, we don't always know what they are. But I've never seen this reaction, and I'm trying to understand why... I worry about the message to the public, about the fear of coming into contact with people, being in the same space as people, shaking their hands, having meetings with people. I worry about many, many consequences related to that... In Hubei, in the province of Hubei [China], where there has been the most cases and deaths by far, the actual number of cases reported is 1 per 1000 people and the actual rate of deaths reported is 1 per 20,000. So maybe that would help to put things into perspective." – Dr Joel Kettner

Professor of Medicine, of Health Research and Policy and of Biomedical Data Science, at Stanford University School of Medicine

Editor-in-chief of the European Journal of Clinical Investigation.

"Patients who have been tested for SARS-CoV-2 are disproportionately those with severe symptoms and bad outcomes. As most health systems have limited testing capacity, selection bias may even worsen in the near future... The one situation where an entire, closed population was tested was the *Diamond Princess* cruise ship and its quarantine passengers. The case fatality rate there was 1.0%, but this was a largely elderly population, in which the death rate from Covid-19 is much higher... Could the Covid-19 case fatality rate be that low? No, some say, pointing to the high rate in elderly people. However, even some so-called mild or common-cold-type coronaviruses that have been known for decades can have case fatality rates as high as 8% when they infect elderly people in nursing homes... If we had not known about a new virus out there, and had not checked individuals with PCR tests, the number of total deaths due to "influenza-like illness" would not seem unusual this year. At most, we might have casually noted that flu this season seems to be a bit worse than average." – Dr John Ioannidis

"I am deeply concerned that the social, economic and public health consequences of this near-total meltdown of normal life – schools and businesses closed, gatherings banned – will be long-lasting and calamitous, possibly graver than the direct toll of the virus itself. The unemployment, impoverishment and despair [that are] likely to result will be public health scourges of the first order." – Dr David Katz

"We have reliable figures from Italy and a work by epidemiologists, which has been published in the renowned science journal *Science*, which examined the spread in China. This makes it clear that around 85 percent of all infections have occurred without anyone noticing the infection. 90 percent of the deceased patients are verifiably over 70 years old, 50 percent over 80 years... In Italy, one in ten people diagnosed die, according to the findings of the *Science* publication, that is statistically one of every 1,000 people infected. Each individual case is tragic, but often – similar to the flu season – it affects people who are at the end of their lives." – Dr Pietro Vernazza

Former professor and director of the Institute of Medical Virology at the University of Zurich from 1993 until her retirement in 2008. Recipient of multiple honors and awards for her work.

"You are now told every morning how many SARS-Corona 2 deaths there are. But they don't tell you how many people already are infected with influenza this winter and how many deaths it has caused... This winter, the flu is not severe, but around 80,000 are infected. You don't get these numbers at all [in the media]. Something similar occurred two years ago. This is not put into the right context... Every week a person dies in Berlin from multi-resistant germs. That adds up to 35,000 a year in Germany. This is not mentioned at all. I believe that we have had situations like this several times and that the measures are now being taken too far... The disease per se is like the flu in a normal winter. It is even weaker in the first week." – Dr Karin Molling

#### **Dr Pablo Goldschmidt**



Professor of Molecular Pharmacology at the Université Pierre et Marie Curie in Paris.

"The ill-founded opinions expressed by international experts, replicated by the media and social networks repeat the unnecessary panic that we have previously experienced. The coronavirus identified in China in 2019 caused nothing less than a strong cold or flu, with no difference so far with cold or flu as we know... Respiratory viral conditions are numerous and are caused by several viral families and species, among which the respiratory syncytial virus (especially in infants), influenza (influenza), human metapneumoviruses, adenoviruses, rhinoviruses, and various coronaviruses, already described years ago. It is striking that earlier this year global health alerts have been triggered as a result of infections by a coronavirus detected in China, COVID-19, knowing that each year there are 3 million newborns who die in the world of pneumonia and 50,000 adults in the United States for the same cause, without alarms being issued... There is no evidence to show that the 2019 coronavirus is more lethal than respiratory adenoviruses, influenza viruses, coronaviruses from previous years, or rhinoviruses responsible for the common cold."

#### SAMPLE LETTER

Dear Governor Newsom,

Please Do Not Deploy 5G / Intensify Wireless Installations in Our Schools During Quarantine and at any time thereafter.

While I appreciate your leadership on COVID-19, I am writing to express my objection to your intention to intensify the wireless infrastructure in schools using the COVID-19 quarantine as the basis for your request, as was announced last week by your office. Further deployment of harmful wireless infrastructure in our schools is taking the wrong leadership path and will cause further and even irreparable harm to our children.

As Mayor of San-Francisco, you have shown rare leadership when you called out the telecom companies' fraud. Since then, the evidence of harm has become clearer. Most recently, The recent Federal government's *National Toxicology Program* study found CLEAR EVIDENCE that this radiation causes cancer and breaks DNA. Thousands more studies proved profound harms from wireless technology radiation.

In 2018 the *CA Dept of Public Health* published guidelines admitting that peer reviewed scientific studies show evidence that this radiation may cause DNA damage, reproduction harms, cancer and learning disabilities among other effects. How come you deploy more wireless in school to improve learning when the evidence is showing it is harming learning?

In 2014, the *CA Medical Association* passed a resolution calling on the FCC to update its health guidelines as the scientific evidence shows profound harms. On February 2, 2020 the *Children Health Defense* submitted a lawsuit in the US Court of Appeals of the Ninth Circuit, against the FCC, challenging its decades' obsolete health guidelines. Among the petitioners are parents of children from CA who have become sick from cell towers and wi-fi in their schools and doctors attesting to the epidemic they see in their clinics including among children.

Government Code Sec. 659641.1(f) gave a special exemption from mandatory approval of wireless siting applications for wireless telecommunications facilities on fire department facilities. This was passed out of concern regarding firefighters' exposure to harmful radiation. Why are we protecting firefighters but harming our children?

Further, peer reviewed scientific studies have shown that the radiation emitted by wireless technology, adversely affects the immune system. In a time when we try to prevent pan-epidemic and need to strengthen our immune system, we should encourage the population, and especially our children who are a vulnerable population, to reduce their exposure to this harmful radiation rather than force more of it.

We asked you not to allow any further deployment of harmful wireless infrastructure during the schools' shutdowns or over Spring Break on school campuses across our state. We ask you to prevent telecom companies from deploying 5G "small cell" antennas or "Hot-Spots" under the false pretense of improving technology for learning. Any further upgrades should be with wired ethernet cables, which provide faster, safer, more secure and more reliable service.

Considering the clear evidence of potential harm to our children from this radiation, we do not consent to any further expansion of wireless emitting devices in our California schools. Education Code Sec. 51101(a)(7) grants the right for parents to ensure that the school environment for their child is safe. Exposing children to this radiation, especially over the objection of the parents and children, directly violates the schools' duty to provide a safe environment and our right to ensure they do. We ask for you to cease and desist any further installations. The radiation batters the children and violates their civil rights and our parental rights.

Furthering the deployment of more wireless when the scientific and human evidence of harm are clear, is being on the wrong side of history. We know that considering the power of the Telecom industry, leading on this issue takes courage. You have shown you have the courage – and **there is no more important time to continue to show this courage than with protecting the health of our children, including your own**.

California parents, and parents across the country, will remember that Governor Newsom stood up to the corporations and put the safety of our children before corporate profits.

If so, which schools and which types of technology changes?"

#### Also inform them that you are interested in being kept informed should the school decide to introduce such installations.

Please also state the following:

Considering the clear evidence of potential harm to our children from this radiation, we do not consent to any further expansion of wireless emitting devices in our California schools. Education Code Sec. 51101(a)(7) grants the right for parents to ensure that the school environment for their child is safe. Exposing children to this radiation, especially over the objection of the parents and children, directly violates the schools' duty to provide a safe environment and our right to ensure they do. We ask for you to cease and desist any further installations. The radiation batters the children and violates their civil rights and our parental rights.

Please cc us in your email to your school with **CA.Safe.Children@childrens healthdefense.org** so we will be aware of your communication with them. If they do not cc us in their response, please forward us their response.

Please respond to us by email with California school responses, school name, city and state to: **CA.Safe.Children@childrenshealthdefense.org** within 48 hours, preferably, to have your school district be supported by our teams. The timing is urgent! Technology upgrades have been planned for Spring Break!

If you do not live in California, but have friends in California, please share this information with them. Also please take action in your state and find out what their plans are! Now is the time!
