# Rockefeller Report of 2010 Proves the 'Pandemic' was Planned

## **Mental paralysis**

The world is heavily sedated by incessant propaganda, with wall-to-wall images of death and disease and a lexicon of depressing terms designed to paralyze our mind. In a sense the "cattle" are being hit with a stun-gun. The remorseless nature of this dark propaganda is sapping the strength of anyone – ANYONE – who is foolish enough to sit down and soak it all up.

The Elite have been planning this attack for decades, the first in a series of deadly blows intended to bring down ("transform") western civilization. A seasonal flu has been turned into a raging pandemic. How? By countless lies, tricks and deceptions. [See our papers #222, #223, and #224] The consequences of this insane lockdown, which has no medical justification, will be far, far worse than the alleged disease:

[The government's anti-COVID19 measures] are grotesque, absurd and very dangerous ... The life expectancy of millions is being shortened. The horrifying impact on the world economy threatens the existence of countless people. The consequences on medical care are profound. Already services to patients in need are reduced, operations cancelled, practices empty, hospital personnel dwindling. All this will impact profoundly on our whole society. All these measures are leading to self-destruction and collective suicide based on nothing but a spook." — <u>Dr Sucharit Bhakdi</u>, specialist in microbiology and one of the most cited research scientists in German history; former professor at the Johannes Gutenberg University in Mainz, Germany; former head of the Institute for Medical Microbiology and Hygiene.

If you doubt whether this is really the case and have not yet come to terms with the material laid out in our recent papers on this topic, then maybe the following piece of concrete evidence will help to convince you.



#### The Rockefeller Foundation

We wish to highlight a report published in May 2010 by the Rockefeller Foundation – one of the main funding agencies for the New World Order – which examined the future use of technology on the world stage. The report was titled, **Scenarios for the Future of Technology and International Development**.

Any time these people use the term "international development" they mean the imposition of their ideas on sovereign nations.

The report carried out its examination by envisioning four future scenarios, where the outcome in each case is largely determined by political factors and the attitude generally toward new technology.

This report was produced by The Rockefeller Foundation and Global Business Network.

One of these scenarios was called 'Lock Step'. This envisaged a world where traditional liberties had disappeared and countries were subject to authoritarian control. This is another way of describing a nation under totalitarian government, which is well expressed by the term 'lock step' – the name they have chosen for this scenario:

LOCK STEP - A world of tighter top-down government control and more authoritarian leadership, with limited innovation and growing citizen pushback

pushback = resistance, negative reaction

The term **lock-step** is defined in most dictionaries as a way of marching where each person is as close as possible to the one in front. In other words, <u>total obedience</u> by the masses to a ruling authority. This is closely related to another word that has become familiar to everyone in recent weeks – **lockdown** – which means the confining of prisoners to their cells. Yes, it is a term closely associated with crime and punishment, where the prisoners are compelled by their guards to remain in their cells 24 hours a day.

This is how the Elite view the cattle. At present they are being kept in quarantine until they are branded. This will likely involve some form of electronic identification or tag which will show who has received the vaccination and store related details [See their reference below to "biometric IDs for all citizens"]. Anyone without this universal ID will be kept in quarantine or given only a limited sphere of activity.

#### **Scenarios**

Here is how the report defines a scenario:

Scenarios are a medium through which great change can be not just envisioned but also actualized. The more closely you read them, the more likely it becomes that you will recognize their important but less obvious implications to you, your work, and your community.

The words "but also actualized" say a great deal. The Rockefeller gang are not simply envisioning a possible future for humanity but one which, in whole or in part, will become actualized. In short, each of the four scenarios contain elements of the future which the Elite have planned for mankind and which they intend to implement.

They expand a little on this definition in the following screenshot from their report. Note the time period they are working within, namely 15-20 years following publication.


#### THE SCENARIO NARRATIVES

The scenarios that follow are not meant to be exhaustive—rather, they are designed to be both plausible and provocative, to engage your imagination while also raising new questions for you about what that future might look and feel like. Each scenario tells a story of how the world, and in particular the developing world, might progress over the next 15 to 20 years, with an emphasis on those elements relating to the use of different technologies and the interaction of these technologies with the lives of the poor and vulnerable.

By the way the "poor and vulnerable" in the above excerpt are the entire population of the earth, the "cattle" who must be coralled, branded and culled:

#### The 2020 pandemic was a central part of the Lock Step scenario

We now come to the proof mentioned in the title of this paper. We will confine ourselves to a few short comments since their own text – given in <u>screenshot form</u> – speaks volumes.

# Ι

## [The pandemic finally arrives and streaks around the world]

In 2012, the pandemic that the world had been anticipating for years finally hit. Unlike 2009's H1N1, this new influenza strain - originating from wild geese - was extremely virulent and deadly. Even the most pandemic-prepared nations were quickly overwhelmed when the virus streaked around the world, infecting nearly 20 percent of the global population and killing 8 million in just seven months, the majority of them healthy young adults. The pandemic also had a deadly effect on economies: international mobility of both people and goods screeched to a halt, debilitating industries like tourism and breaking global supply chains. Even locally, normally bustling shops and office buildings sat empty for months, devoid of both employees and customers.

The pandemic, as we know, "finally hit" in 2020. Virulent and deadly, the virus "streaked around the world."

The pandemic wrecked economies. "International mobility...screeched to a halt." Lockdown!

Shops that were normally busy "sat empty for months, devoid of both employees and customers."

It was all planned!

## II

## [Mandatory quarantine for all citizens]

The pandemic blanketed the planet – though disproportionate numbers died in Africa, Southeast Asia, and Central America, where the virus spread like wildfire in the absence of official containment protocols. But even in developed countries, containment was a challenge. The United States's initial policy of "strongly discouraging" citizens from flying proved deadly in its leniency, accelerating the spread of the virus not just within the U.S. but across borders. However, a few countries did fare better—China in particular. The Chinese government's quick imposition and enforcement of mandatory quarantine for all citizens, as well as its instant and near-hermetic sealing off of all borders, saved millions of lives, stopping the spread of the virus far earlier than in other countries and enabling a swifter postpandemic recovery.

Note how the Chinese are praised for their strict containment strategy.

The "enforcement of mandatory quarantine for all citizens" is summed up today in the word lockdown!

The report identifies lockdown as the best way to deal with the so-called pandemic. Even though it purports to be scientific the report ignores the devastating human cost of a worldwide lockdown.

# III

#### [Authoritarian control imposed by law and retained indefinitely]

China's government was not the only one that took extreme measures to protect its citizens from risk and exposure. During the pandemic, national leaders around the world flexed their authority and imposed airtight rules and restrictions, from the mandatory wearing of face masks to body-temperature checks at the entries to communal spaces like train stations and supermarkets. Even after the pandemic faded, this more authoritarian control and oversight of citizens and their activities stuck and even intensified. In order to protect themselves from the spread of increasingly global problems - from pandemics and transnational terrorism to environmental crises and rising poverty-leaders around the world took a firmer grip on power.

The lurid "mandatory wearing of face masks" gets a prominent mention. The psychological impact of this measure is considerable. We expect Trump to impose this very shortly.

They refer to the increased "authoritarian control and oversight [surveillance] of citizens." Laws enabling this will be retained after the so-called pandemic, and will even be "intensified."

# IV

## [Biometric IDs for all citizens; loss of sovereignty and privacy]

At first, the notion of a more controlled world gained wide acceptance and approval. Citizens willingly gave up some of their sovereignty - and their privacy-to more paternalistic states in exchange for greater safety and stability. Citizens were more tolerant, and even eager, for top-down direction and oversight, and national leaders had more latitude to impose order in the ways they saw fit. In developed countries, this heightened oversight took many forms: biometric IDs for all citizens, for example, and tighter regulation of key industries whose stability was deemed vital to national interests. In many developed countries, enforced cooperation with a suite of new regulations and agreements slowly but steadily restored both order and, importantly, economic growth.

They even have the audacity to spell out the specific methods of control which they plan to impose, such as biometric IDs for all citizens and tighter regulation of key industries. In other words far greater control over citizens and businesses.
