

Suddenly – USA

In a previous paper (#340) we looked at obituary notices in Ireland which included the words “suddenly” or “unexpectedly.” As we noted, the incidence of those words has increased dramatically since the introduction of the Covid-19 ‘vaccines’.

This is a statistically reliable way of demonstrating that the ‘vaccines’ – which are not vaccines at all – are implicated in some way in the increase in all-cause mortality. The deaths in question, as “all-cause” implies, are due to a multiplicity of factors, whether health-related or accidental, and do not necessarily involve a respiratory illness.

One of the most disturbing aspects of this trend – the increase in “excess deaths” or deaths in excess of the long run average – is the extent to which it is manifesting among young people. Until very recently, it was unusual to hear of healthy young men or women in their 20s, 30s or 40s dropping dead “suddenly” or “unexpectedly”.

While obituaries do not give the cause of death, it is widely believed that they are due in the main to blood clots, strokes or heart attacks. However, establishing this with certainty would require closer involvement by the medical profession. Unfortunately this profession has continued to disregard the increase in excess deaths and refuses to view it as a matter of concern.

There are no reports in the media to indicate that politicians are taking the matter seriously or that the studies needed to determine what exactly is happening are being undertaken.

Our previous paper drew its data from the national online obituary archive, RIP.ie, which is kept up to date by undertakers. It is considered so reliable that the national statistics office in Ireland, the CSO, make regular use of it. We noted that other countries do not appear to have a similar national archive of all death notices. This may explain why reports from other countries, where they exist, are mainly anecdotal and of little value for statistical purposes.

A newly discovered source of valuable data

Where the US is concerned, however, this changed in 2023 when an astute analyst found an online data tool embedded in a nationwide obituary website (*legacy.com*) and used it to filter obituaries with the keywords “suddenly” or “unexpectedly”. The tool enabled him to filter the file further, by date and state.

According to Wikipedia, this massive archive is world's largest commercial provider of online memorials:

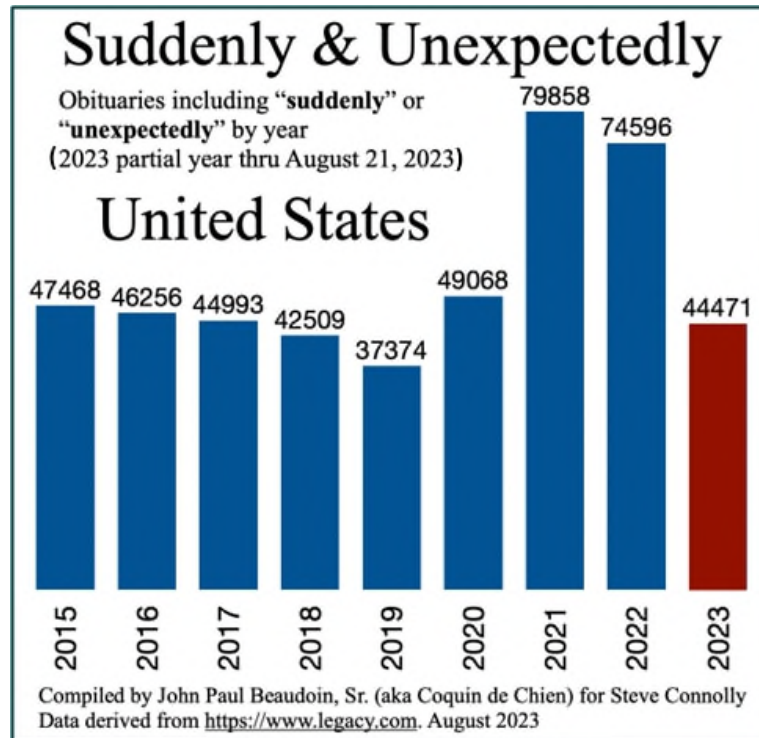
Legacy.com is a United States-based website founded in 1998, the world's largest commercial provider of online memorials. The website hosts obituaries and memorials for more than 70 percent of all U.S. deaths. *Legacy.com* hosts obituaries for more than three-quarters of the 100 largest newspapers in the U.S., by circulation. The site attracts more than 30 million unique visitors per month and is among the top 40 trafficked websites in the world.



We can see that *legacy.com* does not have 100 percent coverage of all deaths in the US (unlike its Irish counterpart), but the fact that it covers all states and provides 70 percent coverage overall means that any trends it identifies will be statistically significant.

The analyst then created a spreadsheet and populated it with the number of obituaries containing the words “suddenly” or “unexpectedly” for every US state for each year, 2015 to 2022 inclusive, plus the current year (2023) to 21 August.

Here is the bar chart for the US as a whole over this period:

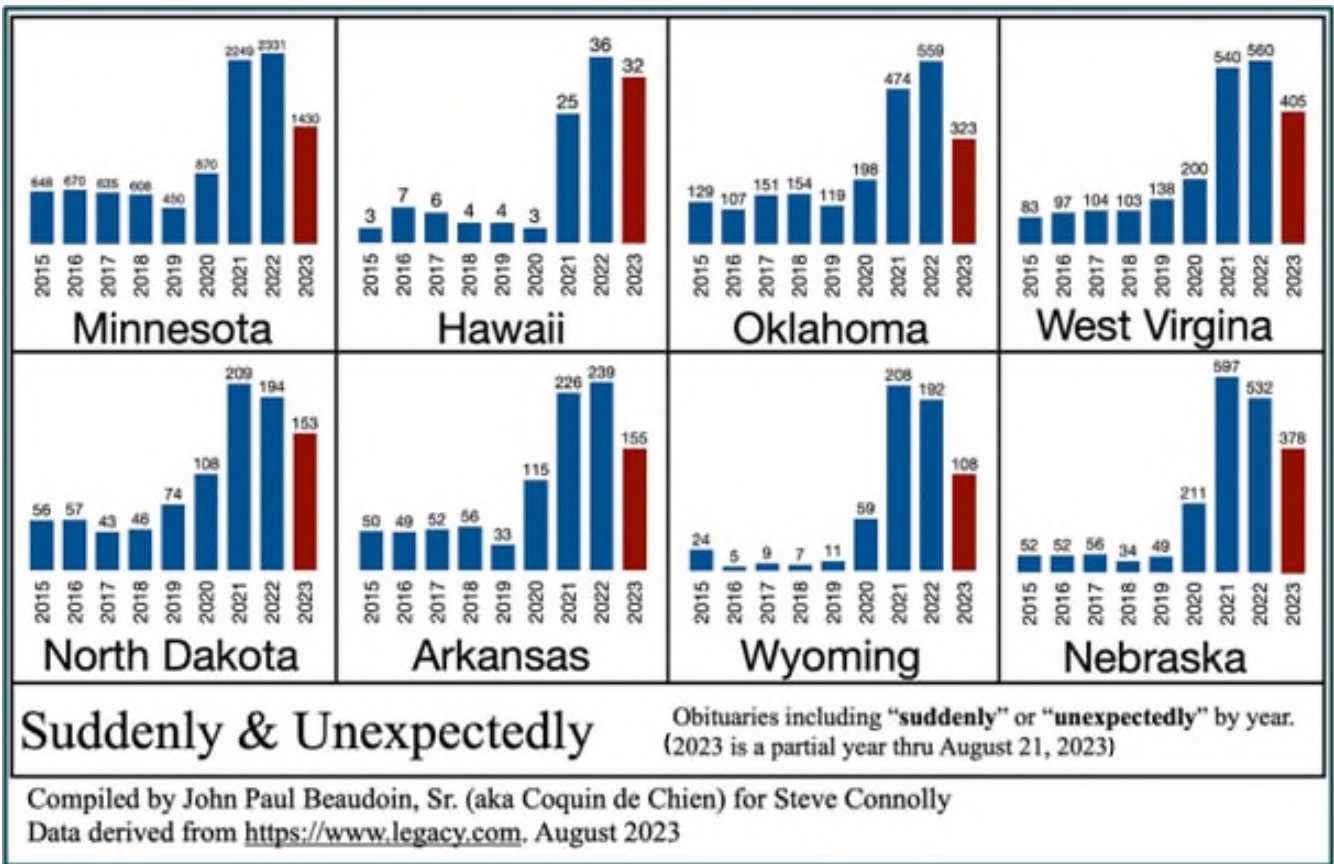
The average for the five year period 2015-2019 was 43,720. Compare that with the average for the two-year period 2021-2022 plus the part-year 2023 when the Covid ‘vaccines’ were being liberally injected across the US – 74,706 (We used a pro rata figure for 2023). That’s a difference of 30,986, representing a phenomenal increase of about **71 percent**.

If we apply this increase to all obituaries in the US, and not just the 70 percent covered by *legacy.com*, we arrive at an estimated number of excess deaths in the category “suddenly/unexpectedly” of around 44,000.

This is a remarkable and deeply troubling statistic. It is saying that every year in the US at least 44,000 people are dying prematurely following the introduction of the Covid ‘vaccines’. We are not counting other premature deaths caused by the ‘vaccine’ where the circumstances in each case did not prompt the inclusion of the words “suddenly” or “unexpectedly” in their obituaries. Thus – as we shall shortly demonstrate – the true figure is certain to be considerably greater than 44,000.

The statistics for rural states are even more shocking

The statistics for states with rural or widely dispersed populations are even more incredible:



Consider those for Wyoming. In 2019 only 11 obituaries across the state, recorded by *legacy.com*, included the words “suddenly” or “unexpectedly”, but it jumped to 206 in 2021! That is an 18-fold increase. The corresponding figures for Nebraska showed a 12-fold increase.

The average increase for these 8 states was 5-fold. Clearly something has gone seriously wrong.

Only a criminal regime would ignore this crisis

We don’t know from these figures whether this trend will continue. We do know, however, that it is unprecedented and ought to be investigated by the medical authorities without delay. We say this solely on the basis of the 44,000 excess deaths already noted. However, as we shall see, the actual number is far greater than that.

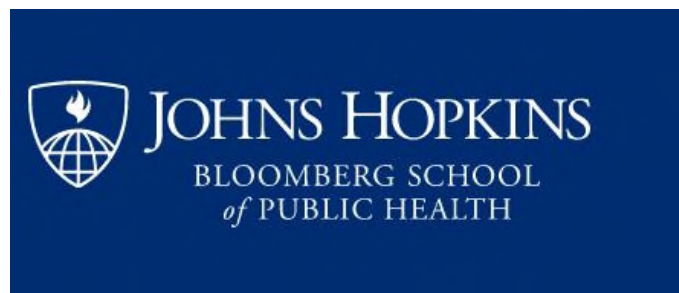
This data should be considered in conjunction with published studies which show that the Covid ‘vaccines’ are a proven cause of myocarditis, plus statistics which indicate that the birth rate is falling and that the number who are leaving the workforce due to ill health is rising sharply. Whistleblowers in the Department of Defense have released reports extracted from the comprehensive DOD health database which show that the incidence of certain kinds of illness among military personnel has increased significantly since the Covid ‘vaccines’ were administered.

The onset of a wide spectrum of illness types among relatively young people who were in good health when they received the ‘vaccine’ would suggest that the ‘vaccine’ is causing an autoimmune reaction or interfering in some way with the effective functioning of their immune system.

We are witnessing a public health crisis which the CDC, the FDA and other agencies under the control of the pharmaceutical industry are refusing to acknowledge.

The unfolding threat

Even worse, they are trying to keep the Covid hoax going by treating it as a recurring illness like influenza – which is pretty much what Covid is, namely influenza under another name. In this way they intend to turn the shot into an “annual vaccination”! Since we already have hard evidence that the original Covid ‘vaccine’ was harmful, it would be criminally irresponsible to introduce a new one. Please note that the FDA is admitting that the 2023 “booster” is not a booster at all but a completely new ‘vaccine’. They say the new ‘vaccine’ is not just boosting existing immunity allegedly obtained from the original Covid injections but building a NEW immune response to variants that are currently circulating. The screen shot below from *Johns Hopkins*, dated 14 September 2023, spells this out very clearly:



Is the new vaccine considered a “booster”?

The FDA has shifted from calling this a booster to calling it an updated COVID vaccine. The change in wording reflects that we’ve begun treating COVID like we treat influenza, with annual vaccination. We encourage people to get their “annual flu shot” not a “flu booster.” Calling it an updated COVID vaccine also reflects that we’re not just boosting existing immunity from previous vaccination; rather, the vaccine builds a new immune response to variants that are currently circulating.

This is a startling admission! The authorities say they intend to develop a new ‘vaccine’ every year and to encourage the population as a whole to avail of it as they would “an annual flu shot.” The CDC has moved from a one-time emergency response to a supposed pandemic using a novel experimental injection to the annual use of a similar emergency-type product where no pandemic exists. This is not medicine at all but a mass experiment on the human population.

The actual number of annual excess deaths in the US

The table below is taken from the chart of “Excess Deaths” maintained by the OECD in respect of member countries. This table covers excess deaths in the US from week 13 to week 30 inclusive in 2023. The number of excess deaths in each week is shown in the middle column, while the righthand column shows the percentage by which the excess deaths in the middle column exceeds the long-run average for that week in previous years.

This 18-week window into excess deaths in the US ought to be a matter of great concern. To begin with the statistics, which are supplied by the Federal Government, are official and undisputed. They show a consistently positive increase in excess deaths in every week over this period, a pattern that commenced in early 2021 and has shown little variation. One would normally expect some weeks to show a positive (above average) increase, and others to show a negative (below average) decrease. But they don't. Instead they reveal an increase running consistently between 7.3% and 11.4%. The average is 9.3%.

During the 18 week period that we are examining, a total of 87,000 Americans died who, according to historical patterns, should still be alive. In a real medical sense, these deaths are unexplained.

The dark picture emerging from the OECD statistics

If we extrapolate from the average of 9.3 percent, the estimated total of “excess” (or medically unexplained) deaths in all 50 states for the year 2022 as a whole was around 304,000. Some medical observers had been predicting in 2021 that the “excess” deaths in 2022 due to the ‘vaccine’ could be as high as 300,000. It seems they were right.

In statistical terms this is highly significant since it indicates that a common health-impairing factor is at work across the country as a whole and that it began to take effect in early 2021. What is this factor? Well, that is something the government ought to be investigating as a matter of urgency. (Our common sense tells us that the Covid ‘vaccines’ are the only nationwide health-related candidate over this period.)

We would suggest that readers who doubt the validity of these statistics, or have difficulty accepting that this health crisis is a worldwide phenomenon that commenced in early 2021, should visit the OECD website (link above) and see just how many countries are experiencing a marked increase in excess deaths.

By the way, the OECD spreadsheet is not well known and is never mentioned in the mainstream media. Also, it appears to be designed to frustrate the average user and to conceal the precise time period to which the data relate.



CONCLUSION

The statistics on obituaries which recorded the circumstances of death as “suddenly” or “unexpectedly” showed that at least 44,000 Americans are dying every year from the Covid ‘vaccine. However, the OECD figures reveal that the true number is far greater, at over 300,000. The difference is likely due entirely to the omission from relevant obituaries of the words “suddenly” or “unexpectedly”. For example a person whose bowel cancer, liver cirrhosis or renal deterioration accelerated dramatically after he or she received the ‘vaccine’ would not normally be recorded as a sudden or unexpected death.

We can see from these figures that the Covid ‘vaccines’ are emphatically NOT SAFE. Indeed, this assessment does not go far enough. The ‘vaccines’ are actually dangerous and should be withdrawn immediately until such time as a thorough independent investigation of this health crisis is carried out.

Please bear in mind, also, that our evaluation of the ‘vaccine’ and its effects is not linked solely to deaths resulting from ‘vaccine’ harm, but to the – as yet unquantified – millions of cases where the ‘vaccine’ did not result in death but caused significant harm to the health of the individuals concerned.

The release of a new ‘vaccine’ at this time is utterly insane. Only a Satan-inspired clique could contemplate such a criminal act. They even appear to be mocking their intended victims. On 13 September 2023, *Newsweek* carried an article on the proposed new ‘vaccine’ which stated: “Preliminary tests conducted by Pfizer in June 2022 were done on eight mice. The actual number of mice involved in the recent trials is unclear.”

The conduct of the CDC, the FDA and Johns Hopkins in this matter is obscene. How can any responsible regulatory authority, when discussing the safety of a highly experimental ‘vaccine’, developed at short notice, deem it appropriate to allay concerns about safety by referring to its impact on 8 mice? In doing so they are showing nothing but contempt for the public, a sickening indifference to the magnitude of the issues involved and their potential implications for the health and well-being of tens of millions of people.
