

The Coming World Tyranny will be Based Initially in Geneva

They will turn once again, tearfully and fearfully, to their respective governments, begging for protection.

The mainstream news will broadcast over and over the same perverted lottery-like slogan, “It could be you!”

Their political leaders know that they will have carte-blanche to do “whatever it takes” to tackle this invisible scourge, and millions will line up to receive the next untested, unproven, and unethical life-saving ‘vaccine’.

They will gladly, avidly, and with hysterical zeal submit to whatever regulations the governments impose, such as pandemic passports, mask wearing, hand washing, remaining six feet apart, sitting impatiently at home, and ...waiting. Why we didn't see it coming

Those who have been warning of the coming ‘New World Order’ never seriously believed the Elite would try something like this. The public are not *that* gullible, they reasoned. The trick is to keep telling everyone the same lie, over and over, loudly and insistently, and warn of baleful consequences for those who don't believe it.

Taken together, fear and deception are a potent narcotic.

The Elite also had a powerful diagnostic tool at their disposal. They could analyze the vast quantity of soft data online which reveals the fears, attitudes, opinions and beliefs of billions of people. This opened an exceptionally large window on mass psychology and human behavior.

In addition, a close study of the public response to earlier ‘pandemic’ threats, notably the SARS-1 outbreak of 2003 and the H1N1 scare of 2009, would have allowed key behavioral factors to be identified. They could predict, with a high degree of accuracy, how submissive, credulous and compliant the public would prove to be when faced with a major ‘pandemic’ threat backed up by intense pseudo-scientific propaganda, phony tests, and life-threatening rhetoric from our respective governments.

Given these factors, it is easier to understand why a psychological operation of this magnitude had a high probability of success. What is less clear is why it should continue to exercise such a powerful grip over the minds of billions of people more than two years later.

Clearly, in our fallen human condition, despite our ability to think rationally and weigh the evidence before us, mankind is still vulnerable to cunning manipulation. What we are witnessing today is misplaced trust on a massive scale, a universal refusal to believe that our governments could work together in secret to implement a plan which could undermine our whole way of life.

The next phase in the great pandemic deception

This introduction may help us to see more clearly how the next phase in the great pandemic deception is likely to play out. To this we can add the many strange events that are now unfolding around the world. These include

1. The truly bewildering situation in Shanghai, where 25 million people are being confined full-time in their homes on the pretext that a deadly plague is raging. We are led to believe that the pathogen is ‘Covid-19’ but this is uncertain. Whether or not other Chinese cities are being subjected to the same barbarous treatment is also unclear.

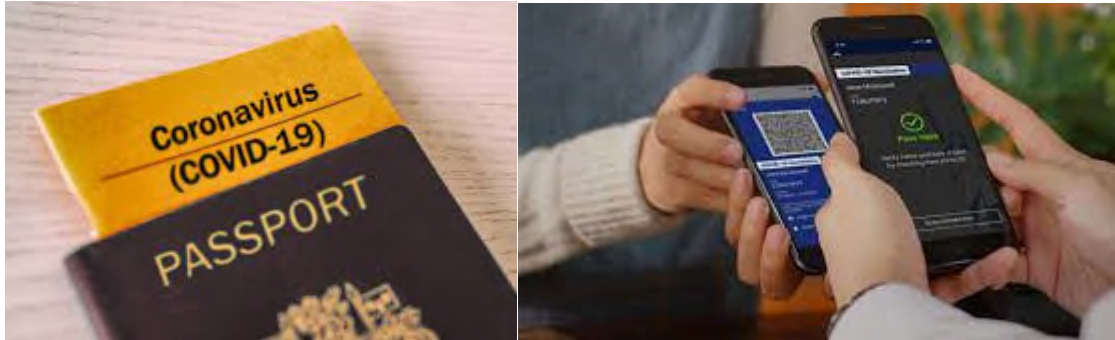
There are numerous reports of severe food shortages in the city and brutal treatment for anyone who dares to defy the official policy. Given that one of the five members of the elite UN Security Council can pursue this vicious policy with impunity is proof – if proof were needed – that the UN itself will countenance similar brutality in other countries if it ever deems such steps are necessary to combat a deadly plague. Of course, we know a genuinely deadly plague is not needed to trigger such drastic action; a shallow, unsubstantiated report by a few eminent ‘scientists’ is sufficient reason to lock down 25 million people. In short, medical disinformation is being used once again as a pretext for tyranny.

2. The various adverse event reporting systems (VAERS in the US, Yellow Card in the UK, and EUDRA in the European Union) show that the total number of deaths and serious adverse events officially attributed to the Covid-19 ‘vaccine’ to date far exceeds the total arising from all other vaccines combined over the past thirty years. One would expect such alarming statistics to bring the ‘vaccine’ program to a screeching halt and to institute an urgent statutory review in all western countries into the safety of these so-called vaccines (We already know their efficacy is zero). But this has not happened, and it won’t happen, because these so-called vaccines – both those already administered and those yet to be distributed – are part of an insidious plan to subjugate and transform western society. The failure to openly address the harm caused by the ‘vaccines’ is proof that they are part of a larger program and that they will continue to be used.

3. The attempts to date to impose a vaccine passport system in several countries and to make vaccine compliance a mandatory condition for participation in normal society is further proof that bogus medical science is being used to transform society. We can expect this to continue, with legal enforcement taking the place of intimidation and coercion. This will necessitate the introduction of international legal powers of sufficient force to override the reservations of sundry sovereign states and their uncooperative citizens.



4. The oft-stated intention by the international banking cartel to introduce a digital currency – an online payment and accounting system for all financial transactions – complements perfectly the digital ID and vaccine passport system envisaged by the medical moguls. Both can use the same technology. Data is simply data, whether it is medical, financial, commercial, academic, statistical, or media-related. It makes no difference. And since most of the adult population in developed economies already own a smart phone – a highly sophisticated mass communication and data transmission device – the infrastructure needed to support this new technocratic social order is already in place. The only missing element is a legal means to enforce it across all nations.

This brings us to the steps that are being taken to impose this legal mechanism.

The legal mechanism that will be used to enforce compliance

The plan that the Elite are following is outrageous but it will likely be implemented with little or no opposition because the parties to the plan – the governments of 194 countries – have long ago agreed to support it. The public is only now getting to see the final phase of a program that was formulated decades ago, a program which envisages the transfer to an international agency of executive powers which are normally exercised only by sovereign states.

We have seen countless examples of the way such powers have been “appropriated” bit by bit in recent decades by organizations like the United Nations and the European Union, but this is the first time that an international agency will be able to decide and enforce by law a set of procedures affecting “**all nations, and kindreds, and people, and tongues**” (Revelation 7:9).

There will be no intermediary parliamentary evaluation or approval by any country of the measures decreed by the agency. While national parliaments may have a say in the way the procedures are applied locally, they will not be able to mitigate their legal force or limit their application.

The agency chosen by the Elite to play the role of proxy world government is the World Health Organization (WHO), which has its headquarters in Geneva. Thus, on paper at least, its Director-General, Tedros Adhanom Ghebreyesus, will become the first person in history to exercise legal authority over every person on earth.

Think about it! By any reckoning this is a milestone in Bible prophecy and a clear sign that the End Time events foretold in God's Holy Word are coming rapidly into view.

The Background

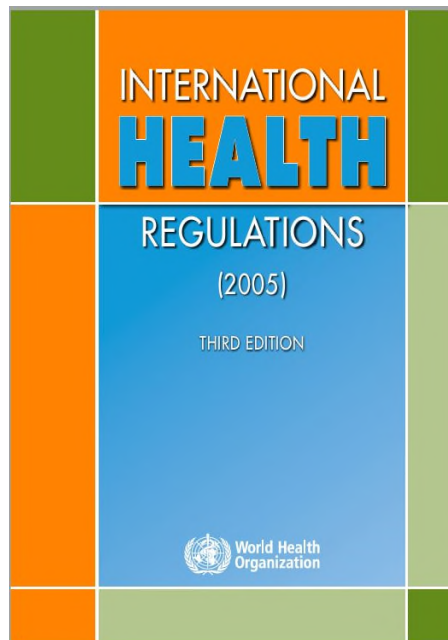
We will look briefly at the institutional steps that were taken to create this proxy for world government.

The main document that nations are following is the IHR (International Health Regulations) which were adopted in 1969. Prior to that they had followed the International Sanitary Regulations which were adopted by the World Health Assembly in 1951. They were designed to tackle and contain infectious diseases known to be dangerous to human health. These were defined by name: yellow fever, bubonic plague, and cholera. The important category known as "quarantinable diseases" was revised in 1973 and 1981.

Up to this point the long-term strategy being followed by the Elite was not easy to discern. This changed dramatically in 2003 with the phony SARS outbreak (SARS means 'severe acute respiratory syndrome'), an event that was designed to trigger the expansion and enhancement of IHR powers.

**“The proud have hid a snare for me, and cords;
they have spread a net by the wayside;
they have set gins for me. Selah.”
-Psalm 140:5**

The SARS outbreak was a grossly exaggerated event, distorted out of all proportion by the world media. The disease itself, if it existed at all, was only a variation of related ‘respiratory syndromes’. In reality it was no different from pneumonia. At this end-of-life stage, the patient’s immune system is so weakened that a bout of pneumonia will generally prove fatal. The proximate cause of death was pneumonia but the true cause was a serious underlying condition. In short, they died from a pre-existing disease, not pneumonia.

The number of deaths attributed to SARS worldwide was miniscule – just 774. In fact, it is doubtful whether any of these cases were bona fide ‘SARS’ deaths since the methodology used to identify them was not very convincing. In addition, there was little or no hard evidence that the pathogen was transmissible. Thus, the public was asked to believe that a new, highly contagious, deadly disease had emerged and that, unless immediate measures were taken to contain it, the pathogen could end up posing a pandemic threat to mankind.

The SARS ‘outbreak’ was an engineered event, a choreographed hoax designed to frighten the world into accepting the need for greater centralized powers to tackle future serious outbreaks. As the World Health Organization stated in the Foreword to the third edition of the IHR in 2016:

“[on foot of] the momentum created by the emergence of severe acute respiratory syndrome (the first global public health emergency of the 21st century), the Health Assembly established an Intergovernmental Working Group in 2003 open to all Member States to review and recommend a draft revision of the Regulations to the Health Assembly. The IHR (2005) were adopted by the Fifty-eighth World Health Assembly on 23 May 2005 . They entered into force on 15 June 2007.”

Two major innovations

The revised IHR of 2005 contained two notable innovations, both of which enabled the WHO to shut down the world in 2020. The first was a major departure from the traditional focus on known quarantinable diseases which were highly contagious and which had already caused a significant number of deaths in the region where the outbreak occurred. The scope of the regulations was no longer limited to any specific disease or manner of transmission but would cover “illness or medical condition, irrespective of origin or source, that presents or could present significant harm to humans.” There was now no theoretical limit to the number of diseases, or supposed diseases, that the regulations could cover, nor was there any need to demonstrate that the disease had already caused significant harm to humans before declaring a pandemic emergency.

The other major innovation was the special power now vested in the Director-General of the WHO to declare a “public health emergency of international concern” [PHEIC, to rhyme with ‘fake’] and to issue “recommendations” which member states were advised – but not obliged – to follow.

Despite the draconian nature of the controls imposed on western nations by their respective governments in 2020, which were based on the Covid-19 “recommendations” issued by WHO, the Elite want even tighter control over and greater uniformity in the way countries respond. This would include the power to make vaccines mandatory, to track vaccination history in real time, and to require that everyone be assigned a digital ID and carry a vaccine passport.



The Presidents of the US and the EU betray their citizens

On 14 April, 2021, the American magazine *Foreign Policy* – a mouthpiece for the Council on Foreign Relations – carried a Covid-19 opinion piece which stated:

“The current public health regime has no way to sanction noncompliance with international agreements and reporting requirements other than naming and shaming the offending states. That this falls short should be obvious by now... To ensure any future pandemic treaty has the teeth to do its job, the international community needs to err on the side of more authority, not less; more independence, not less; more audacity, not less.”

Many similar recommendations, calling for greater centralized control, were made by experts, academics and journalists working for the New World Order. They were a prelude to a remarkable set of amendments proposed by the US which were later given official approval by the White House. In a joint White House statement of 12 May 2022, President Biden confirmed, along with Ursula von der Leyen, President of the European Commission, that


“The leaders [i.e. Biden and von der Leyen] will also cooperate towards the conclusion of a convention, agreement or other international instrument on pandemic prevention, preparedness and response at the WHO, and targeted amendments to the International Health Regulations, in order to strengthen the global rulebook for pandemic PPR*. The EU and the U.S. are working together with expert dialogue to forge consensus on targeted IHR amendments and the content of a pandemic instrument. They also recognise the importance of engagement with other partners to take forward both sustainable financing for PPR and a strengthened WHO.”

The public was not made aware of the magnitude of what these two leaders had agreed. The White House press statement did not disclose the fact that the US had already proposed significant amendments to the IHR on 12 April 2022. If the mainstream media had bothered to report on these amendments the citizens of America – or, more accurately, those citizens who are trying to decipher what their Communist leaders are up to – would have been horrified by what their President had just done.

Strengthening WHO preparedness for and response to health emergencies

Proposal for amendments to the International Health Regulations (2005)

1. The Director-General has the honour to submit to the Health Assembly for its consideration, in accordance with paragraph 1 of Article 55 of the International Health Regulations (2005), the proposal for amendments to the Regulations received from the United States of America pursuant to the said provision (see Annex).


The proposed US amendments were circulated by the World Health Organization in advance of the world health assembly meeting scheduled for 22-28 May. They included the following suggested changes to the IHR:

Proposed Amendments to Article 12.2

2. If the Director-General considers, based on an assessment under these Regulations, that a **potential or actual** public health emergency of international concern is occurring, the Director-General shall **notify all States Parties and seek to** consult with the State Party in whose territory the event arises regarding this preliminary determination **and may, in accordance with the procedure set forth in Article 49, seek the views of the Committee established under Article 48 (hereinafter the “Emergency Committee”).** If the Director-General determines ~~and the State Party are in agreement regarding this determination~~ **that the event constitutes a public health emergency of international concern**, the Director-General shall, in accordance with the procedure set forth in Article 49, seek the views of the ~~Committee established under Article 48 (hereinafter the “Emergency Committee”)~~ on appropriate temporary recommendations.

The proposed amendments to Article 12.2 are startling. They empower the Director-General to declare a pandemic health emergency of international concern [PHEIC] entirely on his own authority. He is under no obligation to seek the agreement of the countries affected. Furthermore, he may do so even if the supposed emergency is merely “potential” and not “actual”. This means he will have the discretion to declare a PHEIC purely on the basis of what he believes might or could happen, and not on the severity of what has actually happened.

In case one doubts whether this “potential” factor could actually be used to trigger a PHEIC, consider the following recommendation from the WHO report, ***Covid-19: Make It the Last Pandemic***, which was published in May, 2021:



There is a case for applying the precautionary principle in any outbreak caused by a new pathogen resulting in respiratory infections, and thereby for assuming that human-to-human transmission will occur unless the evidence specifically indicates otherwise

The bias of the current system of pandemic alert is towards inaction — steps may only be taken if the weight of evidence requires them. This bias should be reversed — precautionary action should be taken on a presumptive basis, unless evidence shows it is not necessary.

IV. Future declarations of a PHEIC by the WHO Director-General should be based on the precautionary principle where warranted, as in the case of respiratory infections. PHEIC declarations should be based on

This is truly astonishing. One man, appointed by the Elite, having received a report of a disease outbreak which may have caused only a few fatalities, may, at his sole discretion, issue legally enforceable recommendations affecting the freedom and rights of everyone on earth.



Draconian powers

The US submission of 12 April also calls for the inclusion of two new provisions which illustrate the sweeping scope of the powers that the Director-General will have when making his recommendations:

New Article 18.3

In developing temporary recommendations, the Director-General shall consult with relevant international agencies such as ICAO, IMO and WTO in order to avoid unnecessary interference with international travel and trade, as appropriate. Additionally, temporary recommendations should allow for the appropriate exemption of essential health care workers and essential medical products and supplies from travel and trade restrictions.

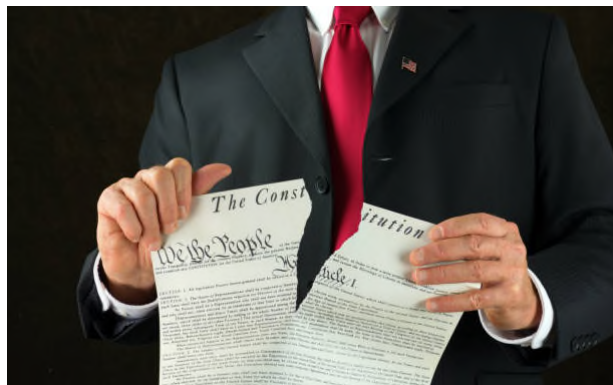
New Article 18.4

New 4: In implementing health measures pursuant to these Regulations, including Article 43, States Parties shall make reasonable efforts, taking into account relevant international law, to ensure that:

- (a) Contingency plans are in place to ensure that health care worker movement and supply chains are facilitated in a public health emergency of international concern;
- (b) Travel restrictions do not unduly prevent the movement of health care workers necessary for public health responses;
- (c) Trade restrictions make provision to protect supply chains for the manufacture and transport of essential medical products and supplies; and
- (d) The repatriation of travellers is addressed in a timely manner, given evidence-based measures to prevent the spread of diseases.

These are all “lockdown” provisions! They envisage the imposition of restrictions that are possibly even more draconian than those imposed in 2020.

Bear in mind, as you ponder this, that these proposed amendments to the IHR have already been approved in principle by President Biden.



Emasculating the US Constitution

The US Constitution is entirely set aside by these amendments. The rights and freedoms which it upholds can be overridden by just one man. The views of the US Congress are irrelevant. No US lawmaker will be called upon to review or approve the Director-General's decision. And the same is true for all sovereign nations!

When he arrives, the Antichrist will crave powers of this nature. His vicious program of destruction will be greatly accelerated if they are already in place. Any Christian who thinks this is not a portent of the End Time is simply not paying attention.

The power to declare a pandemic, and to do so on a precautionary basis “unless the evidence specifically indicates otherwise,” will allow the Director-General to conjure pandemics from nowhere – and nobody will have any legal right to challenge him. The phrase, “unless the evidence specifically indicates otherwise,” is redundant since the evidentiary basis for these declarations will be determined solely at the discretion of the Director-General.

CONCLUSION

The exercise to enlarge the powers of the WHO assumes that “pandemics” will become more frequent, more lethal, and more universal in the coming years, but there is no scientific basis for these sweeping assumptions. It also assumes that quarantines and lockdowns serve a useful purpose, but again the WHO has no scientific (or even unscientific!) data to support this. Finally, it assumes – perversely – that “pandemics” can be addressed only through the liberal use of vaccines.

The World Health Organization is a threat to peace and security on earth. It seethes with lies and duplicity, corruption and graft. It serves the Luciferian cult which established it in 1948 and exists only to harm humanity.

The logo chosen by the World Health Organization brazenly displays the spirit that imbues it, namely the Serpent. The numerous reports in the media about bio-labs in the Ukraine may be intended as a convenient way of explaining – in the not too distant future – how lethal pathogens came to be used in false-flag terrorist attacks. Whether these labs ever existed is immaterial.
