

Vaccines Promote Lifelong Autoimmune Disease

Sometimes important details are hidden in the fine print. In a complex contract they can be used to conceal evidence of criminal intent. However, the fact that something is recorded in writing and openly available does not always mean it is widely known or properly understood. Important information is often neglected or forgotten.

We have long argued in these paper that vaccines are of dubious value and potentially harmful. On October 6, 2019, before the 'Covid' scare, we published #205: ***Vaccines are the Perfect Vector for Mass Infection.*** At the close of the paper we advised our readers to ask themselves “whether the vaccine industry will be used at some stage in the future by persons unknown to inject debilitating or sterilizing drugs into an entire population?” -

Why are they so determined to impose mandatory vaccinations?

Before we close we should ask ourselves why our government and the pharmaceutical industry are determined to inject vaccines into our kids, even if this means making them mandatory? No vaccine, no school (Look at California). Maybe financial penalties will be added later to the list of coercive options. After all, if they are killing our kids via abortion, poisoning their food with pesticides and GMOs, wrecking their education with mind-deadening curricula, filling their screens with pornography, making the cost of their basic medical care prohibitive, legalizing cannabis, promoting gender confusion and sexual perversion, and attacking traditional family values from every possible angle, do you still believe they care about the well-being of your children?

Be sensible and weigh the evidence. We do not have a daysman, akin to the one sought by Job, to carry out this task on our behalf. Nor is one likely to emerge.

If, having done so, you still have the courage and the stamina to look a little further down the road, you may ask yourself whether the vaccine industry will be used at some stage in the future by persons unknown to inject debilitating or sterilizing drugs into an entire population? As we state in the title to this paper, vaccines are the perfect vector for mass infection. They may not use it, but they seem determined to retain it as an option.

The Covid hoax and subsequent developments (WHO pandemic treaty, monkeypox, bird flu, etc) have shown that this is exactly where the Cabal are going. Available sources of information

For anyone who doubts either the safety or the efficacy of vaccines, there is now more than sufficient information on the Internet to show that their doubts are well founded. Alas, the social conditioning is intense. The industry has wrung massive profits from their vaccine products but they have taken care to reinvest a sizeable chunk of these profits into convincing the public that, despite the rumors, vaccines are both safe and effective. Advertising works, and advertising based on fear is especially persuasive.

The poisoning process – if it exists – is slow and gradual. The masterminds behind the industry have a firm grasp of human psychology. They know we find it immensely difficult to see any connection between a product and its adverse effects unless those effects are almost immediate.

The Bible is referring to this tendency when it says:

“Because sentence against an evil work is not executed speedily, therefore the heart of the sons of men is fully set in them to do evil.” (Ecclesiastes 8:11)

Here the Word of God is addressing our personal propensity to sin, but that same propensity blinds us to the impact of sin on society as a whole. When the Apostle says, **“the whole world lieth in wickedness” (1 John 5:19)**, he is drawing attention to a truth which we as Christians are often slow to acknowledge. If the whole world lies in wickedness and **“the heart of the sons of men is fully set in them to do evil”**, then we ought to examine the actions of sovereign states and major corporations with this vital Biblical principle clearly in mind.

Speaking of the End Time tribulation, the Word of God says:

“And except those days should be shortened, there should no flesh be saved: but for the elect's sake those days shall be shortened.” (Matthew 24:22)

If the Bible tells us that all life on earth would be destroyed had the LORD not limited the number of days that the Children of Wickedness had available to them to conduct their genocidal campaign, then we ought to assume that a plan for this purpose has already been formulated.

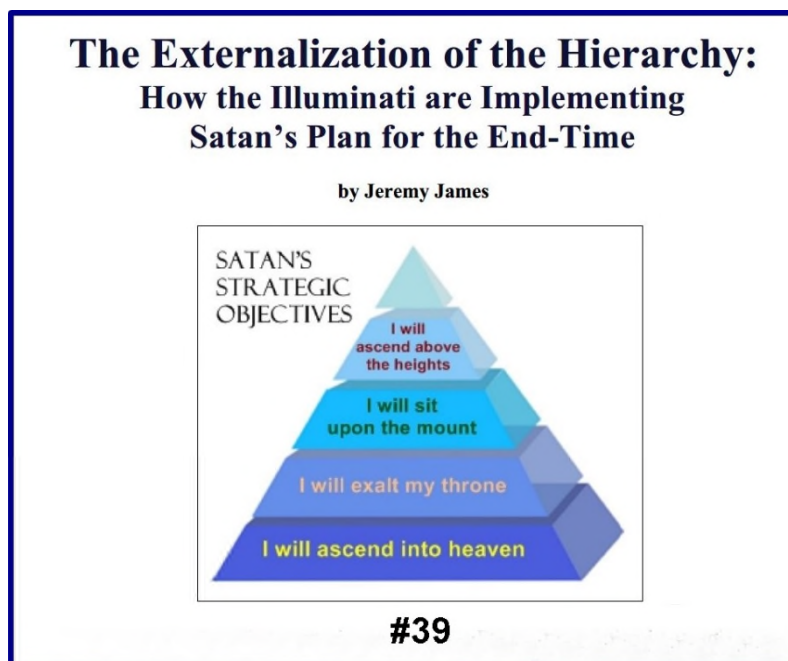


The average person finds it very difficult to imagine that evil of this magnitude is already at work in the world. He likes to think that world events are shaped mainly by rival interests, constrained in the main by chance and circumstance, but this is not what the Word of God is saying. Satan has a plan – which the Word of God has revealed – and his earthly servants, the Children of Wickedness, are putting it into effect.

In our paper #39 [2013], we examined this plan from the perspective of Alice Bailey, one of the mouthpieces that Satan selected to co-ordinate the work of his earthly servants in the lead-up to his great End Time revolution. Bailey’s books constitute a blueprint of this Illuminati Plan, giving details of the various tasks that his acolytes are expected to carry out on the world stage before the arrival of the Antichrist. These books were kept out of the public domain until 1975, but are barely understood today, even by Christians who ought to be “**as wise as serpents**” (Matthew 10:16). As incredible as it may seem, the Illuminati know they can safely disclose large elements of their plan because most of mankind is just too lazy or too indifferent to take seriously the many tell-tale clues that these books contain.

The Illuminati Plan is predicated on genocide

While the Enemy is a consummate liar, he is obliged to some extent to make explicit his intentions when he is giving orders to his disciples. So when he gives a date for the commencement of the final phase of his End Time plan, we ought to take note, especially as the time is upon us and his worldwide preparations show every evidence of being far advanced.



The following passages from *The Externalisation of the Hierarchy*, which was first published in 1957, show that the year envisaged for this commencement (at the time the messages were channeled by Ms Bailey) was the one we are now in, namely 2025:

[Note: The following passages are taken from the printed version of the second paperback edition of 1976. This confirms that the year given (2025) was not subsequently altered to fit later developments.]

“I have made this practical application and this immediate illustration of teaching anent [*i.e. about*] glamour [*another word for illusion*], illusion and maya because the whole world problem has reached a crisis today and because its clarification will be the outstanding theme of all progress – educational, religious and economic – until 2025 A.D.”

[June 1942] (p.363)

“Thus a great and new movement is proceeding and a tremendously increased interplay and interaction is taking place. This will go on until A.D. 2025. During the years intervening between now and then very great changes will be seen taking place, and at the great General Assembly of the Hierarchy – held as usual every century – in 2025 the date in all probability will be set for the first stage of the externalisation of the Hierarchy. The present cycle (from now until that date) is called technically "The Stage of the Forerunner". It is preparatory in nature, testing in its methods, and intended to be revelatory in its techniques and results. You can see therefore that Chohans, Masters, initiates, world disciples, disciples and aspirants affiliated with the Hierarchy are all at this time passing through a cycle of great activity.” [January 1946] (p.530)

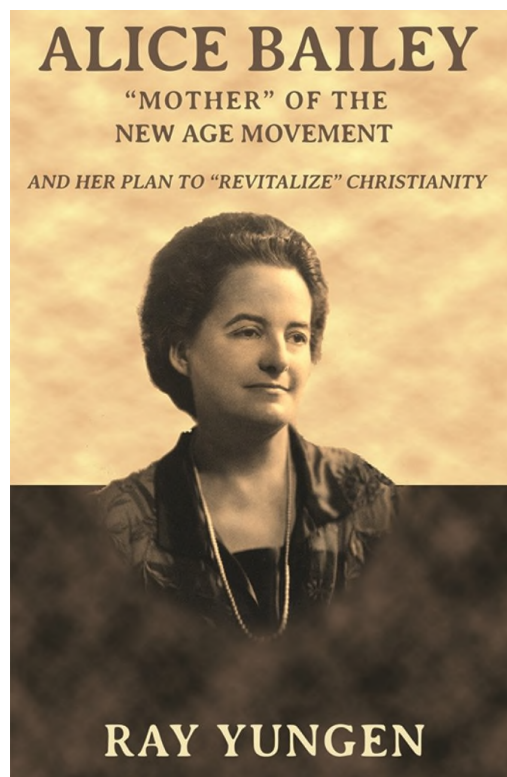
“Today, human beings as a whole are so loudly invocative that the entire trend of the life of the Hierarchy and Its plans to date have been subjected to change, to postponement as far as certain interior and purely hierarchical determinations are concerned, and to a hastening of certain plans which were slated (if I may use such a word) to take place several centuries later than this but which – owing to the unexpected preparedness of humanity – can take place, not prematurely really, but securely and in the fullness of time; this fullness of time, as regards the particular planning with which we are dealing, is from now until the year 2025 A.D. – a brief period of time indeed in which to see the consummation of the larger purpose of the planetary Logos, working through the three major centres within His body of manifestation.”

[August 1946] (p.561-2)

We provide these quotations to show that the Illuminati Plan is similar to a standard business plan, with strategic objectives, the allocation of resources, performance measures, and target dates for delivery. With so many players working together with the ‘Hierarchy’ during the cycle they call *the stage of the forerunner*, they needed a way to co-ordinate their activities while remaining undetected by the world at large.

Understanding the Illuminati Plan – Paper #39

We would urge our readers to review our earlier paper (#39) since it provides an overview of what the Enemy is doing, how he operates, and what he intends to achieve. We need to continually bear in mind that his overall goal is the installation of the Antichrist. His followers are driven by this vision, the prospect that the entire earth will one day be subject to the visible will of Satan. As his servants they expect to be rewarded accordingly – which shows a level of self-deception that beggars belief.



From time to time solitary members of this infernal network awaken to the awful darkness that controls them. In some manner the Light of Christ touches their hearts and they realize how thoroughly deceived they have been.

A few years after paper #39 was published one such ‘escapee’ got in touch with me. I reproduce part of their letter below, with suitable redactions to preserve his/her anonymity:

I enjoyed reading your piece on externalization of the hierarchy. It was spot on. I went down the dark path of drugs, occult, Kundalini yoga, etc until Jesus saved me using some African-America pentecostals and a radical deliverance in 1991. My complete deliverance has taken years as Christ has been formed in me. What has made things particularly sticky is that I come from a family with an antichrist legacy. My mother's family was primarily composed of lords and ladies in the UK. Her father later moved to [a foreign country] to be a gentleman farmer after inheriting his trust. There he met my grandmother who attended [university] and was disciplined by some of Cecil Rhodes' minions. My father's side is titled but all based on achievement. My grandfather co-founded [an international Illuminati organization] and that side of my family is full of academics and physicians. Needless to say, it has been a *battle royale* to get all that iniquity behind me and to be truly free.

When I published #39 I asked the LORD for confirmation that the paper gave an accurate depiction of what the Enemy was doing via his Illuminati servants. I didn't want to mislead anyone. Naturally, the letter was a blessing. As a generational member of the Antichrist cabal, the author was familiar with the plan and was prepared to state that, in his opinion, my paper was "spot on."

If preachers and pastors took to heart the information that is already available, via the Internet and other ways, they would find ample proof that the Antichrist program – the so-called *New World Order* – is at a very advanced stage of implementation. But most of them are not interested. It is difficult to find even one who has any understanding of what the Enemy is doing. The same may be said of church elders, Christians of longstanding who profess to believe God's Word but have no interest whatever in testing His prophetic pronouncements against the tide of world events.

Verifiable information

In these papers we strive as best we can to highlight verifiable information that a New World Order is being prepared and Christianity is facing annihilation. Occasionally we come across a piece of information that stands out from the rest, a fact of such importance that we are amazed it was not better known or widely understood.

We are not sure who deserves the most credit for drawing attention to the matter we are about to discuss, but we'd like to acknowledge the valuable role played by the following: northerntracey213875959.wordpress.com; sashalatyova.substack.com; and bailiwicknews.substack.com. It is only through the tireless research and critical discernment of individuals like these that the disturbing truth behind many aspects of modern medicine is being exposed to public scrutiny.

Our news relates to an important medical discovery in 1902 which earned the scientist concerned, Dr Charles Richet, the Nobel Prize for Medicine/Physiology in 1913. Here is how the official Nobel Prize website summarizes his achievement:

“Our immune system protects us from attacks by microorganisms and poisonous substances. After experiencing an attack, the immune system learns to defend itself against new attacks – we become immune. One of the ways this is used is with vaccinations, when a low dosage of an infectious substance provides immunity. Through studies involving dogs, Charles Richet demonstrated an opposite effect in 1902. After an initial low dose of a substance, a new dose some weeks later could produce a severe reaction. He called the phenomenon anaphylaxis. The result had important implications for our understanding of allergies.” *[emphasis added]*

In his acceptance speech, which is available online at nobelprize.org, he gave a very clear account of his discovery, which is summed up in the word *anaphylaxis*:

"Anaphylaxis... means that state of an organism in which it is rendered hypersensitive, instead of being protected." *[emphasis added]*

Richet's methodology

He describes three possible responses by a subject to a toxin injected twice at an interval of one month:

- (1) No change. The effect on the subject is the same on both occasions;
- (2) The effect is reduced. He compares this to a drug addict who needs a higher dose the second time to achieve the same narcotic effect. (Medical science calls this a form of immunization.)
- (3) The effect is greatly increased. This was Richet's discovery. He stated:

"Now I have shown that there is a third possibility, frequently to be observed in certain conditions which I have specified: this is of heightened sensitivity. The first injection, instead of protecting the organism, renders it more fragile and more susceptible. This is anaphylaxis."
[emphasis added]

The Nobel Prize website comments as follows on the startling nature of his discovery: "He showed that in fact parenteral injection [*such as vaccine inoculation*] of protein substance modifies profoundly and permanently the chemical constitution of the body fluids." Note their choice of adverbs, "profoundly" and "permanently". They hint at the chilling implications of Richert's remarkable discovery.

He was taken aback by what he had found and by how easy it was to demonstrate:

“You will find that it is by no means the result of profound thought but a simple observation, almost a fortuitous one; so that my merit has only been in letting myself see the facts which were plain before me.”

It is a measure of the medical significance of his “fortuitous” discovery – which virtually any experienced physician at the time could have made – that it was awarded a Nobel Prize. One would have expected the mechanism behind anaphylaxis to have been well understood as a result and universally taught to all medical students thereafter. But that did not happen!

If we review Dr Richert’s account of the physiological mechanism behind anaphylaxis we will understand why its true implications were suppressed.

Here is how he described the impact of a second injection of fish toxin given after a 3-4 week interval to a dog whose first toxic dose was of the smallest quantity:

“An unexpected phenomenon arose, which we thought extraordinary. A dog when injected previously even with the smallest dose, say of 0.005 liquid per kilo, immediately showed serious symptoms : vomiting, blood diarrhoea, syncope, unconsciousness, asphyxia and death. This basic experiment was repeated at various times and by 1902 we were able to state three main factors which are the corner-stone of the history of anaphylaxis: (1) a subject that had a previous injection is far more sensitive than a new subject; (2) that the symptoms characteristic of the second injection, namely swift and total depression of the nervous system, do not in any way resemble the symptoms characterizing the first injection; (3) a three or four week period must elapse before the anaphylactic state results. This is the period of incubation.”

Astonished by what he had discovered, he made his research results known to others to see if they could replicate his findings:

"In 1903 Arthus, in Lausanne, showed that a first intravenous injection of serum on a rabbit causes anaphylaxis, i.e. three weeks after the first injection the rabbit is hypersensitive to the second injection. The phenomenon of anaphylaxis was becoming of general application. Instead of applying only to toxins and toxalbumins, it held good for all proteins, whether toxic at the first injection or not." *[emphasis added]*

All proteins! Rickert thought initially that the substance injected into the animal had to be a toxin in its own right, but further research showed that virtually any (seemingly harmless) protein could cause anaphylaxis. This was an astonishing discovery.

He went on to say:

"Two years later Rosenau and Anderson, two American physiologists, demonstrated in a noteworthy piece of work that the phenomenon of anaphylaxis occurs after every injection of serum, even when the injection is minute, for example of 0.00001 ml, which is an infinitely small amount, but nevertheless sufficient to anaphylactize an animal. They quoted examples of anaphylaxis from all organic liquids: milk, serum, egg, muscle extract." *[emphasis added]*

By the way, Katherine Watt points out (bailiwicknews.substack.com) that the Rosenau to whom Richert refers was Milton Rosenau, director of the US Hygienic Laboratory at Harvard University between 1899 and 1909. Harvard was the leading proponent of Eugenics in the US at that time and advocated the forced sterilization of people declared to be feeble-minded, physically handicapped or deemed otherwise unfit to procreate. Rosenau was appointed to his highly influential position by the same cabal that sought to develop covert ways to cull the population. We can see from this why he was so keen to study Rickert's discovery firsthand.



Rickert wanted to believe that the subject's susceptibility to extreme anaphylaxis would pass after a period of time, perhaps a few months, but his research led him to conclude that

"...once a subject has been anaphylactized and consequently modified in his chemical constitution, then the subject can never go back to his former state. Return to normal is not possible. Subjects have been known who even after four years from the date of the first serum injection, were still sensitive to the unleashing reaction." *[emphasis added]*

Just as the Nobel Prize website says, the injected protein "modifies profoundly and permanently the chemical constitution of the body fluids."

Rickert stressed that all proteins "without exception" produce anaphylaxis, even "dead microbial bodies."

He found that, in addition to specific anaphylaxis – where the first and second injections contain the same substance – there exists also a "general anaphylaxis" [his term] where an animal that has been anaphylactically sensitized proves to be significantly more susceptible to *other* injected substances than an animal that had not originally received any sensitizing injections.

Vaccine contents

Common vaccine ingredients include antigens (attenuated 'viruses', bacteria, toxoids), preservatives (thimerosal [mercury], benzethonium chloride, 2-phenoxyethanol, phenol), adjuvants (aluminum salts), additives (ammonium sulfate, glycerin, sodium borate, polysorbate 80, hydrochloric acid, sodium hydroxide, potassium chloride), stabilizers (fetal bovine serum, monosodium glutamate, human serum albumin, porcine gelatin), antibiotics (neomycin, streptomycin, polymyxin B), and inactivating chemicals (formalin, glutaraldehyde, polyoxyethylene).

Rickert's remarkable warning

Rickert concluded his Nobel Prize speech with a remarkable warning. Even though he was almost certainly a member of the Cabal – he sailed with the Prince of Monaco on his yacht – he clearly overstepped the mark when, in the following passage, he effectively declared that all injected proteins, which bypass the digestive system, are potentially harmful, if not fatal:

"We are so constituted that we can never receive other proteins into the blood than those that have been modified by digestive juices. Every time alien protein penetrates by effraction [i.e. injection], the organism suffers and becomes resistant. This resistance lies in increased sensitivity, a sort of revolt against the second parenteral injection which would be fatal. At the first injection, the organism was taken by surprise and did not resist. At the second injection, the organism mans its defences and answers by the anaphylactic shock. Seen in these terms, anaphylaxis is a universal defence mechanism against the penetration of heterogenous substances into the blood, whence they cannot be eliminated." *[emphasis added]*

CONCLUSION

We'll now try to put what we have learned into perspective:

1. It has been well known among the medical establishment worldwide since 1913 that injecting any substance into the blood is a potentially harmful process.
2. It has also been well known since 1913 that there is a very powerful biochemical connection between the intravenous introduction of foreign proteins into the blood and the immune response which the body initiates.
3. It has also been well known since 1913 that after a body has been contaminated with foreign protein via injection that the biochemical status of the body is permanently and irreversibly changed. Except in the unlikely event that this change confers some form of immunity – which is a matter of intense debate – the body is permanently weakened by this biochemical change.
4. The more a person is contaminated intravenously with foreign proteins, the more sensitized he becomes to future proteins introduced in the same way.
5. It has been well known since 1913 that the range of pathological symptoms produced by the body's immune response under these circumstances is extremely broad, of indeterminate duration and intensity, and often unpredictable and specific to the individual. This allergic reaction is caused by the immune system itself, and not by the protein which triggered the reaction.
6. It has been well known since 1913 that foreign protein can **only** be introduced safely into the body via our digestive system and that the digestive process is needed to neutralize a possible immune response.

7. It has been well known since 1913 that the injected foreign protein does not need to be toxic to trigger a severe immune reaction. Any protein derived from a natural source is capable of triggering such a reaction.
8. It has been well known since 1913 that lesser immune reactions will produce an inflammatory response in one or more organs of the body, causing what we call today an *autoimmune disease*. Significantly an autoimmune disease cannot be cured by medical treatment, only alleviated. Here is a short list of the most common autoimmune diseases, all of which we believe have increased in frequency and intensity since the introduction of the childhood vaccine program: multiple sclerosis, diabetes, rheumatoid arthritis, irritable bowel syndrome, asthma, lupus, thyroiditis, psoriasis, myasthenia gravis, Guillain-Barré, vasculitis...

There are known to be more than 100 different autoimmune diseases, but the ‘official list’ does not include the many down-stream pathologies produced, for example, by leaky gut (irritable bowel syndrome). Since medical science admits that all such diseases are difficult to diagnose, having no obvious etiology, there are likely many more, particularly of a neurological kind. Few doctors today are prepared to admit that vaccines are a plausible cause of autism spectrum disorders, the incidence of which is increasing at an alarming rate. Developmental disorders are also increasing, some would say skyrocketing, to the point where one child in six now has a developmental disability – a startling admission by the CDC in 2019.

One in Six

“Recent estimates in the United States show that about one in six, or about 17%, of children aged 3 through 17 years have one or more developmental disabilities. Developmental disabilities are a group of conditions due to an impairment in physical, learning, language, or behavior areas. These conditions begin during the developmental period, may impact day-to-day functioning, and usually last throughout a person’s lifetime .”

We could say more and labor the obvious. The evidence that vaccines are potentially harmful is irrefutable. Furthermore, the evidence that the more we receive the more potentially dangerous they become is also irrefutable.



Types of autoimmune diseases

Vaccines can even be used as a stealth bioweapon, producing untraceable diseases by testing and varying the trigger protein over time. Used in this way they qualify as binary or two-phase weapons, where a harmless substance is introduced into the bloodstream with vaccine #1, setting up an anaphylactic trigger. This trigger can then be activated ("pulled") many years later by administering a second vaccine (vaccine #2) containing the same harmless substance. Progressive sensitization using other vaccines during the interval could result in a severe, possibly fatal anaphylactic shock when vaccine #2 is administered.

We urge our readers to consider the information set out in these papers – #39, #175, #205, #408 and #409 – and draw their own conclusions. We would also encourage our readers to ask themselves **why**, despite all the evidence, both the medical profession and the pharmaceutical industry continue to suppress information about the groundbreaking discovery made by Charles Rickert in 1902.

We need to remind ourselves daily that **"the whole world lieth in wickedness"** (1 John 5:19) and that we are being very foolish if we take everything we are being told at face value:
