Why We Need to Study the Biblical Term *Pharmakeia*

In a previous paper (#340) we examined a document which may or may not have been genuine. However, since it matched closely what we are witnessing today, we took it as a serious statement of intent. Known as 'The Secret Luciferian Covenant' it described the method that the Enemy is using to enslave mankind (See extract below).

"We will keep their lifespans short and their minds weak while pretending to do the opposite. We will use our knowledge of science and technology in subtle ways so that they will never see what is happening. We will use soft metals, ageing accelerators and sedatives in food and water, and also in the air. They will be blanketed with poisons everywhere they turn. The soft metals will cause them to lose their minds. We will promise them a cure from many of our fronts, yet we will feed them more poison. The poisons will be absorbed through their skin and mouth, and will destroy their minds and reproductive systems...

"The poisons will be hidden in everything that surrounds them and what they eat, drink, breathe and wear...

"Those they look up to will help [us]. We will use them to push our poisons... "When they give birth we will inject the poisons into the blood of their children and convince them it's for their health... When their [children's] ability to learn has been affected, we will create medicine which will make them even sicker and cause other diseases for which we will create yet more medicine. We will render them weak and docile before us by our power. They will [become] depressed, slow and obese, and when they come to us for help we will give them more poison...

"If they refuse [to obey] we shall find ways to implement mind-altering technology into their lives. We will use fear as our weapon..."

As we stated in our earlier paper (#340):

The Luciferians admit that their principal weapon against humanity is poison. Through their iron grip over the media and their extensive knowledge of pharmacology, they are able to secretly pollute the human body in a variety of ways and to do so across the entire population over a long period... They get results because (a) the poisoning process is slow, going on for decades, and (b) the public is entirely unaware that something so destructive, and yet highly organized, is going on in their midst.

The public has also forgotten that the Bible warns of the major role that sorcery will play in the End Time. The word "sorcery" in the New Testament is a translation of the Greek term, *pharmakeia*. Poisons are part of the dark arts.

The Luciferians are using poisons to bring about a New World Order. A sick, somnolent, soft-headed society is much easier to control. Their poisons will also enable them to reduce the total population of the world to 10 percent or less, which has always been their long-term goal. The pared-down population will serve the Elite like a caste of obedient slaves, kept in check by mindcontrol technology and more *pharmakeia*.

Keshaphim and Pharmakeia

We find important End Time references to sorcery in the Old Testament as well. Isaiah referred to it twice, each time in relation to the heinous sins of Babylon:


"But these two things shall come to thee in a moment in one day, the loss of children, and widowhood: they shall come upon thee in their perfection for the multitude of thy sorceries, and for the great abundance of thine enchantments." (Isaiah 47:8)

"Stand now with thine enchantments, and with the multitude of thy sorceries, wherein thou hast laboured from thy youth; if so be thou shalt be able to profit, if so be thou mayest prevail." (Isaiah 47:12)

The original Hebrew word which the KJV team translated as "sorceries" is *keshaphim* (Strong's H3785). They took *keshaphim* to be equivalent to the Greek word *pharmakeia*, which they translated as "sorceries" in Revelation 9:21 and 18:23:

"Neither repented they of their murders, nor of their sorceries, nor of their fornication, nor of their thefts." (Revelation 9:21)

"And the light of a candle shall shine no more at all in thee; and the voice of the bridegroom and of the bride shall be heard no more at all in thee: for thy merchants were the great men of the earth; for by thy sorceries were all nations deceived." (Revelation 18:23)



Their interpretation of this word accords with that of the Jewish scholars who compiled the Septuagint around 200 B.C. When translating the Old Testament into Greek they also chose *pharmakeia* to express Isaiah's use of the word *keshaphim* in 47:8 and 47:12. Thus, working a few hundred years after Isaiah, and rooted in the same culture, they confirmed the equivalence of this important technical term with that employed by John in the Book of Revelation.

The word *keshaphim* also appears in Micah 5:12 and Nahum 3:4 –

"And I will cut off witchcrafts [*keshaphim*] out of thine hand; and thou shalt have no more soothsayers:" (Micah 5:12)

"Because of the multitude of the whoredoms of the wellfavoured harlot, the mistress of witchcrafts [*keshaphim*], that selleth nations through her whoredoms, and families through her witchcrafts [*keshaphim*]." (Nahum 3:4)

It is significant that the compilers of the Septuagint translated *keshaphim* in these verses (all three occurrences) with a variant of the Greek word *pharmakeia*.

Micah is referring in chapter 5 to the return of Christ in the End Time and his awesome triumph over the Antichrist and his forces. The LORD closes that chapter with an intense expression of His wrath:

"And I will execute vengeance in anger and fury upon the heathen, such as they have not heard." (Micah 5:15)

Thus one of the tasks that our Lord Jesus will carry out on his return will be the wholesale destruction of the system of *pharmakeia* that the Enemy has been using, seemingly on a grand scale, to bring mankind completely under his control.

Nahum, on the other hand, is speaking about the wrath of God on Nineveh, a city which he describes in castigating terms, a place so steeped in cruelty and darkness that all who hear of her destruction will clap their hands. Her crimes, like those of Babylon, were legion, "...for upon whom hath not thy wickedness passed continually?" (Nahum 3:19)

If we consider these passages as a group, we can see that the greatest possible evil was thriving in these abominable cities, Nineveh and Babylon, and *pharmakeia* was being used extensively by their corrupt leaders to oppress the people.

The Book of Revelation tells us plainly that this mode of oppression will be universal in the End Time: "...for by thy sorceries [i.e. Babylon's use of *pharmakeia*] were <u>all</u> <u>nations</u> deceived." (Revelation 18:23)

There is no doubt, therefore, that drugs, potions, chemicals and poisons of various kinds will be used extensively by the Enemy in the period leading up to the seven-year Tribulation.

(The term "witchcrafts", which the KJV uses in a few places, is probably not sufficient to convey to us today the critical role that mind-altering drugs and physical poisons will play in the End Time. The word *keshaphim* also appears in its plural form only, indicating that a broad spectrum of drugs and poisons will be used, all in a disguised form and without the knowledge of the millions – if not billions – of intended victims.)



This is happening NOW

Is this happening today? Of course it is! It is happening on a horrifying scale but only in ways that can plausibly be explained or excused in scientific terms. The poisoning process is slow and gradual, just as the *Secret Luciferian Covenant* requires.

The cunning and deception behind it all is making it difficult for us to see where danger lies. Yes, there are poisons or potential poisons in plain view, but even these succeed in evading critical public scrutiny because pseudo-science and the mass media have greatly skewed the way we perceive reality. As many have noted, the more often a false proposition is repeated, the more likely we are to 'believe' it, even if it doesn't make sense or is known to have certain defects. It takes real effort on our part to reject a lie which everyone else believes, and the Enemy knows this! Despite what we are being told to the contrary – by teachers, leaders, experts, and preachers – most of society is being worn down and made compliant by the constant repetition of false paradigms and bogus claims.

A look behind the scenes

If, as the Bible says, drugs and poisons are being used strategically, on a worldwide scale, to oppress mankind, then we should expect to find some evidence of this in the documentation which the Cabal are using to co-ordinate their own activities. Naturally, tell-tale evidence of this kind is not easy to obtain but, from time to time, the door opens slightly and we get a peek behind the scenes.

One such document found its way onto the Internet. Produced in July, 2001, it carries the NASA logo but was produced in Langley, Virginia, headquarters of the CIA:



The document itself ('Future Strategic Issues / Future Warfare') is protected by 'plausible deniability', where its existence is explained by the need to analyze what America's enemies are secretly doing, no matter how unethical or disturbing their plans may be. We know, of course, that America's enemies are very unlikely to have the ability to develop weapons which America itself is not already developing. Seen in that light, the document – a compilation of bullet points – is effectively an inventory of US stealth weaponry and offensive capability, organized by functional groups. Attendees at the seminar where these overheads were discussed would, no doubt, have been supplied with more detailed documentation.

Since the document was looking forward 25 years, weapons envisaged in 2001 (based on programs under way at that time) may already have been tested or deployed in real time. This is what makes the following section so disturbing:



In a world of 'pandemic threats', this weapon would appear to have enormous potential. It envisages the release of an aerosol of tiny dust-like particles over a populated area. The unwitting victims below would inhale these invisible mechanical particles and suffer various "pathological" effects. Presumably the Cabal would have a 'vaccine' ready to 'treat' these diseases and a frightened population would rush to receive it.

Notice the closing comment. The CIA would appear to regard this new class of weaponry as "legal". If nothing else this strange remark shows that ethical concerns will have no bearing on how these weapons are likely to be used. The end justifies the means.

The document alludes to other poison-distribution systems:

The appearance of drones [UAVs] over New Jersey in late 2024, as well other American states, is proof that the document is speaking about imminent or credible threats to the American public.

We could devote a lot more time to an examination of this nasty document but we will stick to our main theme, namely the strategic, clandestine use of poisons, drugs and chemicals by governments and corporations prior to the End Time ("the last days") to weaken humanity.

"Imported Vitamins"

Readers may have noticed in the slide above a reference to "imported vitamins" as a possible bio-weapon. It is very strange indeed to see vitamins and aflatoxin on the same list! (Aflatoxin is a dangerous carcinogenic mold which can also destroy one's liver). What do the CIA analysts know about imported vitamins that we don't?

When I first read this document I assumed that the imported vitamins to which it refers would be used to carry a <u>separate</u> toxin or undisclosed substance into the victim's body. But why mention vitamins at all? Any food could be used for that purpose. It was only after I read the papers by **Agent131711** and **Medicine Girl** (which we will discuss shortly) that I realized that imported vitamins may *already* be used for this purpose, namely as a cumulative, slow-acting population poison. By the way, a toxic component would not need to be added if the so-called 'vitamin' itself was toxic.

Is it possible that synthetic vitamins may be part of a multi-decade program to compromise the health of western nations and, in effect, to carry out the slow-poisoning process described in the *Secret Luciferian Covenant?*

The rest of our paper will be devoted mainly to an examination of this question.




Our approach

We could start by citing a mass of data compiled by two online commentators, but we won't. There's a better, more convincing way. These astute individuals have shown how we can do the research for ourselves. It is then up to us, having collected the relevant data, to draw our own conclusions.

Once we consult the right websites – run by the <u>manufacturers</u> of these products – we will see plainly that something is <u>seriously wrong</u> with the so-called 'vitamin' industry.

At the time I was studying the nature of GMOs, it never occurred to me to check the contents and manufacturing process of synthetic vitamins. One reason I failed to consider these products as a possible source of slow-acting toxins was the often-stated intention by the international medical authorities, such as Codex Alimentarius, to restrict public access to synthetic vitamins. We all assumed from this that synthetic vitamins conferred real health benefits and reduced the profits that the pharmaceutical industry could otherwise make from the sale of their own products. But this was a ruse. In reality, the big corporations that control the pharmaceutical industry *also* control the synthetic vitamin industry. They will never ban synthetic vitamins because they are highly profitable and harmful to human health.



Medicine Girl has her Eureka! moment

The key to unlocking the impenetrable door that we call "synthetic vitamins" is an internationally recognized code for classifying individual chemicals. The industry records the properties of the products that it manufactures. By doing this they ensure that other participants in the chemical business know exactly what they are buying. The information on each chemical includes data about toxicity – a fact of immense importance when it comes to gauging the safety profile of synthetic vitamins.

Before we dive into this subject, we'd like to share the 'waking up' process that Medicine Girl underwent. <u>She had long been an advocate of vitamins and</u> <u>supplements and did not entertain any doubts whatever about their efficacy or safety</u>. Then, in 2020, all of that changed:

Like most of you reading this, back in 2020 I was listening to advice from those I felt were in alignment with my values of truth and freedom. Their content was outstanding, they had large followings, and I viewed these people as genuine warriors who were standing up to the pharmaceutical industry. I truly believed what these freedom doctors, authors and show hosts were saying. I too wanted to remain healthy during "Covid" and, as a parent, it was my duty to protect my son. This is why, when Amandha Vollmer, who was someone I regularly followed and quite admired, posted on her social media that Vitamin D3 with K2 in lanolin was something everyone needed to supplement, I jumped to make the purchase. Amandha has such a distinguished career in alternative medicine that anything she said, I, along with her giant following, took as unquestionable guidance. But it wasn't just Vollmer touting this health advice, the D3+K2 miracle cure was something we all saw everywhere we looked.

Together, my son and I began taking our new supplement every morning. I adjusted his dose to ½ of mine, so he was intaking roughly only 250 IU per day, which was far under the level the internet recommended and substantially less than the amount the freedom broadcasters were advising to consume.

And just like with Agent131711's story, *everything was great until the day it wasn't*, and in our case, it didn't take long for *the day it wasn't* to arrive.

Tragedy struck only six weeks after we began dosing ourselves with the D3 drops. What started as a regular day ended in disaster for my child.

My very athletic son, whose favorite hobby is going to the local skatepark, happened to have a short fall while skating – nothing abnormal here, skaters fall regularly and other than some little bruises and scrapes, they are perfectly fine... but not this time. On this specific day, a very minor fall resulted in a broken shoulder! As an avid skater, he's fallen so many times and never had a serious injury, let alone one of this magnitude. It just didn't make sense because he was physically fit and didn't even land hard. We were stunned.

When the results from the x-ray came back, they revealed the severity of the damage. It was so bad that when the MD showed it to us, I gasped in horror. I just couldn't wrap my mind around how such a minor fall caused so much destruction. As a parent, I felt helpless seeing my child in such pain. I knew I needed to find out how to make sure this never happened to him again, but in order to do that, I first needed to figure out what could have possibly caused this to happen to my young, healthy son to begin with.

I spent hour after hour on the internet, desperately searching for answers: Youtube, Telegram, Instagram, Facebook, blogs, websites, anywhere there was potential information, but nothing I located seemed to fit the situation. I began posting in various truth forums, asking if anyone could explain what was going on with this horrendous break. Nobody seemed to have answers until one person asked if I was supplementing my son's diet with D3. I already knew what he was going to tell me, *D3 builds strong bones*, so I proudly replied, "of course I am and it's the expensive stuff with lanolin and K2." But to my complete and total shock, he didn't respond to congratulate me, nor did he tell me to up the dosage, he instead told me to research D3... because **it's rat poison**...



I then came to the realization that when I said, "of course I am and it's the expensive stuff with lanolin and K2", I had no idea what I was talking about. I had not the slightest clue what the D3 or the K2 in the bottle *actually* were, let alone what the combination of them does – all I was doing was parroting what I heard from Lee Merritt, Amandha Vollmer and the people I never met yet put so much faith into.

Verifying the forum-responder's claims was simple, all it took was a Google search. Of course Google states that yes, it is rat poison, but it's only bad for rats and the dose is so tiny it can't hurt you, but despite what Google claims, as a parent, I refuse to feed my child rodenticide, even in very small amounts.

When I began researching deeper, I discovered that vitamin D3 kills rats through <u>hypercalcemia</u>, which is <u>bone destruction</u>. My son's break was so severe because the *vitamin* was weakening his bones, because that's what rat poison does.

I knew I needed to rush this information to the freedom doctors, authors and show hosts who were recommending the product. I believed that when I showed them what I had discovered, they too would be shocked and would not only take the product off their websites, but they would rush to warn people to stop taking it. But instead of receiving a huge *thank you* from them, **I was blocked and banned.** Trying to share this information with influencers like Alec Zeck, Andy Kaufman, Kelly Broland, Sayer Ji, Sam and Mark Bailey, Steve Falconer, Lee Merritt, Brian Ardis and Luke Storey, resulted in me being attacked in such a way that I questioned my safety; it felt like, if people knew where I lived, they would have come for me with pitchforks and torches to burn me alive. I could not believe how furious people become when you try to show them that what they are taking is rodenticide – and this isn't even some kind of hard-to-find information, <u>it can be easily verified by simply looking at the D-Con</u> website or running an internet search.

At this point, I still believed Amandha Vollmer was a good person who was unknowingly selling a dangerous product disguised as a vitamin. I thought she had been tricked, just like the rest of us, and if I could just get her to look at the information, she would be quick to take action because she seemed to sincerely care about health. I posted my findings in her Telegram group and was quickly eviscerated by the mob, but the attacks didn't end there. Next, Amandha herself called me an *attention-seeking narcissist that needs to journal and get therapy*... all for revealing that D3 is poison.. which is what it literally is... the **only active ingredient in this famous rodenticide is** *vitamin D3* **(the inactive ingredients are sugar, fat and flour).**

It seemed something more was going on here, something much deeper than *good people mistakenly promoting a bad product*.

My shock turned to outrage. I was outraged that trusted people were recommending that their followers take rat poison when a 2-year old could take one look at this and tell you it's something we shouldn't be eating.

Determined to warn others, I began making videos to speak out against the *supplement*. I launched my own show, started my own Substack, began posting on TikTok and even made a Telegram channel...

As time went on and I continued to research, I realized one of three things must be true:

- 1. Either these influencers know the truth yet choose pride and money over the health and wellbeing of their subscribers;
- 2. Or they are so indoctrinated into Rockefeller's game they actually BELIEVE rat poison is somehow good for the body;
- 3. Or they fit the definition of a shill paid pharmaceutical representatives, D3 lobbyists, controlled opposition.

...Once you hear how the industry was invented, sustained, and pushed, it is as obvious as finding out that government vaccines are harmful. And I thank all those that have attacked me so ferociously to keep me fired up to reveal the truth.

It is easier to investigate vaccines than vitamins

When Medicine Girl began to correspond with Agent131711 she discovered that his research methodology and his findings were similar to her own. It is clear from reading their papers that the task of establishing how synthetic vitamins are made is extremely time consuming, with lots of false trails and dead ends. We can be grateful that they undertook this arduous task on our behalf and shared their findings.

At one point Agent131711 explained why the task was so difficult. As we read through his comments (below) we can see that the industry itself has placed numerous obstacles in the path of those who tackle this subject. It takes an unusually determined attitude to persist with this work, not to mention a really good mind for collecting and evaluating relevant data:

I am not being hyperbolic when I tell you, Synthetic *Vitamins* are one of the most complex, most difficult to investigate topics I have ever researched. It is a mind-numbing, painstaking, run-around that consists of:

- Scattered information;
- *History* with no supporting sources;
- Papers that cite documents that don't exist and appear to have never existed, or if they do exist, I have no way to find them and none of my traditional deep-digging methods work;
- The documents that do exist don't say what the paper that referenced it claimed it says;
- *"Studies"* that aren't scientific and often do not have any form of legitimate control group;
- "Studies" that are assumptions and merely "point-and-declare" (i.e. dump a bunch of goo into a pot, withdraw a sample, put it under a microscope and say, "Yep, that's Vitamin B!");
- "Studies" with no process information;
- There are no readily available photos of 100% <u>natural</u> isolated Vitamins under a microscope. In fact, I can't locate a single microscopy photo of <u>natural</u> Vitamin D3, B12 or C;
- The MSDS is loaded with Hazard Category Codes, but the meaning of the codes are not on the MSDS. You have to dig through sites like OSHA.gov to locate the Hazard Category sheet to find out what "Category 3 Health Hazard" actually means;
- Studies that do take place are often absolutely morbid Hollywood-horror-movie nonsense that makes literally zero sense, like drilling holes in skulls of small animals, injecting their brains with chemicals, then calling it a *"virus"*;

- "sourced from" is not the same as "made from";
- "made in the USA" doesn't mean the contents are actually from the USA;
- *Natural* means nothing;
- Organic is a scam;
- There are zero regulations regarding vitamin and supplement testing;
- The industry is not regulated in any way whatever;
- The FDA approves toxic substances for consumption providing the amount is small;
- Incredibly, there isn't even an ingredients list for most vitamins and supplements and finding out how they are made is virtually impossible;
- Medical documents and scientific literature endorsing vitamins and supplements have been funded by Big Pharma, but you would never know that unless you went through the painful process of trying to figure out who the authors were and tracing their ties to Big Pharma;
- Incredibly, there isn't even an ingredients list for most vitamins and supplements and finding out how they are made is virtually impossible;
- Medical documents and scientific literature endorsing vitamins and supplements have been funded by Big Pharma, but you would never know that unless you went through the painful process of trying to figure out who the authors were and tracing their ties to Big Pharma;
- [Vitamins and supplements are nothing more than industrial chemical compounds with no proven connection of any kind to the nutrients found in natural food;]

• The names of the chemicals all have *"synonyms*", but the synonyms, although we are told they mean the same thing, can actually mean something completely different.

Basically, it's a confusing, tangled web of intentional chaos, in my opinion. I have never, in my life, had to deal with such diluted data, skewed information and bought-and-paid *research studies*. It is easier to investigate vaccines than vitamins.

Establishing the facts about synthetic vitamins

Now that these two researchers have worked out a reliable way to get hard, factual information about the chemicals that are used to make 'vitamins', we have a tool we can use ourselves:

STEP 1 – SDS

Manufacturers and sellers of these products leave themselves exposed to significant financial penalties if they fail to list all of the adverse or toxic effects of the chemical concerned, or the circumstances under which the chemical could prove harmful. The Safety Data Sheet (SDS) explains to the purchaser what the chemical shouldn't be mixed with, what protective gear should be worn when handling it, health hazard information, and so on.

An SDS is mandatory if a chemical is hazardous. Even if a chemical is not classified as hazardous it must have an SDS if it contains <u>a small amount of a hazardous substance</u>.

STEP 1A – Health Hazard Pictograms

At some point in your research you will come across health hazard pictograms. These are internationally recognized symbols, in use worldwide since 2015, which make it possible to get the hazard-related message across without encountering a language barrier. Here are four which we need to be familiar with:

STEP 2 – Fisher Scientific

Agent131711 says: "Personally, I always use Fisher Scientific MSDS because they have the biggest selection of chemicals, the largest database of documents available and the most thorough Safety Data Sheets that are based on American, Canadian and European standards, not China's and India's *low-to-nonexistent* standards"

As it happens virtually ALL of the chemicals used to formulate synthetic vitamins are made in either India or China. This puts a safe legal distance between the western corporations that market the products (making huge profits) and the factories that actually blend the chemicals. If problems arise, the western players can easily pass liability to their eastern counterparts.

STEP 3 – check the ingredients for yourself

If you want to know which chemicals ("ingredients") are used to make a particular vitamin – possibly one you have been consuming for years without knowing what it actually contains – simply do a search on the chemical name given on the vitamin jar. In fact, it may not be necessary to do this in many instances. A search on the commonly used name, such as Vitamin A, should lead to a PDF with the full SDS.

Using the search terms below, changing the vitamin each time, I was able to download the SDS for 9 of the most commonly consumed vitamins:


